Subject: - Promotion to the post of Principal amongst Post Graduate Teachers and Headmasters (Rest of Haryana Cadre) –Clarification on drawl of salary.

Kindly refer to this office order no. 4/4-2021 HRG-I(1) dated 04.08.2021 on the subject cited above.

In pursuance with order dated 02.07.2021 passed in CM-6745-CWP2021 in CWP No 19403 of 2019 titled as Baljit Singh V/s State of Haryana, promotions amongst Headmasters from seniority no. 1307 to 1480 (as stood on 01.06.2015) and Post Graduate Teachers from seniority no. 1646 to 2800 (as stood on 08.07.2019) were made on 04.08.2021 in pursuance with Haryana State Education School Cadre,(Group B) Service Rules, 2012 amended in 2014 subject to final outcome of aforementioned writ petition. It is stated that you were provided direction in the aforesaid order dated 04.08.2021 to draw the salary of such promote(s) principal against the vacancies available in the district.

It has come to know that some of districts are facing difficulty in drawing salary as surplus promotee(s) as compare to vacancies available in the district have joined in some of the District Education Offices and the details of such district are as under:-

The above position established that some districts have surplus promote(s) principal in comparison to the vacancies available in the district and some district have less number of principals in comparison to the vacancies available in the district. Hence, you are directed that the lien of surplus promote(s) principals may be shifted as per the above table. You are further directed to shift the lien of junior most surplus principal in the district and may ensure that salary may be disbursed to all newly promoted principal.

It has also been found that these promote(s) principal were the DDO(s) of the school while working as PGT(s) and salary of such school has not withdrawn due to promotion of such DDO(s) as Principal. In this context, you are directed to delegate DDO powers to the deserving official(s) immediately and ensure salary of the same be disbursed immediately.

It is made clear that present directions restricted to drawl of salary only and this may not be considered /treated as temporary posting.
