- विद्यालयों के भवनो के निर्माण/मुरम्मत/अलटरेशन इत्यादि कार्य शीघ्र करवाकर उपयोगिता प्रमाण पत्र संबंधित मुखिया/प्रधानाचार्य व एस0एम0सी0 कमेटी के हस्ताक्षर करवाने उपरान्त गये कार्य की फोटो सहित जिला शिक्षा अधिकारी के प्रतिहस्ताक्षर प्राप्त करके तत्काल निदेशालय को भेजना होगा। कार्य करवाने उपरान्त शेष उपलब्ध राशि यदि होतो उसे तुरन्त खजाने में चालान द्वारा जमा करवा कर निदेशालय को उपयोगिता प्रमाण पत्र के साथ भेजे।

Order No. 13/28-2021 HRME-I (3) Dated, Panchkula, 22/9/2021

Whereas the petitioners had filed a Civil Writ Petition No. 21928 of 2020 titled as Ram Avtar and others Vs State of Haryana & others praying therein for the issuance of a writ in the nature of Certiorari quashing the schedule I, Part -II of General ACP matrix of Haryana Civil Services (Assured Career Progression) Rules, 2008 (Annexure P-2) dated 30.12.2008 with further prayer for issuance of a writ in nature of mandamus commanding the respondents to remove the anomalies in the pay scale/ grade pay / ACP Grade pay of the petitioners and also grant the benefits of Assured Career Progression equal to the grade pay of next promotional post from clerk to assistant in Education Department.

The above mentioned Civil Writ Petition came up for hearing on 18.12.2020 and the Hon'ble High Court was pleased to dispose of the same with following orders:-

"The petition is disposed of with a direction to respondent No. 3 to consider this writ petition as a representation and to decide the same by passing a speaking order within a period of eight weeks from the date of receipt of certified copy of this order after giving an opportunity of hearing to the petitioner. In case it is found that money is due to be paid, the same be paid within a further period of four weeks."


In compliance of the above said order, department offered an opportunity of personal hearing to the petitioners on dated 27.08.2021, wherein they presented the same facts as they had submitted in the present Civil Writ Petition. The case of the petitioners was minutely examined and it

was found that there is no provision in the ACP rules, 2016 regarding granting of Assured career progress of the promotional cadre to Clerks. The Scheme of Assured Career Progress is based upon the Grade Pay of a particular cadre and it is only a coincidence in some cases where it would become equal to the next promotional post available in the cadre as in the Case of JBTs. It is further clarified that a JBT teacher is appointed in the Grade pay of 4200 and its promotional post is TGT that comes under the Grade pay of 4600. It is germane to mention here that there is no other grade pay between the grade of 4200 and 4600, therefore, the first ACP in the pay scale of 4200 will become 4600.

Whereas, the case of the petitioners is entirely different, the petitioners are working on the post of clerk i.e. come under the Grade Pay of 2800 and their promotional post is the post of Assistant, which comes under the Grade pay of 4200 and there are number of other slabs that come between the Grade of 2800 and 4200. Therefore, there are no anomalies in non granting of such benefits to the employees of ministerial cadre.

Whereas, the petitioners were never been discriminated and were equally treated among the similar situated employees working in the same cadre under Department of School Education Haryana, Panchkula.

Whereas, the demand of the petitioners is not tenable at all, because all the ACPs were granted in strict compliance to the ACP rules notified by the State Government.

 Whereas, the promotion to an employee is granted on the fulfilment of the minimum eligibility criteria along with the availability of the vacant posts in the promotional scale. As far as the case of the petitioners is concerned there is lack of availability in the promotional posts. Therefore, they will be


promoted subject to the availability of the promotional post as well as the according to their turn as per their seniority list.

Whereas, the purpose of ACP is only to provide the career progress in case of lack of promotional post. It is germane to mention here that there is no provision in the service rules as well as in the ACP Rules, 2016 to grant the benefits of the next promotional post to the posts of clerks or to the other employees of the Ministerial cadre.

Keeping in view of the aforementioned facts, the claim of the petitioners made through writ petition is not tenable and is liable to be rejected being devoid of merits.

I order accordingly.


