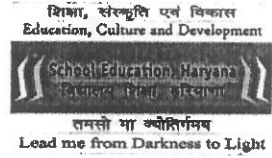

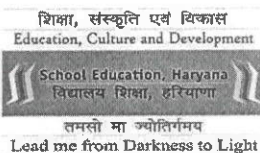

Order No. 13/216-2019 HRME-I (4) Dated, Panchkula, 24-9-2021

Whereas, the petitioner had filed CWP No. 23893 of 2019 titled as Raj Bala Vs State of Haryana & others praying therein for issuance of a writ in the nature of Mandamus directing the respondents to regularize the service of the petitioner w.e.f. 01.04.2011 instead of August 2014, the date from which other similar situated Part time class IV employees working in the respondent department were regularized with consequential benefits and to release the arrear of salary with interest @ 18% P.A.

The said writ petition came up for hearing on 02.09.2019 and the same was disposed of by the Hon'ble High Court by passing the following orders:

"without going into the merits and the demerits of the claim of the petitioner, I deem it appropriate to direct 2nd respondent- Director, School Education, Haryana, Shiksha Sadan, Sector 5, Panchkula to consider the legal notice dated 01.04.2019 (P-6) within a period of 2 month from the receipt of the certified copy of this order and shall pass a speaking order thereon."

In compliance of the above said direction of Hon'ble High Court, the case record and legal notice dated 01.04.2019 of the petitioner was examined. After due examination of the matter, it was found that the petitioner was engaged on 01.08.2002 as Part-Time class IV employee against non sanctioned post in Government Primary School Siwani Bolan District Hisar. The petitioner stands at seniority no. 382 in the seniority list of 2003 prepared by District Education Officer, Hisar and accordingly the petitioner has already been

regularized w.e.f. 14.08.2014 vide order no. E-III-2014/1866-70 dated 14.08.2014 District Education Officer, Hisar. As far as the contention of the petitioner with regard to regularization from 01.04.2011 is concerned it is hereby clarified that the claim of the petitioner is not tenable as no similar situated employee was regularized in the District Hisar, prior to the petitioner as per the provisions of the policy dated 11.11.2003. Further the examples of Sh. Nafe Singh and Sh. Nehru Singh has been quoted by the petitioner in her writ petition. But they belong to District Panipat and not of District Hisar. Thus, the claim of the petitioner is not tenable as the seniority list of Part-Time Class IV is of District level and one can not avail the benefit by citing the example of employee of another District.

Whereas per the policy of 1999 the seniority list of class-IV was at institutional level but in the policy 2003, the common seniority list was prepared at district level. There was condition of sanctioned post besides other conditions for the regularization in the policy of 1999 as well as of 2003 & the claim of the petitioner has already been rejected by the competent authority i.e. District Education Officer, Hisar vide order No. E-III-2019/1978-81 dated 22.11.2019.

Keeping in view of the above, the claim of the petitioner demand through Legal Notice dated 19.04.2019 is not tenable being devoid of merits. Hence, the claim of the petitioner is rejected.

I, pass order accordingly.
