



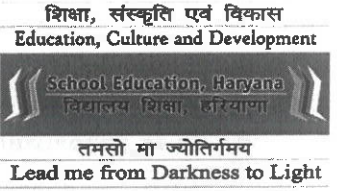

6. It is informed that before they are allowed to join their duties, the required ESP Gradation certificate shall be got verified from the issuing authority i.e Sports Department, Haryana and also to follow the orders passed in LPA No 1332 of 2019 (O &M)- Shankar and others V/s State of Haryana and others by the Hon'ble Punjab and Haryana High Court on dated 09.10.2020 in terms of the new policy notified on 25.05.2018 as issued by the Sports Department, Haryana.

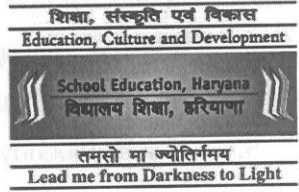

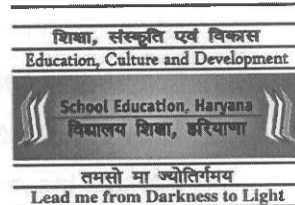
