

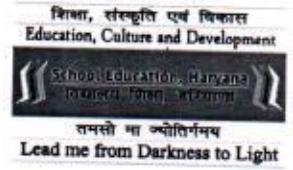



After completion of due course, HSSC recommended the names of 349 eligible candidates vide recommendation No. HSSC/Confid./Recomm./2019/550 dated 26.08.2019.

In pursuance to the above recommendation received from HSSC, the names of Smt. Rani Manderna, Roll No. 38701196 (Gen. Category), Merit No. 180-A, Smt. Sunita, Roll. No. 38701862 (Gen.
