

Order No. 13/53-2021 PGT-I (3)

Dated, Chandigarh, the 29.10.2021

Whereas, Sh. Sunil Kumar and others have filed CWP No. 5648 of 2019 titled as Sunil Kumar and others Vs. State of Haryana and others with a prayer to quash the arbitrary action of respondents while issuing departmental order dated 04.12.2018 and with the prayer to grant the pay higher than the pay of the juniors from the day on which the juniors started getting the pay higher than the seniors alongwith the interest.

After considering the official record, it has been found that the juniors of the petitioners have been promoted to the post of PGT in various subjects w.e.f. 26.04.2016. So, the petitioners are also eligible for promotion notionally from the date of their juniors. Now, it has been decided that the following petitioners be promoted to the post of PGTs w.e.f. 26.04.2016 (Notionally) from the date, their juniors, had been promoted:-



Whereas, Smt. Kaushalya Rani [046590] the then Block Education Officer, Israna [5037], Panipat now Deputy District Education Officer, Panipat (4141) was charge sheeted under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order dated 28.06.2021 and the following allegations were leveled against her:-

"That Shri Dharmender Indora, Ward No. 16, Shiv Colony, Samalkhan, Panipat has made complaint dated 01.06.2020 wherein allegation of irregularities in claiming TA/DA were leveled against her i.e. Smt Kaushalya Rani. In this regard, District Education Officer, Panipat was directed on 19.11.2020 to enquire the matter and District Elementary Education Officer, Panipat constituted a committee of Accounts Officer, Sarv Shiksha Abhiyan/Rashtriya Madhyamik Shiksha Abhiyan, Panipat, Section Officer O/o District Elementary Education Officer, Panipat under the chairmanship of District Elementary Education Officer, Panipat. This committee submitted report dated 04.12.2020 which was forwarded by District Elementary Education Officer, Panipat. On examination of this report, it is found that she i.e. Smt Kaushalya Rani committed irregularities in the following journeys:-

1. That she i.e. Smt Kaushalya Rani claimed the travelling allowance of Rs 6320/- for the period from 09/14 to 03/15 and Rs 1130/- for the period from 01/15 to 03/15 which is in violation of rule 77 of the Haryana Civil Services (Travelling Allowance) Rules, 2016 as travelling allowance can be claimed only once in a month for various journeys performed during the preceding month and no supplementary claim in this regard can be entertained.

2. That she i.e. Smt Kaushalya Rani has not countersigned the travelling allowance bills from the competent authority in violation of rule 81 (2) of the Haryana Civil Services (Travelling Allowance) Rules,

3. That she i.e. Smt Kaushalya Rani failed to obtain permission for Journey beyond Jurisdiction before claiming the travelling allowance bills in violation of Rule 81 of the Haryana Civil Services (Travelling Allowance) Rules, 2016.

4. That she i.e. Smt Kaushalya Rani has claimed daily for journey performed within the radius of 8 Kms and 20KMs in violation of rule 30 of the Haryana Civil Services (Travelling Allowance) Rules, 2016.

5. That she i.e. Smt Kaushalya Rani has claimed travelling allowance for the journeys performed on Saturday and Sunday which is violation of Rule 14 of Haryana Civil Services (Travelling Allowance) Rules, 2016.

 That she i.e. Smt Kaushalya Rani has not mentioned time of journey for the bill claimed after 19.07.2016 which was mandatory as allowances are to be disbursed in proportion to 30%/50%/100%

based on the time of journey but she i.e. Smt Kaushala Rani has claimed 100% allowance for the journey.

7. That she i.e. Smt Kaushalya Rani failed to submit the tour report for the journey performed by her but claimed the travelling allowance and she i.e. Kaushalya Rani inspected the repeated schools with malafide intention to claim travelling allowance".

The charged officer submitted her reply on dated 09.07.2021 to the said charge sheet and denied all the allegations leveled against her. The reply of the charged officer found unsatisfactory. Resultantly, Shri O P Langyan, IAS (Retd) appointed as inquiry officer vide order dated 27.07.2021/29.07.2021 to conduct regular departmental enquiry. The inquiry officer submitted his report vide letter dated 17.09.2021 wherein charges leveled against her were not proved.

Keeping in view the above said facts, finding of inquiry officer & documents on record, it is observed that no prejudice/loss has been caused to the state exchequer due to acts of the charged officer as revealed from report of inquiry officer. Therefore, the Governor of Haryana is pleased to file the present disciplinary proceedings against, Smt. Kaushalya Rani [046590] the then Block Education Officer, Israna [5037], Panipat now Deputy District Education Officer Panipat (4141).

It is ordered accordingly.

Whereas, Shri Vishnu Kumar [014980] the then Principal, Government Senior Secondary School, Ferozpur Jhirka [884], Nuh now posted at Government Senior Secondary School, Old Faridabad [969], Faridabad was charge sheeted under rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 on 22.01.2021/29.01.2021 and the following allegations were allegation was leveled against him:-

"That Shri Deepak Pal S/o Shri Tarachand resident of Ward No 8, Ferozpur Jhirka, Nuh made a complaint dated 26.12.2018 on CM Widow Portal, for payment of honorarium for the period he i.e. Shri Deepak Pal worked as apprentice, which was enquired by the District Education Officer, Nuh and the report dated 04.03.2020 was submitted by the District Education Officer, Nuh wherein it was mentioned that all the Block Education Officers were directed on 18.01.2018 to comply with letter dated 22.11.2017 of the Deputy Commissioner, Nun whereby apprentice were to be engaged @minimum 2.5 and maximum 10% of the total manpower. In compliance of he i.e. Shri Vishnu Kumar appointed the following officials:-

Further, he i.e. Shri Vishnu Kumar was directed by the District Education Officer, Nuh on 18.05.2018 to terminate the services of all the apprentices with immediate effect but he i.e. Shri Vishnu Kumar failed to comply with order dated 18.05.2018 and also failed to terminate the said services of apprentices which was serious lapse on his part i.e. Shri Vishnu Kumar"

The charged officer submitted his reply on dated 04.02.2021 to the said charge sheet and denied the all the allegations leveled against him. The reply of the delinquent was found unsatisfactory. Consequently, Sh. OP Langyan, IAS (Rtd.) was appointed as Inquiry officer on 10.05.2021/24.05.2021 to conduct regular departmental enquiry. The Inquiry Officer submitted his report on dated 22.07.2021 wherein charges were not

proved against him. The operative part of findings dated 22.07.2021 is reproduced as under:-

"After examination of the evidence of the prosecution, defence evidence, witnesses and documents placed on record, it is found that the delinquent was charge sheeted on the ground that he did not terminated the services of apprentice(s) in compliance of order dated 18.05.2018 of District Education Officer, Nuh. In this context, joint committee of Smt Saroj Kumar and Shri Sushil Kumar submitted their report dated 03.03.2020 that letter dated 18.05.2018 were sent to all Block Education Officers through email with a copy endorsed to ITI Nuh which establishes that letter dated 18.05.2018 regarding termination of services of apprentice(s) were sent only through email not through post. It is relevant to mention here that both previously mentioned witnesses could not produce any evidence i.e. copy of email forwarding which may prove that the email was sent to the delinquent. In this context, Shri Devender Kumar, Clerk of the then school was examined and he deposed that letter dated 18.05.2018 of DEO Nuh was not received in the school but a letter regarding termination of services was received in January 2019. Further, the delinquent also mentioned in his defense statement that letter dated 18.05.2018 was not received in his office but a letter was received in January 2019 and such three apprentice(s) were left the job prior to receipt of this letter. After thorough examination, it is found that District Education Officer, Nuh sent the letter dated 18.05.2018 through email only which was not delivered to the delinquent as per deposition of the clerk of the school nor any evidence came up on record, which may prove the delivery of letter dated 18.05.2018. Thus, the charge against the delinquent official does not stand proved"

Keeping in view the above said facts, finding of Inquiry Officer and documents on record it is observed that although, there was omission on his part to comply with the directions of higher authority but the same pertains more of communication gap between him and the District Education Office. The principal being head of school cannot absolve his liability by merely stating that he did not receive the order of higher authority and the matter was not in his knowledge. However, since no prejudice/loss has been caused to the state exchequer due to this act of omission of the charged officer.

Therefore, taking a lenient view, the Governor of Haryana is pleased to convert the present charge sheet into rule 8 & the minor punishment of "Censure" is hereby inflicted upon Sh. Vishnu Kumar [014980] Principal, Government Senior Secondary School, Old Faridabad [969], Faridabad

It is ordered accordingly.
