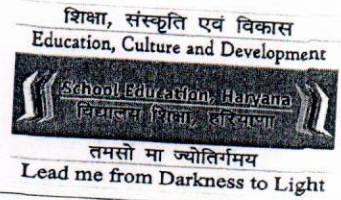

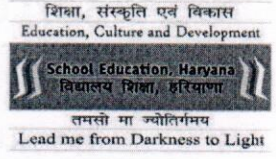

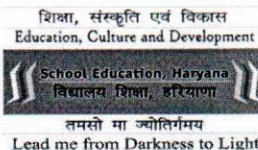

The charges are based on the statement of allegations appended thereto.

2 Shri Rajender Parshad is hereby required to state in writing within a period of 15 days from the receipt of this memorandum by him whether he admits the truth of all, or any, of the charges, what explanation or defence, if any, he has to offer and whether he desires to be heard in person.

3 Shri Rajender Parshad is hereby further informed that if for the purpose of preparing his written statement, he wishes to have an access to the relevant official records, he should inspect the same in the office of the Director, Secondary Education, Haryana, Panchkula on any working day after making prior appointment with him. It is, however, pointed out that only such documents will be shown to him as are in the possession of the Director, Secondary Education, Haryana, Panchkula, and as are strictly relevant to the case. If in the opinion of the Government, it is not desirable in the public interest, to allow him access to any document, such access shall be refused. If, Shri Rajender Parshad wishes to consult any other relevant record, which is not in the custody of the Director, Secondary Education, Haryana, Panchkula, it is for him to undertake its inspection. It is, however, made clear to Shri Rajender Parshad that his failure to inspect the documents shall not constitute a valid ground for delay in the submission of his written statement and if the written statement is not received by the undersigned within the specified period, it shall be presumed that he has none to submit.

4 The written statement should be submitted direct to the undersigned.

Statement of allegations against Shri Rajender Parshad [051849] the then Principal, Government Model Sanskriti Senior Secondary School, Mahendergarh [now retired].


While being posted as Principal, Government Model Sanskriti Senior Secondary School, Mahendergarh from 12.09.2018 to 31.01.2021, Shri Rajender Parshad committed following acts of omission and commission :-

That Shri Devender Kumar son of Shri Manphool Singh resident of House NO. 9, CHC Campus, Mahendergarh, made a complaint dated 30.10.2020 wherein it was mentioned that FIR No. 0461 dated 11.09.2020 under sections 354 B, 452 & 506 of the Indian Penal Code was registered against him i.e. Shri Rajender Parshad in Police Station, City Mahendergarh and he i.e. Shri Rajender Parshad obtained the Teacher State Award in the year 2018 by concealing his pending disciplinary proceedings initiated under rule-7 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016. In this context, the District Education Officer, Narnaul was directed vide letter no. 5/198-2020 HRG-I(1) dated 24.11.2020 to submit report. Consequently, District Education Officer, Narnaul submitted report on dated 27.11.2020 and on examination of this report, following irregularity was found to be committed on his part i.e. Shri Rajender Parshad :-

1. That FIR No. 0461 dated 11.09.2020 under sections 354 B, 452 & 506 of Indian Penal Code was registered against him i.e. Shri Rajender Parshad in Police Station, City Mahendergarh on the complaint made by Smt Santosh Devi wife of Shri Naveen Mittal resident of Brahmchari Road, Devi Lal Colony, Mahendergarh wherein the allegation of sexual harassment were leveled against him i.e. Shri Rajender Parshad and challan under sections 354 B and 452 of the Indian Penal Code was presented/submitted before the Hon'ble Court of ACJ(SD)-cum-SDJM, Mahendergarh on 21.10.2020. In this context, he i.e. Shri Rajender Parshad was arrested on 06.10.2020 and granted bail on the same day i.e. 06.10.2020. Thus, he i.e. Shri Rajender Parshad defamed the department with such immoral act.
2. That he i.e. Shri Rajender Parshad obtained the State Teachers Award in the year 2018 by concealing his pending disciplinary proceedings initiated under rule-7 of Haryana Civil Services (Punishment and Appeal) Rules, 2016 issued vide order no. 5/128-2011 HRG-I(1) dated 29.02.2012/13.03.2012. Resultantly, the State Award granted to him i.e. Shri Rajender Parshad in the year 2018 was withdrawn vide order No. 15/12-2020 CO.1(1) dated 19.02.2021/09.03.2021.

In this way, he i.e. Shri Rajender Parshad committed an act unbecoming of a Government officer by indulging into an immoral act of sexual harassment and defamed the Government with such act and as such violated the provisions of rule 4, 5 and 6 of the Haryana Civil Services (Government Employees Conduct) Rules, 2016.

The lapses detailed above constitute grave misconduct on the part of Shri Rajender Parshad [051849] the then Principal, Government Model Sanskriti Senior Secondary School, Mahendergarh [now retired] rendering him liable for strict disciplinary action under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016 read with rule 12(2)(b) of the Haryana Civil Services (Pension) Rules, 2016.

That Shri Devender Kumar son of Shri Manphool Singh resident of House NO. 9, CHC Campus, Mahendergarh, made a complaint dated 30.10.2020 wherein it was mentioned that FIR No. 0461 dated 11.09.2020 under sections 354 B, 452 & 506 of the Indian Penal Code was registered against him i.e. Shri Rajender Parshad in Police Station, City Mahendergarh and he i.e. Shri Rajender Parshad obtained the Teacher State Award in the year 2018 by concealing his pending disciplinary proceedings initiated under rule-7 of the Haryana Civil Services (Punishment & Appeal) Rules, 2016. The lapses detailed above constitute grave misconduct on the part of Shri Rajender Parshad [051849] the then Principal, Government Model Sanskriti Senior Secondary School, Mahendergarh [now retired] rendering him liable for strict disciplinary action under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016 read with rule 12(2)(b) of the Haryana Civil Services (Pension) Rules, 2016.


