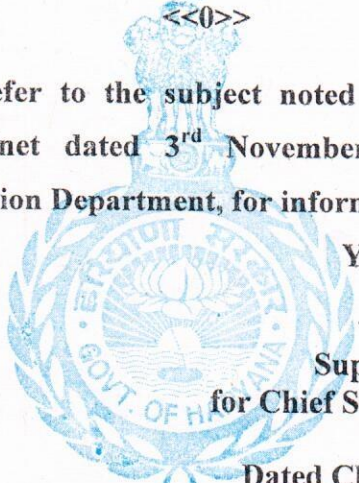

संख्या 6/1/2020-1मंत्रिमंडल.- भारत के संविधान के अनुच्छेद 166 के खण्ड (2) तथा (3) द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, मैं, बंडारू दत्तात्रेय, राज्यपाल, हरियाणा, इसके द्वारा, हरियाणा सरकार कार्य (आबंटन) नियम, 1974, को आगे संशोधित करने के लिए निम्नलिखित नियम बनाता हूँ, अर्थात्:-

1. ये नियम हरियाणा सरकार कार्य (आबंटन) संशोधन नियम, 2021, कहे जा सकते हैं।
2. हरियाणा सरकार कार्य (आबंटन) नियम, 1974 में, अनुसूची में, "सामान्य प्रशासन विभाग (मुख्य सचिव के माध्यम से)" शीर्ष के नीचे, उप-शीर्ष "(ज) नागरिक संसाधन सूचना" तथा उसके नीचे विद्यमान प्रविष्टियों के बाद, निम्नलिखित उप-शीर्ष तथा उसके नीचे प्रविष्टियाँ जोड़ी जाएंगी, अर्थात्:-

"(झ) मानव संसाधन विभाग

1. सभी सरकारी पदों की सेवा शर्तों का विनियमन।
2. मानव संसाधन प्रबंधन प्रणाली (एच.आर.एम.एस.) सभी सरकारी कर्मचारियों का डाटा बेस।
3. हरियाणा लोक सेवा आयोग/हरियाणा कर्मचारी चयन आयोग।
4. सामान्य पात्रता परीक्षा के संबंध में नीति।
5. प्रशिक्षण नीतियां, राज्य स्तरीय सरकारी कर्मचारियों का प्रशिक्षण तथा प्रशिक्षण संस्थाएं।
6. अस्थाई और संविदात्मक सेवाओं के संबंध में नीति।
7. ऑनलाइन स्थानांतरण नीतियां।

8. अनुग्रह पूर्वक नीति ।
9. सेवा नियम ।
10. लोक सेवाओं की सत्यनिष्ठा बनाये रखने तथा भ्रष्टाचार के उन्मूलन और अदक्षता और भ्रष्टाचार के आधार पर कर्मचारियों की छंटनी के लिए नीति ।

The 3rd November, 2021

No. 6/ 1 /2020.- 1Cabinet.— In exercise of the powers conferred by clauses (2) and (3) of article 166 of the Constitution of India, I, Bandaru Dattatraya, Governor of Haryana, hereby make the following rules further to amend the Business of the Haryana Government (Allocation) Rules, 1974, namely:-

1. These rules may be called the Business of the Haryana Government (Allocation) Amendment Rules, 2021.
2. In the Business of the Haryana Government (Allocation) Rules, 1974, in the Schedule, under heading “GENERAL ADMINISTRATION DEPARTMENT (Through the Chief Secretary)”, after sub-head “(H) Citizen Resources Information” and entries thereunder, the following sub-head and entries thereunder shall be added, namely:-

“(1) **HUMAN RESOURCES DEPARTMENT**

1. Regulation of Service conditions of all Government Posts.
2. Data- base of all the Government employees (HRMS).
3. Haryana Public Service Commission/Haryana Staff Selection Commission.
4. Policy regarding Common Eligibility Test.
5. Training policies, Training of State Level Government Employees. Training Institutions.
6. Policy regarding temporary and contractual Services.
7. Online Transfer policies.
8. Ex-gratia policy.
9. Service Rules.
10. Policy for the maintenance of the integrity of the public Services and eradication of corruption and weeding out of employees on grounds of inefficiency and corruption.
11. Restructuring of departments from time to time ”.
