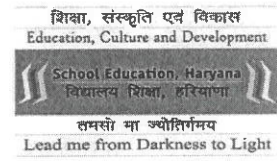

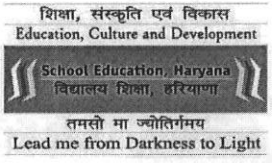
Note :-

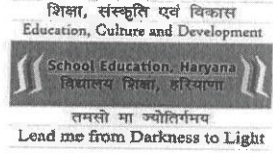
