DISSENTING NOTE**

Whereas, Smt. Sheela Devi [072174] the then Principal, Government Girls Senior Secondary School, Nangal Kalan [3643], Sonapat [now posted at Government Senior Secondary School, Kundli [3628], Sonapat] was charge sheet under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 on 21.01.2021/28.01.2021 and the following allegations were leveled against her:-

1. That in the matter Shri Krishan Chaudhary, Deputy District Education Officer, Sonapat, conducted an enquiry on 28.02.2020 and submitted the report on 09.03.2020 to the District Education Officer Sonapat wherein it was mentioned that Post Graduate Teachers of the subjects i.e. Hindi and Political Science, were posted at Government Girls Senior Secondary School, Nangal Kalan during the academic session of 2018-19 and both the aforesaid teachers of Hindi and Political Science subject, had taken benefit of their exam results. Thus, she i.e. Smt Sheela Devi had wrongly availed the benefits of five points for well performance in board exams.
2. That she i.e. Smt Sheela Devi failed to submit any documentary proof regarding teaching of any subject for the academic session of 2018-19 and she i.e. Smt Sheela Devi also refused to answer the questionnaire during the time of enquiry held on 28.02.2020 by Shri. Krishan Chaudhary, Deputy District Education Officer, Sonapat. That the Joint Director Admn-II office of Director Secondary Education, Haryana, Panchkula i.e. Shri Anil Nagar, HCS, in his note dated 07.09.2020 at noting page 22 of the office file i.e. 5/6-2020 HRG-I(1), observed that she i.e. Smt Sheela Devi was heard by him wherein she submitted that she i.e. Smt Sheela Devi had claimed result of both board examination i.e. i.e. Smt Sheela Devi 10th & 12th and her result for the class Xth board examination, remained 95% in the session 2018-19. As such, she i.e. Smt Sheela Devi was directed to provide the documentary evidence of the said claimed result within two days but she i.e. Smt Sheela Devi failed to provide the documentary evidence of the said results. Consequently, the board result of class 10th for the session 2018-19, was obtained from the Haryana Board of School Education, Bhiwani wherein it was found that 58 students appeared and only 39 students passed the class Xth in the session 2018-19. As such, board result of the class Xth for the year 2018-19, was 67%. Thus, she i.e. Smt Sheela Devi wrongly deposed/submitted before him i.e. Joint Director Admn-II with malafide intention and illegally claimed five points for well performance in the transfer drive in the year 2019".

Thereafter, the charged officer submitted her reply to said charge sheet on dated 30.03.2021 and denied all the allegations leveled against her. The reply of the charged officer found unsatisfactory. Resultantly, Sh. O. P. Langyan, IAS (Retd.) appointed as Inquiry officer vide order dated 29.06.2021/09.07.2021 to conduct regular departmental Inquiry. The Inquiry Officer submitted his report on dated 23.08.2021, wherein charges leveled against her were not proved.


Whereas, on perusal of finding of Inquiry Officer & and documents on record, it is observed that the inquiry officer has not examined the present matter properly and ignored the material points while conducting the regular departmental

inquiry. The inquiry officer ignored the substantive points thereby; charges were not proved against her.

Keeping in view the facts enunciated above, magnitude of the irregularities, gravity and sensitivity of the present matter, the Government has observed that the charged officer could not be absolved from her liability of fraud & misrepresentation merely because Inquiry Officer did not prove charges. However, before proceeding further, this dissenting note is hereby served upon Smt. Sheela Devi, Principal, Government Senior Secondary School, Kundli [3628], Sonapat with reference to followings :-

1. The inquiry officer ignored the fact that Teacher Transfer Policy, 2017 (as amended time to time) entry no. 9 provides entitlement of points only for academic performance and not for supervisory performance as claimed by the charged officer. Therefore, she got undue benefit of 5 points.
2. She fraudulently availed the benefit of 5 points for overall 100% result of said school i.e. 10th & 12th classes whereas, the actual result of 10th class was 67%.

In this regard, representation if any, be made in writing along with supporting documents within a period of 15 days from the date of receiving of this note. It is further clarified that no further extension will be granted and further action as per rules will be taken against her
