Whereas, Sh. Satpal Dudi had filed the CWP No. 26057 of 2019 – Satpal Dudi Vs. State of Haryana & Others in the Hon'ble Punjab & Haryana High Court, praying therein for issuance of an appropriate writ, order or direction particularly in the nature of mandamus directing Respondent Nos. 1-3 to consider the Petitioner for appointment as PGT, History as he fulfills all the conditions as laid down in the advertisement, and has been placed at Serial no. 28 in the merit list (Annexure P-7). Further, petitioner prayed for direction for keeping seat vacant for him.

The above mentioned writ petition came up for adjudication on 22.10.2019 and the Hon'ble Court disposed of the same vide order dated 22.10.2019. The operative part of the same is as under: -

“.....Without going into the merits and demerits of the claim of petitioner, I deem it appropriate to direct respondent No.2-Director, School Education, Directorate of School Education, Plot No.1/B, Shiksha Sadan, Sector 5, Panchkula to consider representation dated 23.09.2019 within a period of two months from the date of receipt of certified copy of this order and pass a speaking order thereon, failing which respondent No.2 shall be liable to pay costs of `25,000/- to the petitioner. This condition of imposing costs is only to prevent petitioner running from pillar to post and avail remedy of contempt in case of non-compliance of directions issued by this Court.

It is clarified that Haryana School Teachers Selection Board has now substituted with Haryana Staff Selection Commission.

The writ petition stands disposed of with the above

direction.”

In compliance of the above order dated 22.10.2019 passed by the Hon'ble High Court, the representation dated 23.09.2019 has been minutely examined. The brief facts of the case are that Sh. Satpal Dudi applied for the post of Post Graduate Teacher (hereinafter referred as 'PGT') – History under the Advertisement No. 1/2012 dated 07.06.2012. The said selection process was conducted by the Haryana School Teachers Selection Board, now Haryana Staff Selection Commission (hereinafter referred as 'HSSC') as per the Haryana State Education School Cadre (Group B) Service Rules, 2012. The Educational Qualification specified for the post of PGT (History) has been prescribed hereunder: -

- (i) M.A. History with at least 50% marks and B. Ed from recognised university; AND**
- (ii) Matric with Hindi/Sanskrit or 10+2 B.A/M.A. with Hindi as one of the subject: AND**
- (iii) Certificate of having qualified Haryana Teacher Eligibility Test (HTET)/School Teachers Eligibility Test (STET).**
- (iv) Consistent Good Academic Record.**

After due course, HSSC recommended the name of the petitioner at Sr. No. 28 vide recommendation dated 29.04.2013 in the Joint Merit List for the post of PGT History against the Advt. No. 1/2012 subject to following conditions: -

“The selected candidate has not been medically examined and no special enquiry into her antecedents has been made. The documents pertaining to their Educational Qualification, age, Caste/category and universities as claimed by them in the application form may please be got checked/verified from the issuing authorities, before they are allowed to join their duties. A copy of the appointment letter issued to the candidate may also be endorsed to the

Board.”

In pursuance to the recommendation *supra*, the department issued public notice vide which all the recommended candidates were requested to appear before the Document Verification Committee (hereinafter referred as 'DVC') for checking the genuineness of the documents of the candidates. Accordingly, petitioner attended the DVC along with other recommended candidates. In the DVC process the committee found that Sh. Satpal Dudi obtained his Bachelor of Education (B.Ed.) Degree from Institute of Advance Studies in Education University (IASE), Sardarshahr, Rajasthan. However, it is pertinent to mention here that the above university has been declared deemed to be university by the University Grant Commission (*hereinafter referred as 'UGC'*). Moreover, the department also sought clarification in this respect from UGC and accordingly, UGC clarified vide its letter bearing no. DEC/BU/BLR/KAR/2009/8798 dated 01.08.2014 as follows: -

***“IASE Deemed University, Sardarsahar, Rajasthan: The erstwhile Distance Education Council (DEC) as per a decision taken in the third meeting of Joint Committee of UGC-AICTE-DEC, DEC vide letter No. DEC/IASE/RJ/03/5449 dated 29.08.2007 accorded one time post-facto approval to IASE deemed University for the programmes (approved by the statutory bodies of the university) offered through distance mode till 2005 only. Vide DEC letter F.NO.DEC/Univ./State/07/5740 dated 03.09.2007 IASE deemed University had also been accorded Provisional recognition for offering programmes (approved by the statutory bodies of the university) through distance mode for a period of one year w.e.f. the date of issue of the aforementioned letter i.e. 03.09.2007. No further recognition has been given to this University by the DEC.*”**

The matter is sub-judice. The above letter also states that DEC has decided not to insist on territorial jurisdiction to be followed by institution in offering programme through distance mode and for that matter universities should be governed by their own Acts and Statutes.

The DEC had given institutional recognition in place of programme-wise approval to IASE Deemed University for offering programmes through distance mode during the period of Post facto and Provisional recognition. Further, in case of technical/professional programmes offered by the university is concerned, wherever required approval from the AICTE in accordance with the Gazette notification No. 44 dated 01.03.1995 issued by MHRD is required to be obtained by the university. The universities are required to offer programmes as per the norms and guidelines of apex regulatory bodies. Seeking approval from the respective apex bodies is the responsibility of the university concerned.”

As per the clarification *supra*, the IASE Deemed University was provided only one time post-facto approval for the programmes offered through distance mode till 2005 only. However, Sh. Satpa Dudi obtained B.Ed. Degree in the year of 2006, therefore, in light of the clarification *supra*; Sh. Satpal Dudi was not offered appointment to the post of PGT History.

Whereas, in regard to the contention of petitioner w.r.t. Decision of LPA No. 1215 of 2015 dated 19.08.2019, it is clarified here that the judgment covered the appointment cases of the candidates who obtained their post-graduation degree from deemed to be universities. However, in case of Sh. Satpal Dudi, he obtained his B.Ed. Degree from deemed to be university. Therefore, the case of the petitioner does not fall under the realm above of said judgment due to different cause of action.

So, there is no merit in the claim of the petitioner as the same is not tenable and considerable due to reasons stated *supra*, therefore, the claim of the petitioner demanded through his representation dated 23.09.2019 is hereby rejected being devoid of merits.
