Whereas, Sh. Jalbir Singh was employed on the post of PGT Hindi in the Secondary Education Department of Haryana Government. During his service period as such, he was convicted in case no. 564 of 2013, under Section 302 read with 34 & 120-B of Indian Penal Code, 1860 by the Court of Ld. Additional Sessions Judge, Kurukshetra vide order dated 16.12.2015 and was awarded punishment of life imprisonment and with fine of Rs. 50,000/- for murder of his own mother namely Smt. Rajwati.

Aggrieved with the above said conviction order, Sh. Jalbir Singh filed an appeal via CRM 12459/2016 in CRA-D-45-DB/2016 before the Hon'ble Punjab and Haryana High Court for suspension of his sentence wherein the Hon'ble Appellate Court (Division Bench) vide its order dated 09.05.2016 was pleased to dismiss his appeal. The operative part is mentioned below:

"As per the custody certificate produced by learned State counsel, the applicant has undergone an actual sentence of four months and twenty two days.

After hearing learned counsel for the applicant and keeping in view the facts and circumstances of the case, this court is of the considered view that applicant does not deserve the concession of Suspension of his sentence of imprisonment at this stage.

The application, is accordingly, dismissed."

Thereafter, against the above said order of Hon'ble Appellate Court Sh. Jalbir Singh approached the Hon'ble Supreme Court by filing special leave petition no. 6086/2016. The Hon'ble Apex Court vides its judgment dated 10.03.2017 only granted conditional bail and his sentence was neither revoked nor suspended. The operative part of the said judgment is reproduced hereinafter:-

"On the previously mentioned facts, we are inclined to release the accused appellant on bail. Therefore, the appellant is ordered to be released on bail to the satisfaction of the learned trial Court in connection with Sessions Case No. 564 of 2013.

The learned trial Court is free to impose appropriate conditions(s) as it deems fit. Consequently, the order of the High Court is set aside and the present appeal is disposed of in the above terms."

Whereas, Sh. Jalbir Singh intentionally misrepresented the material facts by stating that he was acquitted from the Hon'ble Appellate Court although he was only granted conditional bail by Apex Court vide order dated 10.03.2017. In this regard, opinion of legal expert of department also sought who stated that neither Hon'ble High Court nor Hon'ble Apex Court stayed the conviction and only allowed bail to the convict. Therefore, he stands convicted. Furthermore, on perusal of file, no record of revocation or suspension of his sentence was found. In the instant case, the employee has been convicted by the Ld. Additional Sessions Judge, Kurukshetra and he has been awarded life

imprisonment and fine of Rs. 50000/- vide order dated 16.12.2015 and there is no document on file to prove the stay of his conviction to which he got undue benefit of his reinstatement in 2017.

Keeping in view the above said facts & circumstances and documents on record, the matter has been re-examined in view of the provisions contained in rule 7 (A)(16) proviso 2 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016 and Article 311 (2) of the Constitution of India, which provide that major penalty can be imposed upon an employee on the ground of his conduct which led to his conviction on a criminal charge, without holding any departmental enquiry. Offences under the above said sections of IPC are quite serious and fall under the category of moral turpitude and hence no lenient view should be taken in his case. Therefore, it shall not be in public interest to retain such a person in government service. Hence, Sh. Jalbir Singh deserves punishment of dismissal from service.

Therefore, the Governor of Haryana is pleased to dismiss Sh. Jalbir Singh, PGT Hindi, DIET Palwal from service w.e.f. **16.12.2015** i.e. the date of his conviction. This is also in consonance with the law laid down by the Hon'ble Punjab and Haryana High Court in the case of Fateh Singh Vs. State of Haryana reported in PLR CXXXVI (2004-1)672.

It is ordered accordingly.

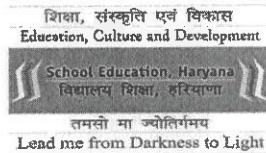


