

- 1. इसके द्वारा **श्री मान सिंह, उप—अधीक्षक, कार्यालय जिला शिक्षा अधिकारी, रेवाड़ी** को सूचित किया जाता है कि संलग्न विवरण में दिये गये आरोपों के आधार पर हरियाणा सिविल सेवा (दण्ड एंव अपील) नियमावली 2016 के नियम—8 के तहत कार्यवाही करना प्रस्तावित किया गया है। ये आरोप उससे अनुबन्ध अभिकथनों के विवरण पर आधारित है।
- 2. इसके द्वारा श्री मान सिंह से उनकें द्वारा इस ज्ञापन की प्राप्ति की तिथि से पन्द्रह दिन की अविध के भीतर लिखित रूप में बताने की अपेक्षा की जाती है कि वे सभी आरोपों या उनमें से किसी को स्वीकार करते हैं या नहीं। उन्होंनें क्या स्पष्टीकरण या प्रतिवेदन, यदि कोई हो, प्रस्तुत करना है और क्या वे व्यक्तिगत रूप में अपनी सुनवाई चाहते हैं।

1. यह कि निदेशालय की पी०जी०टी०—।। शाखा द्वारा दिनांक 03.09.2020 को अपील केस न0 6815/2020 अन्डर आर०टी०आई० एक्ट 2005 में सूचना की प्रति भेजने हेतू लिखा गया। इसके पश्चात 06.01.2021 को ई०मेल के माध्यम से कार्यालय छोड़ने से पूर्व उक्त रिपोर्ट भेजने हेतू स्मरण पत्र दिया गया परंतु इन आदेशों की पालना नहीं की गई। इसके बाद कार्यालय के दूरभाष पर सूचना देने बारे सम्पर्क किया गया जो कि आप द्वारा अटैण्ड किया गया तथा आप द्वारा (जो कि जिला शिक्षा अधिकारी रेवाड़ी को ई०मेल० के माध्यम से भेजने बारे लिखा गया था) उक्त रिपोर्ट देने से मना कर दिया।

अतः आप द्वारा ऐसा करके उक्त आदेशों की अवहेलना करते हुए हरियाणा सिविल सेवा (सरकारी कर्मचारी आचरण) नियमावली 2016 के नियम—4(ii) की उल्लंघना की गई।

इस प्रकार उपरोक्त अनियमितता करके आपने हरियाणा सिविल सेवा (दण्ड एवं अपील) नियमावली 2016 के नियम—8 के अन्तर्गत अपने आपको अनुशासनिक कार्यवाही के लिए उत्तरदायी बनाया है।
