Subject: - Promotion to the post of Principal amongst Post Graduate Teachers and Headmasters (Rest of Haryana Cadre) – Updation of MIS after Temporary allotment of station through online counseling.

Kindly refer to this office order no. 4/4-2021 HRG-I(1) dated 04.08.2021, 10.08.2021, 11.10.2021 &amp; 08.12.2021 on the subject cited above.

It is stated that the promotion to the post of principal was made on 04.08.2021 & 10.08.2021 in pursuance with order dated 02.07.2021 passed in CM-6745-CWP2021 in CWP No 19403 of 2019 titled as Baljit Singh V/s State of Haryana amongst Headmasters from seniority no. 1307 to 1480 (as stood on 01.06.2015) and Post Graduate Teachers from seniority no. 1646 to 2800 (as stood on 08.07.2019) in pursuance with Haryana State Education School Cadre,(Group B) Service Rules, 2012 amended in 2014 subject to final outcome of aforementioned writ petition. Thereafter, initial temporary posting was given to the principal promoted vide order dated 11.10.2021 subject to the condition that they will participate in the ensuing Teachers' Transfer Drive and final outcome of CWP No 20416 of 2021 – Dharamvir Singh & Others V/s State of Haryana. Further, you were request on 08.12.2021 to direct the DDO(s) of these newly promoted principals to relive them from the post of PGTs & Headmasters w.e.f. 11.10.2021 and join as principal on 11.10.2021 so as to ensure proper updation of MIS data of such incumbents without any gap.

Now, you are directed to ensure that all newly promoted principal may submit their joining on the MIS portal by today positively otherwise disciplinary proceedings will be contemplated against the erring officer(s).

Whereas, the petitioner had filed CWP No. 34029 of 2019 titled as Bala Devi Vs State of Haryana & others praying therein for issuance of a writ in the nature of Mandamus commanding the respondents to consider the case of the petitioner and decide the legal notice (P-5) dated 25.09.2019 by passing a speaking order within a stipulated time.

The said writ petition came up for hearing on 22.11.2019 and the same was disposed of by the Hon'ble High Court by passing the following orders:

**“Without commenting upon the merits of the claim and in view of the innocuous nature of the prayer made by learned counsel for the petitioner, the writ petition is disposed of by directing respondent No.2 to consider and decide the claim made in the legal notice (Annexure P-5) dated 25.09.2019, in accordance with law within a period of 3 months from the date of receipt of certified copy of the order.”**

In compliance of the above said directions of Hon'ble High Court, the case record and legal notice dated 25.09.2019 of the petitioner was examined. After due examination of the matter, it was found that the petitioner was engaged as Part-Time class IV employee against un-sanctioned post in the year of 1991 in Govt. Girls Primary School Durajanpur, Bhiwani.

According to regularization policy dated 30.12.1998/25.02.1999 two conditions are required to be fulfilled, apart from completion of 6 years service in case of direct recruitment or completion of 3 years

service in case of recruited through employment exchange as Part-Time Class-IV employee, which are reproduced as follows:-

1. The part time class IV employee should have possessed the qualification prescribed for regular class-IV employees in Haryana State Secondary Education field offices (Group-D). services rules, 1998.
2. There should be vacant sanctioned post in the institution, where he/she was working as part time class IV employee.

Whereas, the petitioner namely Smt. Bala Devi was working in Govt. Girls Primary School Durajanpur, Bhiwani as Part-Time class IV employee and there was no sanctioned post of class IV in the above captioned school. Therefore, she is not entitled to be regularized under the regularization policy dated 30.12.1998/25.02.1999 as she does not fulfilled the terms and conditions of the aforesaid policy the petitioner has already been regularized under the regularization policy dated 30.12.1998/25.02.1999 as she does not fulfill the terms and conditions of the aforesaid policy. The regularization policy dated 30.12.1998 and 25.02.1999 provides for the seniority of Part time Class IV employee at institutional level, was superseded by the new regularization policy dated 11.11.2003/22.08.2004, where the common seniority list was prepared at District Level as per the policy of 2003 even if, there was no vacant sanctioned post at institutional level, the part time Class IV can be regularized in some other institution as the common seniority list was prepared at District level. There was condition of sanctioned post besides other conditions for the regularization in the policy of 1999 as well as in the policy of 2003.

Further, the petitioner quoted the examples of Sh. Bhoop Singh and Sh. Shishpal in her legal notice dated 25.09.2019, but they

belong to District Fatehabad and not to the District Bhiwani. Thus, the claim of the petitioner is not tenable as the seniority list of Part-Time Class IV is of District level and one cannot claim the benefit by citing the example of employee of another District. The services of the petitioner has already been regularized in the year 2012 under the regularization policy dated 11.11.2003 by the competent authority i.e. DEO, Bhiwani as per the seniority list of District Bhiwani as well as her eligibility as and when regular vacant sanctioned post was available. Further, the claim of the petitioner has already been rejected by the competent authority i.e. District Education Officer, Bhiwani vide order No. E-I-2020/888-92 dated 20.06.2020.

Keeping in view of the above, the claim of the petitioner demand through Legal Notice dated 25.09.2019 is not tenable. Hence, the claim of the petitioner is hereby rejected being devoid of merits.
