Whereas Sh. Narender Kumar had filed the Civil Writ petition No. 10461 of 2020 before the Hon'ble Punjab & Haryana High Court praying therein for issuance of writ in the nature of mandamus directing the respondent to appoint the petitioner to the post of PGT Biology with all consequential benefits w.e.f. the date the candidates lower in merit were appointed.

The above writ petition came up for adjudication on 23.07.2020 and the Hon'ble High Court disposed of the same vide order dated 23.07.2020. The operative part of the same is as under;-

"Consequently, this petition is disposed of with a direction to the competent authority amongst the respondents to take a decision on the aforesaid legal notice got issued by the petitioner, within a period of two months from today, after hearing the petitioner and taking into consideration the judgment of the Division Bench of this court (and other judgments on the issue), as also the 'orders' passed by the Andhra University.

If, despite the above, the opinion of the competent authority is that the petitioner is not eligible for such appointment, detailed reasons shall be given in the order to be passed, as to why, when MSC Life Science is one of the qualifications prescribed in the statutory rules for eligibility to such appointment, the petitioner cannot be considered eligible with the qualification that he has, which at least in the prime facie opinion of this court, at this stage, (without going into the detailed merits thereof), would also seem to be covered by the term "Life Sciences".

In compliance of the above direction passed by the Hon'ble High Court, a personal hearing was imparted to the petitioner in which the legal notice dated 13.02.2020 (Annexure P-10) was minutely examined as per the prevailing rules/instructions.

Whereas, the petitioner had applied for the post of PGT Biology against the Advt. No. 4/2015, Cat. 1. Whereas, the recruitment process was conducted as per Haryana State Education School Cadre (Group-B) Service Rules-2012. As per these rules of 2012, the following qualifications are required for the post of PGT Biology:-

- (i) M.Sc. Zoology/Botany/ Bio-Science/Bio-Chemistry/Genetics/Micro Biology/ Plant Pathology/Biotechnology/Life Science/Molecular Bio. with at least 50% marks provided that the applicant had studied Botany & Zoology at Graduation level and B.Ed from recognized university; AND
- (ii) Matric with Hindi/Sanskrit or10+2/B.A./M.A. with Hindi as one of the subject; AND
- (iii) Certificate of having qualified Haryana Teacher Eligibility Test (HTET) / School Teachers Eligibility Test (STET).
- (iv) Consistent good academic record.

Whereas, the petitioner obtained his Post Graduation degree in the subject of M.Sc. (Coastal Aquaculture and Marine Biotechnology) and his name was recommended by the HSSC vide Roll No. 61202340, Merit No. 35 vide recommendation dated 09.03.2019.

Whereas, vide order No. 13/94-2020 PGT-I (2) dated 03.08.2021, the issue w.r.t. non equivalency of subject was referred to Kurukshetra University, Kurukshetra for clarification regarding the degree obtained by Sh. Narender Kumar. In pursuance to the above said referral, Kurukshetra University, Kurukshetra has clarified vide its letter No. ET-1/21/10458 dated 08.09.2021, that M.Sc. (Coastal Aquaculture and Marine Biotechnology) cannot be considered equivalent to M.Sc. Zoology/Botany in the faculty of Life Sciences.

Keeping in view of the facts and clarification referred *supra*, the Post-graduation degree obtained by Sh. Narender Kumar in M.Sc. (Coastal Aquaculture and Marine Biotechnology) is not considerable for the post of PGT Biology as the same is not equivalent to the courses mentioned in Rules, 2012. Therefore, the claim of the petitioner demanded through legal notice (Annexure P-10) is hereby rejected being devoid of merits. Furthermore, the candidature of Sh. Narender Kumar at Merit No. 35 (Roll No. 61202340) received vide recommendation dated 09.03.2019 is also cancelled being not considerable as per Rules, 2012.

I, order accordingly.
