Terms and Conditions:-

- The Mewat Development Agency will hand over the land along with buildings and assets of these 8 schools to the department of School Education Haryana.
- The Government/Department will not accept any financial liabilities prior to take over of these schools. Mewat Development Agency will be responsible for the same which is running these schools presently.
- 3. The employees working in regular capacity in Mewat Model Schools and are having the qualifications at par with their counter parts working in School Education Department are only absorbed as regular employee in Mewat Cadre of the School Education Department.
- 4. The services of non-teaching employees working in regular capacity in Mewat Model Schools are also taken over to School Education Department, Haryana. However, where the post is not sanctioned in the School Education Department, Haryana, the post of these employees be sanctioned from the Finance Department.
- 5. The services of contractual employees (teaching/non-teaching) will also continue on contract basis.
- 6. All teaching staff who do not possess the required eligibility criteria would be given only ad-hoc appointment for a period of two years to complete the required qualification such person shall have to qualify the essential qualifications within two years from the date of issuance of this notification and if they fail to do so, their appointment shall stand terminated automatically without giving any further notice.
- The STET was first time conducted by the State Government in August,
 2008 and first recruitment was made on the basis of STET in the year of

2009 in the School Education Department. Further, the department framed new service rules on 11.04.2012. Therefore, there are three set of teaching employees i.e. (i) Employees those were appointed before 2009, the eligibility should be considered as per old Service Rules, 1998 (ii) Employees those were appointed from January, 2009 to March, 2012 the eligibility should be considered as per old Service Rules, 1998 but they must be STET/HTET qualified and (iii) Employees those were appointed after April, 2012 the eligibility should be considered as per New Service Rules, 2012. This above criteria is further subject to final outcome of SLP No. 7820 of 2013 titled as Shivani Gupta & Ors. Vs. State of Haryana & Ors.

- 8. The services of teaching employees who possessed their qualification from deemed to be universities are also taken over to School Education Department, Haryana only on ad-hoc basis subject to the final outcome of SLP No. 17134 of 2001 filed by the department titled as State of Haryana & Ors. Vs. Gurmail Kaur & Ors.
- One more building of Mewat Model School situated at Chilawali (Nuh) is completed and will also be taken over by the School Education Department, Haryana.
- 10. The services of all categories (teaching and non-teaching) will be governed under New Pension Scheme (NPS) which is applicable w.e.f. 01.01.2006.
- 11. The leave account of the employees appointed under Haryana School Education Department will start with zero balance.
- 12. Services of teaching staff shall be governed by 'The Mewat District School Education (Group-B) Service Rules, 2012' in case of Group-B employees. Further, the services of Group-C teaching staff shall be governed by 'The Mewat District School Education (Group-C) Service Rules, 2012' in case of Group-C employees and the services of Ministerial Staff shall be governed by 'The Haryana Education Department, Sub Offices, Ministerial (Group-C) Service Rules, 1983' in case of Group-D employees, the Haryana State Secondary Education Department (Group-D) Service Rules, 1998.
- 13. In case of any confusion and ambiguity in terms and condition, the decision shall be taken by the Government.
- 14. The Department should endeavor to create new posts by shifting/utilizing surplus posts in other schools.
- 15. Posts of Accountant is not available in the School Education Department, Haryana, therefore, the working Accountants in Mewat Model Schools are to be adjusted/transferred later on in other Govt. Departments on need basis.
- 16. Only 3 posts of drivers are available in Mewat Cadre of School Education Department. Therefore only Senior Most 3 drivers are hereby

- adjusted/absorbed in the School Education Department and remaining 12 drivers working in Mewat Model Schools are to be adjusted/transferred later on in other Govt. Departments on need basis.
- 17. Posting orders of these employees of Mewat Model Schools will be issued separately after detailed scrutiny of their record/qualification. Appointment will be issued to the employees who fulfill the essential qualification as per requirement. The said employees will perform their duties at their existing place of posting till the end of current academic session i.e. up to 31st March, 2022.
- 18. Online Teacher Transfer Policy 2016 will also be applicable on these teaching/non-teaching employees of Mewat Model Schools after taking over into School Education Department, Haryana. After end of current Academic Session, these teaching/non-teaching staff will be posted in Mewat Cadre on provisional basis subject to they will participate in next Online Transfer Drive.
- 19. Employees being taken over from Mewat Model Schools to School Education Department will be posted in Mewat Cadre of School Education Department and will remain in Mewat Cadre only.
- 20. Employee being taken over from Mewat Model Schools to School Education Department will continue in their existing pay-scale and will carry their pay at the stage where they were drawing in Mewat Model Schools.
- 21. They will only be promoted to next promotional post, if they fulfill the criteria described for promotion in the present service rules of School Education Department.
- 22. The seniority will be fixed at the tail of same cadre post in Mewat Cadre of School Education Department Haryana.
- 23. Haryana Civil Service Rules (Pay, Allowance, Leave, Conduct, Punishment& Appeal), 2016 will be applicable to the taken over staff.
- 24. Contractual employees of Mewat Model Schools will continue on contract basis and they will not be regularized as per policy of Mewat Model School Society.
