



As per provision in the Haryana Civil Services (Compassionate Financial Assistance/Appointment) Rules, 2019, issued vide notification no. G.S.R. 32/Const./Art.309/2019 dated 02.08.2019, sanction is hereby accorded to appoint the following dependents due to death (while in service) of their father on the post of Clerk (Group-'C') on compassionate ground in the Government School of Education Department without going through the procedure of Haryana Staff Selection Commission/Director Employment Exchange Department in the pay band FPL-2 (19900-63200) of Schedule-I pay Matrix of Haryana Civil Services (Revised pay) Rules, 2016 plus usual allowances as sanctioned by the Haryana Government from time to time. They are hereby posted in the offices/institutions mentioned as under against vacancy and are posted at place mentioned against their names with immediate effect on the terms and condition mentioned below:-

- Note:-** 1. His appointment is subject to the condition that concerned District Education Officers may ensure the Character Certificate and all other documents regarding date of birth and all educational documents.
2. He is also directed to participate in next online transfer drive for taking permanent Station.

**TERMS & CONDITIONS:-**

1. His appointment is against a purely temporary post which is liable to be abolished at anytime and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to him at present. His services can be terminated without any notice, whenever there is no vacancy against which he can be retained.
2. If at any stage he desires to resign his posts he will be required to give one month's notice or forfeit in lieu thereof, his salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given to him by the Directorate Secondary Education, Haryana, Panchkula in case it is proposed to terminate his services for the reason other than that mentioned in clause (I) above.
3. He will be required to take the prescribed oath of allegiance to the constitution of India.

4. In case he is married, he will produce the following certificate to his/her Head of office:-

"That he/she is not having more than one living spouse." In case they are unmarried, they shall have to furnish a declaration to the effect that each of these will not have more than one living spouse.

5. In case he is unmarried, he will have to furnish a declaration to the Head of the Department that he has not taken any dowry after marriage. The declaration should be signed by your wife, father and father-in law, as per Chief Secretary to Govt. Haryana letter No. 18/1/2004-2GSI dated 21.02.2006.
6. The candidate shall have to qualify the State Eligibility Test in Computer Appreciation and applications (SETC) within the probation period of two years, extendable by one year in case of direct recruitment. The candidate appointed against the aforesaid categories of posts in the group 'C' shall not be entitled to earn any increment in his pay scale till he/she qualifies the said test failing which the services of such employees shall be dispensed with.
7. He will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the pursuing of higher studies.
8. He will be required to produce the original Educational documents and date of birth certificate before joining his duties of the said post.
9. He shall have to furnish fitness certificate from the Chief Medical Officer as required under Rule 9 of Haryana CSR (General), 2016 before joining his duties.
10. No TA/DA and joining time will be paid to him for joining this post.
11. He will remain on probation for a period of two years, from the date of his joining in the department. The period of probation can be extended in accordance with the existing rule on the subject. For assessing his performance during the period of probation, his work conduct will be taken into consideration. If his work and conduct during this period is not found satisfactory his services will be terminated without any notice.
12. His appointment is subject to have passed 10+2 or its equivalent examination with Hindi or Sanskrit.
13. That in the matters, not specifically mentioned in this Communication, he shall be governed by the Civil Service Rules as applicable to Haryana Government employees and such rules/order /instructions as may be issued by the State Government from time to time. He shall further be governed by the "Haryana Education Department Sub Offices Ministerial (Group-C) Services Rules, 1983" and amended in the year 2013.
14. His services will be governed under the "NEW DEFINED CONTRIBUTORY PENSION SCHEME" of the Haryana Government as per Finance Department's notification dated 28.10.2005.
15. That if he got appointment on the basis of furnishing false/forged or fraudulent information/facts/documents which are detected later on to be

false or forged or fraudulent, he would be liable for termination of his services without any notice besides such criminal action that may be taken as prescribed in the Indian Penal Code or any other Law enforce.

**ORDER No. 13/104-2020 HRME- I(4)**

Whereas the petitioner has filed CWP No. 12420 of 2020 titled as Neha Vs State of Haryana & Another, before the Hon'ble Punjab & Haryana High Court, praying therein for issuance of a writ in the nature of certiorari for quashing the impugned order no. 22/66-2020 HRME-1 (4) dated 14.08.2020 (Annexure P-3) vide which the petitioner has been transferred from District Education Officer Charkhi Dadri, Block Dadri, District- Charkhi Dadri to Govt. Sr. Sec. School Badarpur, Block Nagina District Nuh-Mewat.

The above said Civil Writ Petition came up for adjudication before the Hon'ble High Court on 08.11.2021 and the same was adjourned with following orders:-

**"Learned Counsel for the petitioner seeks time to make representation to the competent authority within one week from the today. In case such representation is made within the stipulated period, the same shall be considered and decided in accordance with law within next two weeks.**

**Posted on 07.12.2021.**

**Till the next date of hearing, interim order to continue. "**

In compliance of the abovementioned orders of the Hon'ble High Court, a representation dated 10.11.2021 of the petitioner was received in the department on dated 12.11.2021 and the same was minutely examined & it was found that the petitioner voluntarily participated in the online transfer drive 2020 and in case of voluntarily participation there is no need to complete the minimum tenure of 5 years. The petitioner opted for 123 stations and obtained the merit score of 35.7014 points, as per transfer policy 2020. The 90<sup>th</sup> preferred station was allocated to one employee namely, BABITA DEVI, who obtained the score of 66.6137 points. The petitioner was transferred in *Anywhere in the State* category due to non-availability of preferred stations as the same were allotted to the persons higher in merit. The same has been done in a fair & transparent manner in strict compliance of the Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Whereas, the Government of Haryana framed Online Transfer Policy of Ministerial Staff dated 06.03.2020. Thereupon, transfers were made under

less than 125 were blocked for the purpose of proper utilization of the manpower available with the department and the same was reduced to 55 students per school on the arrival of new clerks for the purpose of temporary posting of them. Whereas these newly appointed clerks will also have to complete with the other clerks in the next transfer drive whenever the same will be conducted by the Department. Thus for the process of even distribution of clerks in the State the process of rationalization was done as per mandate of Clause 4 (iv) of Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Whereas as per the provisions of the policy, allotment of a vacant seat/station to an employee is based on total composite score earned by the employee concerned out of total 80 score points. The employee concerned earning highest score is entitled to be transferred against a particular vacancy. For merit points, age is prime factor for deciding the claim of the employee against a vacancy, as it has weightage of maximum of 60 points out of total 80 points. However, it is worthwhile to mention here that the categories like women, widows, widowers, differently-abled persons, employees with serious ailments, a privilege of maximum 20 points can be availed by the employees. Therefore, the employees were asked to opt for maximum stations as per their choice suitable to them so that their chances of getting posted on an un-opted station in 'anywhere in the state category' may be reduced. In other words, if a employee could not be transferred against any of the stations preferred by him/her, he/she shall be transferred under '**Anywhere in the State**' category. In case, an employee is to be transferred on an un-opted station in "Anywhere in state" category then Computer Programme/Software, instead of sending them at a distant place, searches for a vacancy nearest to them and put them at that vacancy as per their merit points.

Whereas, according to general principles of the policy, every employee is responsible for the accuracy and regular updation of data in MIS in respect of his/her credentials, otherwise the department is at liberty to transfer him anywhere category in the state. Employees are liable to be transferred under this policy in any zone or anywhere in the State, in public interest, on completion of prescribed tenure.

In view of the circumstances mentioned above, petitioner has been transferred by the Department in strict compliance to the transfer policy

this policy to ensure equitable distribution of Ministerial Cadre Employees of the Department across the State, in a fair & transparent manner and to maximize job satisfaction amongst employees. Under this policy all the government schools/ institutes have been categorized into seven zones for the purpose of transfer of clerks and every participant is eligible to opt for any number of schools/ institutes across the zones available to him/her. He/She is free to give preferences in order of his/her suitability, so that chances of being posted in '**Anywhere in the State**' category may be decreased. Further according to the Para No. 4 sub clause V (b) of the Transfer Policy of Ministerial Staff 2020, the department is at liberty to post an employee anywhere in the State if he/she fails to get one of his/her preferred options. Thus the petitioners got the stations as per the online transfer policy of Ministerial Staff 2020.

Whereas the stations were blocked by following the process of rationalization. It is worthwhile to mention here that according to the sub clause-iv of Clause-4 of online transfer policy of Ministerial Staff 2020, the department can block actual vacant post for the purpose of rationalization. Sub clause-iv of Clause-4 online transfer policy of Ministerial Staff 2020 is as under:-


**iv) Rationalization and Blocking of posts:** To avoid disproportionate concentration of employees at a particular station, the department should rationalize their sanctioned posts and also block actual vacant post to be kept vacant in the transfer drive. In the long run, however, the department may increase/decrease the total number of sanctioned posts as per the assessment/requirement in consultation with work Assessment Cell in the Administrative Reforms Department and Finance Department.

The posts with less workload were blocked by the department, because stations with over workload require more employees for smooth working in the department. So, for maximum utilization of the potential of an employee at over workloaded station and to avoid misappropriate concentration of employees at a particular station, the blocking of posts was done by the process of rationalization in the public interest.

Moreover, the stations were blocked by the department by following the proper criteria i.e. the schools in which the student strength is

dated 06.03.2020. Therefore, the claim of the petitioner made through representation dated 10.11.2021 is hereby rejected, being devoid of merits.






