

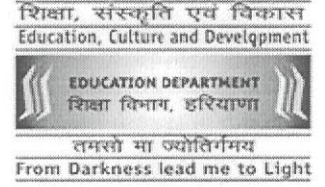

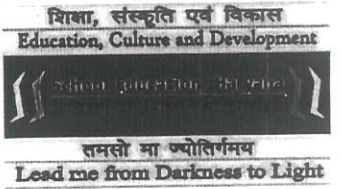

यह कि आप द्वारा जन सूचना अधिकार अधिनियम 2005 के तहत अवर प्रशासकीय सुधार विभाग, हरियाणा सिविल सचिवालय से सूचना मांगी थी जिसके संदर्भ में उनके कार्यालय के आर0टी0आई0 सैल द्वारा अपने पत्र क्रमांक 1/3/2018-2डी0सी0यू0 दिनांक 12.12.2019 को सूचना उपलब्ध करवाई गई थी जिसमें उन द्वारा यह भी स्पष्ट कर दिया गया था कि इसके अतिरिक्त जो भी सूचना कार्यालय में उपलब्ध होगी उसे 15 दिन के अन्दर-2 किसी भी कार्य दिवस में पहुंचकर दस्ती प्राप्त कर सकते हैं। आप दिनांक 16.12.2019 का आर0टी0आई0 सैल में पेश हुए और आते ही अभद्र भाषा का प्रयोग करते हुए जोर जोर से बोलना शुरू कर दिया और कहने लगे कि सचिवालय के सभी कर्मचारी आपस में मिले हुए हैं तथा अपने पदों व शक्तियों का दुरुपयोग करते हैं साथ ही आप द्वारा अपने आपको एल0एल0बी0, एल0एल0एम0 तथा अपने मामा जी को मंत्री बतलाकर एक-एक को देख लेने व उनके खिलाफ एफ0आई0आर0 दर्ज कराने की धमकी देने लगे। इतना ही नहीं आप द्वारा श्री राहुल कटारिया नाम के सेवादार से हाथापाई तथा गाली गलौच की गई। आप उप-अधीक्षक तथा सभी स्टाफ सदस्यों से बदतमीजी से पेश आये और सचिवालय के 8 वें तल पर ऊंची आवाज में यह भ्रांति फैलानी शुरू कर दी कि उसके साथ झगड़ा आर0टी0आई0 सैल के उप-अधीक्षक द्वारा करवाया गया है।

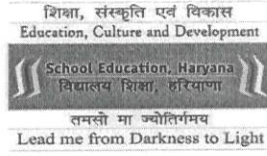

- No TA/DA and joining time will be admissible to the official if he/she has been shifted on his/her request after exercising option.
- If there is no vacancy in the destination school for any reason the incumbent transferred shall re-join his/her previous place of posting and also inform to concerned branch/computer cell at HQ.
If any discrepancy is noticed in this order or there is a violation of transfer policy, It should be brought to the notice of Computer Cell/Concerned branch within three days and the order be not implemented.
- Consent/affidavit of the official be taken that he is willing to loose his/her seniority in case of requested transfer orders.
- The condition that official has not been joined previous transfer place of posting is not implemented on Cancellation Order.
- The official will be update their profile in MIS Portal when he/she join/relieve from his present working station and also supply the information to the Directorate.
- Concerned DDO is also requested to update and approved MIS data of the official at your own level.
