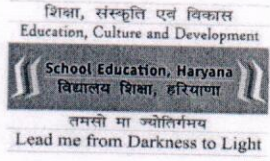

While posted as Clerk, in office of District Education Officer, Rohtak from 04.09.2013 to 11.03.2019, you have committed the following acts of omissions and commissions :-

1. That you did not take any action for filing written Statement in the Civil Appeal No. 87 of 2017 titled as Suresh Singh & others V/s State of Haryana & others before the Hon'ble District Judge-Cum Educational Tribunal, Rohtak. Further, you failed to comply with directorate letter dated 10.01.2018.
2. That you did not take any interest to attend the abovesaid case in the Hon'ble District Judge-Cum Educational Tribunal, Rohtak at the time of hearing of the same and never made any serious efforts in this case.

In this way, you had shown lack of responsibility and devotion to duty and acted in a manner which is unbecoming of Government official of your status and thereby contravened the provision of rule 4 (ii), 5 (i) (vi) of the Haryana Civil Service (Government Employees Conduct) Rules, 2016.

The lapses detailed above constitute grave misconduct on your part of Sh. Manoj Kumar Nandal, (the then) Clerk office of DEO Rohtak, rendering yourself liable for strict disciplinary action under rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016.



2. That he did not take any interest to attend Civil Appeal No. 87 of 2017 titled as Suresh Singh & others V/s State of Haryana & others in the Hon'ble District Judge-Cum Educational Tribunal, Rohtak at the time hearing of the same on any date and never made serious efforts in this case.

In this way, he had shown lack of responsibility and devotion to duty and acted in a manner which is unbecoming of Government official of his status and thereby contravened the provision of rule 4 (ii), 5 (i) (vi) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016.

The lapses detailed above constitute grave misconduct on the part of Sh. Manoj Kumar Nandal, (the then) Clerk office of DEO Rohtak rendering himself liable for strict disciplinary action under rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016.





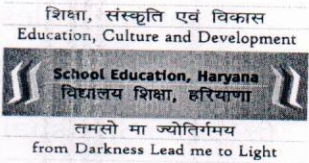

He is directed to join at the place of posting as mentioned below:-

Terms and conditions:-

1. The benefit of ante-date appointment will be admissible w.e.f. 06.08.2014 from the date when his/her juniors have been appointed only for notional pay fixation & seniority. The actual financial benefits will be admissible to him/her from the date he/she joins duty as **PGT Sanskrit**.
2. He/She is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
3. He/She shall have to take an oath of allegiance to the Constitution of India.
4. In case he/she is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If he/she has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt him/her from this condition.
5. He/She shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant

service rules and instructions of the State Government issued from time to time later on.

6. He/She shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.
7. In the matters, not specifically mentioned in this communication, he/she shall be governed by the Haryana Civil Services Rules as applicable to Haryana Government Employee and such orders/instructions as may be issued by the Government from time to time.
8. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/ Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be, is false then his/her service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
9. Candidate is hereby directed to produce his/her original certificates of academic qualifications and other relevant certificate to the District Education Officer concerned alongwith photostat self- attested copies. District Education Officer is directed to compare the photo copies with the original and thereafter original certificates and testimonials will be returned to the candidate.
10. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining. District Education Officer will also give character and antecedent verification forms to his/her and after filling the form, the candidate would submit it to the District Education Officer concerned immediately.
11. He/She shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
12. If at any time during the course of his/her temporary appointment, he/she desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
