

Subject:- Extension/ provisional affiliation of one year to Private Schools for academic session 2021-2022.

Your attention is invited on the subject cited above.

It is to inform you that the Department was in receipt of several representations from the Private School Associations requesting for extension of provisional/temporary affiliation granted to the schools. Whereas, it is quite essential to take cognizance and safeguard the interests of the students studying in such schools. Thus, the Government after due deliberation and consultation has decided to grant provisional affiliation for another academic session i.e. 2021-22 to such schools whose cases of recognition have not been finalized by the Department/DLC.

However, the same is subject to the condition that:-

- The aforesaid schools shall have to produce the proof of temporary recognition/affiliation granted by the department during the last session i.e. 2020-21.
- No further extension will be granted to such schools and they have to ensure that they do not admit students in their Schools from the next academic session i.e. 2022-2023.
- Any act contrary to the provisions of the rules will invite appropriate action under the relevant rules.

1. If any, disciplinary proceeding under Rule 7 or 8 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 is found pending subsequently, the said incumbents(s) shall be reverted without issuing any notice.
2. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
3. If subsequently, it is found that any candidate has done Post Graduation or other qualifications in distance mode from Deemed Universities from study centers located outside the campuses of the University, without seeking approval of UGC and the State Government, the same shall be reverted in view of division bench judgment of Punjab and Haryana High Court in CWP No. 1640 of 2008 decided on 06.11.2012 titled as Kartar Singh Versus Union of India and others cited in 2013(1) RSJ 224. Moreover, LPA No. 19 of 2021 titled as State of Haryana and others Vs Shri Bhagwan and others has filed by the department, in which the Hon'ble Bench has stayed the order dated 16.10.2019 and the same is listed for hearing on 04.02.2022.
4. If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate(s) shall be reverted in view of Govt. instructions dated 31.05.2006.
5. If any discrepancy regarding not fulfilling the essential qualifications eligibility as prescribed in the Haryana State Education School Cadre (Group B) Service Rules, 2012', the said incumbent(s) shall be reverted without issuing any notice.
6. This promotion order is based on provisional seniority list and without prejudice to the right of the seniors to be considered if they opt for promotion as **PGT (Political Science)** provided those seniors are found eligible for the post.




