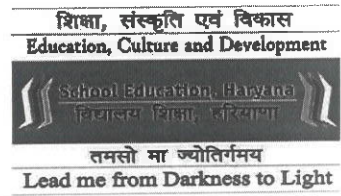

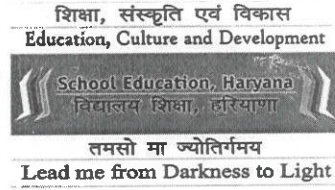

Whereas Sh. Sandeep Singh, the then clerk O/o DIET Kaithal now Clerk, GMS Salimpur, Kaithal was chargesheeted under rule-7 of Haryana Civil Service Rules (P&A) Rules, 2016 vide this office order No KW 2/01-2014 HRME-I(3) dated 14.12.2017 and as per the enquiry report of DEO, Kaithal. The following charges were levelled against him:-

"That Sh. Sandeep Singh, Clerk while forwarded/recommended the promotion case of Sh. Parveen Kumar, Clerk for the post of Statical Assistant without verifying the facts that Sh. Parveen Kumar was not entitled for promotion as the punishment of stoppage of 10 annual increments with cumulative effect had been passed in a case of embezzlement of funds was inflicted, vide office order No. 5/63-2002 ME (2) dated 17.03.2009, which were very serious lapse on his part and he is responsible.

Thus, Sh. Sandeep Singh, Clerk had shown lack of responsibility and devotion to duty and had acted in a manner which is unbecoming of a Government official of his status and thereby he contravened the provision of rule 4 of the Haryana Government Employees (Conduct) Rules, 2016.

The lapses detailed above constitute grave misconduct on the part of Sh. Sandeep Singh, Clerk rendering himself liable for strict disciplinary action under rule 7 of HCS (P&A) rules 2016."

In response to this, Sh. Sandeep Singh, Clerk replied to the chargesheet on dated 15.01.2018 and denied all the charges levelled against him. The reply filed by him was found unsatisfactory. Sh. Jogender Singh Hooda, DEO, Kaithal was appointed as an Enquiry Officer to hold the regular departmental Enquiry vide order No KW 2/01-2014 HRME-I(3) dated 29.11.2018/07.12.2018. The Enquiry Officer submitted the the Enquiry Report on 21.06.2019. In the Enquiry Report, it was stated that Sh. Sandeep Singh, Clerk forwarded/recommended the promotion case of Sh. Parveen Kumar, Clerk for the post of Statical Assistant without verifying the facts that he was not entitled for promotion as the punishment of stoppage of 10 annual increments with cumulative effect had been imposed upon him in a case of embezzlement of funds, vide office order No. 5/63-2002 ME(2) dated 17.03.2009, which was very serious lapse on his part and he is responsible for the same. Thereafter, a punishment of stoppage of two annual increments with cumulative effect was inflicted upon Sh. Sandeep Singh vide order dated 11.10.2019/13.12.2019.

Thereafter, Sh. Sandeep Singh filed an appeal dated 30.09.2020 against the order dated 11.10.2019/13.12.2019 with request to

drop the chargesheet dated 14.12.2017 and set aside this order. Subsequently, Sh. Sandeep was granted an opportunity of personal hearing on 12.11.2021 wherein he reiterated the same facts as submitted by him in his earlier reply.

After going through the contents of the appeal, reply to the chargesheet and the submissions made by the appellant during personal hearing and keeping in view the comments/report of District Education Officer, Kaithal, I, have come to the conclusion that the punishment order dated 11.10.2019/13.12.2019, whereby a penalty of stoppage of two increments with cumulative effect was imposed on him does not suffer any infirmity. Hence, the same is upheld and the present appeal is hereby dismissed.
