ORDER

On the recommendation of Haryana School Teachers Selection Board, Panchkula conveyed vide their Memo No. 2/1/2013-HSTSB/2013/CA/45 dated 13.01.2014, the Governor of Haryana is pleased to appoint the following candidate as Post Graduate Teacher (PGT) **Hindi** (HES-II) in the pay band of Rs. 9300-34800 + Grade Pay 4800/- plus usual allowances as admissible from time to time. She is directed to join at the place of posting as mentioned below:-

Terms and conditions:-

1. He/She is appointed purely on temporary basis.
2. He/She is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
3. He/She shall have to take an oath of allegiance to the Constitution of India.
4. In case he/she is married, he/she shall produce a certificate, before joining duty, to the effect that he/she has only one living spouse. If he/she has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt him/her from this condition.
5. He/She shall not claim seniority on the basis of this order. His/Her inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.
6. He/She shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.

7. In the matters, not specifically mentioned in this communication, he/she shall be governed by the Haryana Civil Services Rules as applicable to Haryana Government Employee and such orders/ instructions as may be issued by the Government from time to time.
8. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/ Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be, is false then his/her service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
9. Candidate is hereby directed to produce his/her original certificates of academic qualifications and other relevant certificate to the District Education Officer concerned alongwith photostat self- attested copies. District Education Officer is directed to compare the photo copies with the original and thereafter original certificates and testimonials will be returned to the candidate.
10. Medical fitness certificate issued by the concerned Civil Surgeon will be produced before the joining. District Education Officer will also give character and antecedent verification forms to his/her and after filling the form, the candidate would submit it to the District Education Officer concerned immediately.
11. He/She shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
12. If at any time during the course of his/her temporary appointment, he/she desires to resign, then in such eventuality, he/she shall be required to give one month's notice or forfeit, in lieu thereof, his/her one month's salary including allowances etc.
13. No TA/DA will be admissible to the candidate for joining as PGT.
14. If he/she gets an appointment as PGT on the basis of his/her furnishing ineligible/invalid qualifications, false/forged or fraudulent information / facts which are detected later on, he/she would be liable for termination of service without any notice.

15. In case, he/she has not passed STET/HTET and B.Ed. as yet, he/she shall have to qualify HTET and B.Ed. as mentioned in Rule 19A of the 'Haryana State Education School Cadre (Group-B) Service (Second Amendment) Rule, 2012' amended from time to time, otherwise his/her appointment shall stand terminated automatically without giving any further notice.
16. The appointment will be subject to the final outcome of SLP No 7820 of 2013 and other connected SLPs pending for adjudication in the Hon'ble Supreme Court of India, CWP No 18693, 20344, 17656 of 2012 pending in Hon'ble Punjab and Haryana High Court.
17. The appointment will be subject to the condition of good moral character as the verification report is awaited from the District Magistrate, concerned and Superintendent of Police, concerned.
18. If he/she is willing to accept this offer of appointment as PGT, HES-II (School Cadre) on the above terms and conditions, he/she should submit his/her joining report as per aforesaid directions.
19. **He/She is directed to join his/her place of posting within 15 days and send the joining report (duly signed by DDO) at dsepgt1@gmail.com, failing which this offer of appointment letter will be deemed to have been withdrawn.**

Further the sanction may be accorded to all the DEOs to disburse the same to the approved Managements/Administrators of the concerned Aided School under their control in their respective Districts subject to the following conditions:-

1. The amount shall be charged/debitable to the Major Head 2202-General Education-02-Secondary Education-110- Assistance to Non Govt. Secondary Schools-98-Grant-in-aid to Non-Govt. School (Salary Grant) scheme as figuring in the printed budget for the year 2021-22.
2. Under no circumstances, the total amount drawn during the year shall exceed the amount indicated in this sanction order unless and until the same is reviewed at the time of finalization of Revised Estimates for the year 2021-22.
3. It is likely that actual justification/requirement for release of funds by the Directorate may be lower/excess than the amount indicated in the schedule attached herewith. If that be the situation, the concerned DEO will be competent to draw the amount indicated for the quarter plus minus the un-utilized portion of the amount for the previous (s) installments of 3rd quarter as the case may be subject to the condition that such un-utilized portion should not exceed 100% of the installments for the quarter. **It may also be ensured that this installment of salary grant should not exceed of the 75% of admissible grant for the year of 2021-22 of the concerned schools. This amount may be drawn lumpsum before the end of the 3rd Quarter or not later than 31, December, 2021 positively.**
4. The DEO will be responsible for proper utilization of the amount as sanctioned above in accordance with the stated objectives of the scheme. Further, the sanctioned amount shall not be utilized for any purpose other the one for which it has been sanctioned.
5. The DEO will ensure to obtain the claim of Gratuity from concerned school at their own level and ensure the payment of Gratuity of employees in time. DEOs will be responsible for any lapse of Grant and delay in payment. The DEOs will also ensure the utilization certificates from the GIA receiving bodies and take all steps considered necessary to ensure that the amount has been utilized properly including audit of accounts of grant receiving bodies.
6. The DEO will ensure that the pay of unqualified teachers shall not be charged from salary grant.
7. The DEO may reduce the grant where an employment in any recognized aided school a teacher whose certificate has been withdrawn or who has after due enquiry been declared unfit to be a teacher by the department.
8. No aid shall be admissible, on any special increment, allowance or financial benefit given to the employees by the managing committee at its own level.
9. No aid shall be granted in respect of any employee, who is retained in service beyond the age of superannuation, except in the case of National/State awardees in which extension has been approved by this Directorate.
10. No aid shall be admissible in the case of an employee appointed by the managing committee on part time basis.
11. The minimum number of weekly period of actual secular instructions required for qualify a teacher for full staff, grant shall not be less than as laid down by the department from time to time provided that the staff grant may be reduced or disallowed if this condition is not fulfilled.
12. No grant shall be calculated more than the prescribed scale of the post sanctioned by the department.

13. No grant shall be allowed for the post filled by the managing committee without the approval of the department.
14. The rate of dearness allowance, house rent allowance compensatory allowance shall be claimed as allowed by the Govt./Department from time to time.
15. The District Education Officer shall draw the amount of salary grant sanctioned to the school and remit the amount to the duly authorized correspondent of the school concerned through bank draft/account payee cheque immediately. It should also be ensured that the school has authorized managing committee duly approved by the department. It may also be ensured that the management has actually been made the payment to the employees during the year 2021-22 for which the claim is made.
16. The amount should be rechecked and make payment to the school accordingly but should not be more than the amount to the school. The APRs be sent to the Directorate by 31.12.2021 positively and utilization certificate in respect of this grant duly countersigned by DEO must be sent to the Accountant General., Haryana, Chandigarh directly within 15 days with a copy to this Directorate for record.
17. It may please be ensured that the salary grant is not to be released to the institutions from whom the utilization certificates in respect of any previous grant-in-aid is awaited.
18. No grant will be given to the institution in case it is not permanently recognized.
19. No grant will be given to the intuition, if it does not fulfil any condition laid down in the rules for release of the grant.
20. No grant will be given to the institution if any proceedings under Haryana School Education Act, 1995 and rules made there under are pending.
21. DEOs may ensure that grant is not to be released in those cases where institution has been paid the salary of the employees for the last quarter of 2021-22.
22. DEO may ensure that grant is not be released for those posts on which the teachers working on sanctioned posts have been declared surplus in rationalization report which has been sent to his office/management of the school.
23. DEO may also ensure that Employer's share of CPF (25 % of 10 % of Basic Pay) w.e.f. 5/98 to 12/2021 has been deducted from Grant-in-aid claims of concerned schools. CPF amount may be worked out by S.O. and if any amount is found yet to be recoverable from any school management, the same may be deducted from payable Grant-in-aid of concerned school before releasing this instalment of Grant-in-aid.
24. All the DEO's may be directed that the grant allocated to them under this sanction will be utilized for the purpose of payment of pending salary of the staff working on sanctioned posts in the aided schools of their districts till the date of their taken over in Govt. Schools and the staff who is still working on sanctioned posts who have not given option for taken over or whose case is still pending in the department for their taken over.
25. All the DEO's may be directed to send the details of the claims duly verified by the Section Officers of their Districts regarding the payment of arrears on account of the revision of the pay scales of staff working on aided schools w.e.f. 01.01.2016 till the date of taken over/relieving from the

aided schools and up-to-date in case of the staff who is still working due to not taken over by the department or have not given option for their taken over in Govt. Schools latest by 31.12.2021 through email aideddse@gmail.com.

26. All the DEO's may be further directed that in case the payment of arrears of salary of all the staff already take over remains balance in that case only the arrear of the 6th & 7th Pay Commission may also be paid through Escrow Accounts after verification of the same by the Section Officer of their offices.
27. The 75% salary grant in aid is granted to aided schools under rule 54(1) of Haryana School Education Rules, 2003.






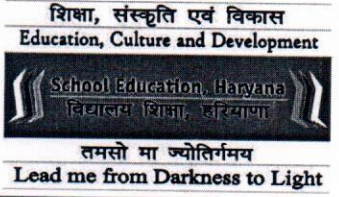

Jitender Kumar [041627] PGT Mathematics (Retd.)** was appointed as Maths Master on 12.11.1991 vide order No. 2/65-1991 E-IV (2) dated 31.10.1991 and thereafter, he was given ante-dated promotion as PGT Mathematics w.e.f. 18.01.1996 vide order No. 15/29-2020 PGT-I (3) dated 02.11.2020.

Whereas, promotion of one Smt. Kanta Devi was made vide order dated 29.01.1999 w.e.f. 18.01.1996 against a vacancy in female promotion quota under Punjab Educational Service, Class III, School Cadre Rules, 1955.

Thereafter, Sh. Jitender Kumar was granted ante-dated promotion to the post of PGT Mathematics w.e.f. 18.01.1996 in view of promotion of Smt. Kanta Devi being his junior vide order No. order No. 15/29-2020 PGT-I (3) dated 02.11.2020. Whereas, the promotion order was issued ignoring the fact that Smt. Kanta Devi being a female had been promoted against a vacancy in female quota.

Whereas, under Punjab Educational Service Class-III, School Cadre Rules, 1955, Appendix 'B', Men and Women teachers were appointed & promoted separately at that time. Under these rules, a separate promotion quota was allocated for male and female employees working under School Education Department under these rules, promotion of male & female employees were done separately as and when vacancy was available in their respective category.

In view of the above, a show-cause notice bearing No. 15/29-2020 PGT-I (3) dated 09.07.2021 was served upon Sh. Jitender Kumar to show why his promotion order should not be cancelled. Accordingly, Sh. Jitender Kumar replied the same vide dated 23.07.2021 wherein he contended that his promotion was processed through proper channel and as per rules.

Whereas, in pursuance of the above said Show Cause Notice and reply served by Sh. Jitender Kumar, an opportunity of personal hearing accorded to Sh. Jitender Kumar on 07.12.2021, through video conference. During the course of hearing, Sh. Jitender Kumar gave example of Sh. Dharamvir Singh, TGT Mathematics. The same has been examined minutely and found that promotion orders of Sh. Dharamvir Singh, have been withdrawn vide order No. 15/142-2017 PGT-I (3) dated 15.01.2022.

Keeping in view of the above said facts and circumstances, reply of incumbent & documents on records, it is observed that Sh. Jitender Kumar was not entitled for ante dated promotion w.e.f. 18.01.1996 as PGT Mathematics. Moreover, merely stating by him that the promotion order was

issued through proper channel is not tenable when he himself conceals the material facts and misguides the department. Accordingly, the show-cause notice vide dated 09.07.2021 is hereby confirmed and ante-dated promotion vide order No. 15/29-2020 PGT-I (3) dated 02.11.2020 wherein Sh. Jitender Kumar got undue benefit of ante-dated promotion w.e.f. 18.01.1996 as PGT Mathematics, is hereby withdrawn with immediate effect.

It is ordered accordingly.



Whereas, **Sh. Dharmvir Singh [008093]** Principal Govt. Model Sanskriti Senior Secondary School, Badhra (Charkhi Dadri) [658] initially appointed on adhoc basis on 30.12.1986 and his service was regularized on 01.01.1991.

Whereas, promotion of one Smt. Sujita was made vide order dated 20.08.1999 w.e.f. 18.01.1996 against a vacancy in female promotion quota under the then Punjab Educational Service Class III, School Cadre Rules, 1955.

Thereafter, Sh. Dharmvir Singh was granted ante-dated promotion w.e.f. 18.01.1996 in view of promotion of Smt. Sujita being his junior vide order No. 15/142-2017 PGT-III (9) dated 18.05.2018. Whereas, the promotion order was issued ignoring the fact that Smt. Sujita being a female had been promoted against a vacancy in female quota that time.

Whereas, under Punjab Educational Service Class III, School Cadre Rules, 1955, a separate promotion quota was allocated for male and female employees working in School Education Department. Under these rules, promotion of male employees and female employees was done separately as and when vacancy appeared in their respective category. Smt. Sujita got promotion when the respective vacancy was available in her allotted quota.

Whereas, a show cause notice vide no. 15/142-2017 PGT-I (3) dated 09.07.2021 was served upon Sh. Dharmvir Singh as to show why his promotion order should not be cancelled. He replied vide dated 23.07.2021 wherein he contended that his promotion was processed through proper channel & done as per rules.


In pursuance to the reply submitted by Sh. Dharmvir Singh, the ante-dated promotion case was examined according to prevailing rules & instructions (amended upto date) and as per Educational Service Class III, School Cadre Rules, 1955. Resultantly, and it has been found that Sh. Dharmvir Singh was granted ante dated promotion in-advertently. However, as per Rules *supra*, he was not entitled for promotion since the provisions contained under Educational Service Class III, School Cadre Rules, 1955 provides separate quota for both male and female employees in their respective category.

Whereas, in pursuance of the above said Show Cause Notice and reply served by Sh. Dharmvir Singh, an opportunity of personal hearing was

accorded to Sh. Dharmvir Singh on 07.12.2021, through video conference. During the course of hearing, incumbent gave another example of Sh. Sushil Kumar, TGT Mathematics. The same has been examined and found that Sh. Sushil Kumar's case is also not applicable to him as he belongs to reserved category of backward class and his promotion was also made under quota of reserved category from TGT Mathematics to PGT Mathematics and whereas Sh. Dharmvir Singh belongs to general category.

Keeping in view of the above said facts and circumstances, reply of incumbent and documents on record, it is observed that Sh. Dharmvir Singh was not entitled for ante dated promotion as PGT Mathematics. Moreover, merely stating by him that the promotion order was issued through proper channel is not tenable when he himself conceals the material facts and misguides the department. Accordingly, the show-cause notice bearing no. 15/142-2017 PGT-I (3) dated 09.07.2021 is hereby confirmed and ante-dated promotion order bearing no. No. 15/142-2017 PGT-III (9) dated 18.05.2018 vide which Sh. Dharmvir Singh was promoted w.e.f. 18.01.1996 as PGT Mathematics, is hereby withdrawn with immediate effect.
