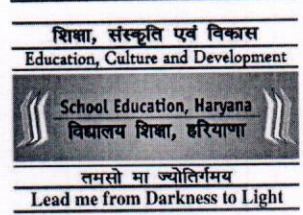

1. If any, disciplinary proceeding under Rule 7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 is found pending subsequently, the said incumbent(s) shall be reverted without issuing any notice.
2. **This promotion orders are subject to final outcome of Civil Writ Petitioner No. 19403 of 2019 titled as Baljit Singh and others V/s State of Haryana and Civil Writ Petition No. 20416 of 2021 titled as Dharamvir Singh & others Vs State of Haryana.**
3. **This promotion orders shall remain to the final outcome of LPA No. 1773 of 2013 titled as Dinesh Kumar Vs State of Haryana and Show Cause Notices given to them, if any.**
4. The promote(s) will remain on probation for one year as per rule 27 of Haryana Civil Services (General) Rules, 2016.
5. If the currency of penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate shall be reverted in view of the CS office instructions dated 31.05.2006, without issuing any notice.
6. The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding the integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
7. If subsequently, it is found that any candidate has done Post Graduation or other qualifications in distance mode from deemed Universities from study centers located outside the campuses of the University, without seeking approval of UGC and the State Government, then such candidate shall be reverted in view of Division Bench judgment of Punjab and Haryana High Court in CWP no. 1640 of 2008 decided on 06.11.2012 titled as Kartar Singh Versus Union of India and others cited in 2013(1) RSJ 224.

9. In case the promote officer found ineligible for the feeder post or unsuitable for appointment/promotion as Headmaster on account of any reason, such officer shall stand reverted without any notice.

10. In the case of candidates whose inter se seniority as Head Master is not available in the database, then such candidates will be suitably placed by determining their inter se seniority as Head Master and will be assigned subsequent seniority in the corresponding Principal seniority list accordingly.
11. If subsequently any senior person becomes eligible for promotion due to availability of ACRs or other records, then in that eventuality, he/she shall be treated as senior to any promoted junior candidate, even if promoted later.
12. After joining at the station allotted herein he/she shall proceed on a School Leadership training to be imparted through *Teacher Education Institutions* controlled by the SCERT, Haryana. The detail programme in this respect shall be communicated to her by the SCERT, Haryana.
13. Needless to say, the present promotion is subject to the outcome of any court case pending in any court of law which might have any bearing on the present order.

Order No. 13/123-2020 PGT - I (2)

Dated, Panchkula, the 06/02/2022

Whereas, Sh. Vinod Ranga had filed the CWP No. 2619 of 2021 - Vinod Ranga Vs. State of Haryana & Others in the Hon'ble Punjab & Haryana High Court, praying therein for issuance of an appropriate writ specially in the nature of Mandamus directing respondents to consider the candidature of petitioner to the post of PGT (Fine Arts) under SC Category against Advt. No. 5/2015 dated 05.07.2015. The petitioner further prayed for issuance of necessary directions to respondents to keep one post reserve for the petitioner and not to re-advertise the same, during the pendency of present writ petition. Petitioner also prayed for issuance of necessary directions to respondents to not to relieve/terminate the petitioner from the post of PGT (Fine Arts) on which petitioner is already working.

The above mentioned writ petition came up for adjudication on 26.04.2021 and the Hon'ble Court disposed of the same vide order dated 26.04.2021. The operative part of the same is as under: -

".....Without commenting on the merits of the case, the present petition is disposed off with a direction to respondent nos. 2 and 3 to take a decision on the legal notice dated 04.08.2020 (Annexure P-5) in accordance with law expeditiously and in any case within a period of three months from the date of receipt of certified copy of this order.

Disposed off accordingly."

In compliance of the above said order dated 26.04.2021 passed by the Hon'ble High Court, the legal notice dated 04.08.2020 (Annexure P-5) has been minutely examined. Whereas, Sh. Vinod Ranga was earlier appointed as TGT (Fine Art) in O/o Director Elementary Education vide their office order bearing no. E-2-2010/3086-3200 dated 05.05.2010.

Whereas, Sh. Vinod Ranga applied for the post of Post Graduate Teacher (hereinafter referred to as 'PGT') - Fine Arts, under the Advertisement No. 5/2015, Category No. 2. The said selection process in view of the advertisement

dated 05.07.2015 was conducted by the Haryana Staff Selection Commission (hereinafter referred to as 'HSSC'). But during the said recruitment process, Sh. Vinod Ranga was promoted as PGT -Fine Art, vide this office order bearing no. 15/11-2016 PGT-II (3) dated 13.07.2016.

Whereas, HSSC recommended the name of the petitioner at Sr. No. 116 in the Joint Merit List for the post of PGT Fine Arts dated 09.01.2019 against the Advt. No. 5/2015. This recommendation was subject to following conditions: -


“The selected candidate has not been medically examined and no special enquiry into her antecedents has been made. The documents pertaining to their Educational Qualification, age, Caste/category and universities as claimed by them in the application form may please be got checked/verified from the issuing authorities, before they are allowed to join their duties. A copy of the appointment letter issued to the candidate may also be endorsed to the Commission.”

Whereas, in pursuance to the recommendation *supra*, the department issued public notice dated 15.01.2019 vide which all the recommended candidates were requested to appear before the Document Verification Committee (hereinafter referred as 'DVC') on 17.01.2019. Accordingly, petitioner attended the DVC along with other recommended candidates on 17.01.2019. Thereafter, during online counselling conducted for temporary posting of newly selected PGTs, Sh. Vinod Ranga did not opt for any preference/station, rather, submitted his option for forgo appointment with remarks ***'Forgo appointment orders (Already promoted as PGT from TGT)'***.

Whereas, it was the pre-requisite condition that any employee who has already been serving under any Government Department/Body, have to produce No Objection Certificate issued by his/her previous employer at the time of DVC procedure. But, Sh. Vinod Ranga neither show any No Objection Certificate issued by his previous employer to the DVC nor gave any justifiable reasons for the same.

In view of the above mentioned facts and official record,, the claim of the petitioner demanded through Legal Notice dated 04.08.2020 (Annexure P - 5) is not tenable due to the reasons stated *supra* and same is hereby rejected being devoid of merits.

I, order accordingly.


