ORDER

Order No. 5/18-2015 HRME-II (1)

Dated: 21/2/2022

Whereas, Sh. Rajender Kumar, Clerk, GSSS, Mirzapur (Kurukshetra) was charge-sheeted vide order No. 05/18-2015 HRME-I dated 23.08.2018 U/R 7 of Haryana Civil Services (Punishment and Appeal) Rules, 2016, wherein the following charges were levelled against him:-

1. यह कि श्री राजेन्द्र कुमार, लिपिक, रा0व0मा0वि0, मिर्जापुर (कुरुक्षेत्र) ने कक्षा 9 से 12वीं तक के कक्षा इंचार्जों से बच्चों के फंड व ट्यूशन फीस के रूप में एकत्रित राशि 16,656 रुपये प्राप्त कर जानबूझकर विधालय में जमा नहीं करवाये हैं, जिस बारे उसके विरुद्ध U/S 409 IPC थाना शहर, थर्ड गेट, कुरुक्षेत्र युनिवर्सिटी, कुरुक्षेत्र में FIR क्रमांक 0179 दिनांक 24.04.2018 दर्ज है।
2. श्री राजेन्द्र कुमार, लिपिक, रा0व0मा0वि0, मिर्जापुर (कुरुक्षेत्र) ने बिना अवकाश स्वीकृत करवाये दिनांक 13.10.2017 से लगातार ड्यूटी से अनुपस्थित चल रहा है।
3. कर्मचारी अनुपस्थित रहने का आदी है तथा पहले भी अनुपस्थिति के कारण कर्मचारी की दो वार्षिक वेतन वृद्धियां रोकी गई है।

Whereas, the employee submitted his reply to the charge-sheet on 05.12.2018 wherein he explained the circumstances of his family which affected him physically, mentally as well as financially and consequently, he was issued charge-sheet dated 23.08.2018.

Whereas, Smt. Shashi Budhwar was appointed as Enquiry Officer vide order No. 5/18-2015 HRME-II(1) dated 05.08.2021 in the aforesaid matter and in context of the same, Inquiry report dated 29.10.2021 was submitted by the Enquiry officer and the charges levelled against Sh. Rajender Kumar, Clerk stood proved.

Earlier also, Sh. Rajender Kumar, Clerk was charge-sheeted U/R 7 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 vide order No. 5/18-2015 HRME-I dated 07.11.2015 for his willful absence from duty without any information, consequently vide order No. 5/18-2015 HRME(1) dated 11.10.2017, the punishment of stoppage of two annual increments without cumulative effect was inflicted upon him. However, during the pendency of inquiry in this case, he was allowed to join and at that time, he had assured to improve his behavior in future.

As per his earlier assurance, no change was found in the behavior of the employee. He again committed certain acts of omission and commission due to which he was charge-sheeted vide order No. 5/18-2015 HRME-I dated 23.08.2018 and also, the charges levelled against him stood proved as per the Enquiry report dated 29.10.2021.

Whereas, before taking any decision on the charge-sheet of the employee, an opportunity of personal hearing was granted to him on 05.01.2022 and even during

his personal hearing, he referred his family circumstances due to which he was issued the charge-sheet dated 23.08.2018 and requested to permit him to join his duty.

Whereas section 4 of Haryana Civil Services (Government Employees' Conduct) Rules, 2016 (hereinafter referred to as "Rules") provides with General Rules relating to misconduct of Govt. employees, the relevant portion of Section 4 is reproduced below for further clarity

"4. General.—

(1) Every Government employee shall at all times—

- (i) maintain absolute integrity;
- (ii) maintain devotion to duty;
- (iii) do nothing which is unbecoming of a Government employee; and
- (iv) act in accordance with the Government's policies.

Explanation.— A Government employee who habitually fails to perform a task assigned to him within the time set for the purpose and with the quality of performance expected of him shall be deemed to be lacking in devotion to duty within the meaning of clause (ii) above.

(2) (i) Every Government employee holding a supervisory post shall take all possible steps to ensure the integrity and devotion to duty of all Government employees under his control and authority."

Whereas, Section 5 of Haryana Civil Services (Government Employees' Conduct) Rules, 2016 further elaborates acts and omissions amounting to misconduct, which interalia includes wilful insubordination or disobedience; unfaithfulness; untrustworthiness; acting subversive of discipline; habitual negligence in respect of the duties for which one is engaged. Therefore, I am totally satisfied that the act of the employee amounts to misconduct as under the aforementioned section.

Whereas, I am fully convinced that only those employees deserve sympathy who are conscientious, sensitive, devoted and not the one's who view Departmental inaction or mild punitive measures of the Department as its weakness and continue with their defiant delinquent behaviour with a belief of going scot free on one ground or the other. Infact, mild or no action further emboldens such employees who either try to pressurize the supervisory officials through political approaches or rely on humanitarian side of the supervisory officer/punishing authority and resort to emotional blackmailing during the Departmental proceedings. Whereas, it has to be essentially understood by the employee itself that it is they who are responsible for their actions and could have avoided such penal actions by improving their conduct timely. When they themselves apparently don't care a wee bit about their family, mental harassment, stigma or things alike

about the eventual repercussions of their defiant, delinquent and audacious behaviour, then expecting a supervisory officer to show remorse, sympathy and kindness (at a belated stage) is unwarranted.

Furthermore, it cannot be denied that delinquent behaviour is infectious; not taking any stringent action against the erring employee emboldens other to follow suit and thus spread indiscipline amongst the organisation. Besides, any inaction by the punishing authority as in instant case shall also tantamount to injustice to several other employees who are similarly placed and situated but sweating out their blood and working tirelessly with all sincerity and diligence.

Thus, bare perusal of the past service record clearly shows that the employee never took his services seriously and lacked devotion to his duty because of which he has been punished in the past as well, but the employee never showed any signs of improvement. Therefore, having perused the past record of the employee and details, facts and circumstances as aforementioned; and having convinced myself that proceedings initiated were completely fair, just and impartial. Hence, I am of the considered opinion that the employee is not entitled to continue his service in future. But while adopting the lenient view and due to his adverse family circumstances, compulsory retirement is hereby accorded to Sh. Rajender Kumar, Clerk, GSSS, Mirzapur, Kurukshetra.

Whereas Sh. Ravinder Kumar the then Clerk, GHS Buana, Jind now Govt. Sr. Sec. School, Igrah, Jind was charge sheeted under Rule-7 of Haryana Civil Services (Punishment & Appeal Rules), 2016 vide order No. 5/68-2017 HRME-I (6) dated 15.09.2020, wherein, the following allegations were leveled against him:-

“That Sh. Ravinder Kumar the then Clerk of Govt. High School Buana, Jind now posted in Govt. Sr. Sec. School, Igrah, Jind was found guilty of harassing the staff members as well as he was indulged in sexual activities with one female employee at work place namely Smt. Sunita Rani, Sanskrit Teacher. An FIR No. 90 dated 24.07.2017 was also lodged against him u/s 354-A, 506, 34 IPC”.

The delinquent submitted his reply on 16.01.2018 to the charge-sheet contended therein that there was no fault on his part and hence denied the charges leveled against him. The delinquent further prayed to drop the charge-sheet issued against him.

Thereafter, vide order no. 5/68-2017 HRME-I (6) dated 21-05-2018 Sh. Vijay Kumar Verma, Joint Director Prosecution Haryana (Retd.) was appointed as Inquiry Officer in the matter and in context of the same inquiry report on dated 24.10.2018 was submitted wherein the allegations against the delinquent stand proved. Consequently the punishment of *“stoppage of five annual increments with cumulative effect was inflicted by Additional Director vide order no. 5/68-2017 HRME-I (6) dated 15.09.2020 of Sh. Ravinder Kumar the then Clerk of Govt. High School Buana, Jind.”*

Whereas on 01.10.2020 an appeal was preferred by the delinquent to Director Secondary Education Haryana, Panchkula against the order dated 15.09.2020 of Additional Director. Thereafter, he was accorded an opportunity of personal hearing on 04.02.2022 and during his personal hearing he has

submitted the order of JMIC, Jind dated 09.11.2017 vide which the cancellation report given by the Police, was accepted and the delinquent further pleaded that despite the order of the Court, a harsh penalty of stoppage of five annual increments with cumulative effect was imposed upon him.

After, hearing the applicant and pursuing all the relevant documents, I am of the considered view that the penalty imposed upon Sh. Ravinder Kumar is indeed harsh, when no criminal action was pending against him.

Hence, I amend the order of the Joint Director Admn-I that instead of stoppage of five annual increments, with cumulative effect, Sh. Ravinder Kumar, Clerk GHS Buana, Jind now Govt. Sr. Sec. School, Igrah, Jind is hereby strictly warned to be careful in future.

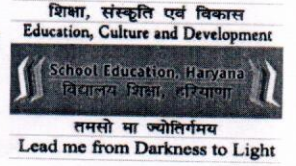

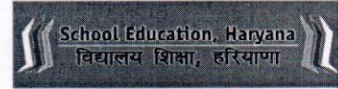
