Order No. 13/64-2021 PGT – I (2)

Dated, Panchkula , the 9.3.2022

Whereas, Smt. Manju filed the CWP No. 11191 of 2021 titled as Manju Vs. State of Haryana & Others before the Hon'ble Punjab & Haryana High Court under Article 226/227 of the Constitution of India with the prayer for issuance of writ, order or direction especially in the nature of mandamus directing the respondents particularly respondent No. 2 to grant the appointment to the petitioner to the post of PGT Physics at par with the similarly appointed candidates.

The above mentioned writ petition came up for adjudication on 29.06.2021 and the Hon'ble Court disposed of the same vide order dated 29.06.2021. The operative part of the order dated 29.06.2021 is as under: -

“.....“Accordingly, the present writ petition is disposed of, by directing the petitioner to put in appearance before respondent No. 2 /competent authority to whom representations have also been made wayback in 02.09.2020 (Annexure P-17). Resultantly, respondents are bound down by their undertaking and the necessary exercise be completed within 2 months. In case the benefit is to be denied to the petitioner and a favourable order is not to be passed, a reasoned order be passed and supplied to the petitioner, forthwith.”

In compliance of the above said order dated 29.06.2021 passed by the Hon'ble High Court, the representation dated 02.09.2020 has been minutely examined.

Whereas, Smt. Manju applied for the post of PGT Physics under Advt. No. 1/2012 dated 07.06.2012 issued by Haryana School Teacher Selection Board (hereinafter referred to as 'HSTSB'), now Haryana Staff Selection Commission (hereinafter referred to as 'HSSC'), on the basis of experience obtained from privately managed school. As per *Haryana State Education School Cadre (Group – B) Service Rule, 2012*, one time exemption for acquiring/passing Haryana Teacher Eligibility Test (HTET) was granted to those candidates who had worked in privately managed Government aided/recognized or Government aided of Government Schools for a minimum period of four years.

Whereas the HSTSB recommended the name of petitioner at Merit No. 526 vide letter No. 2/1/2013-HSTSB/2013/CA dated 20.03.2013. In pursuance to the recommendation received from HSTSB, the department constituted Document Verification Committee (hereinafter referred as 'DVC') to verify the genuineness of Educational qualification & Experience related

documents. Whereas, at the time of DVC, the petitioner submitted experience certificate issued from two schools namely Shiksha Bharti School, Rohtak and GSSS Kalanaur. As per experience certificate dated 26.06.2012 issued by Shiksha Bharti School, she worked as PGT Physics from 09.10.2007 to 22.12.2007. Furthermore, as per experience certificate issued by DEO Rohtak, petitioner worked as Guest teacher in GSSS Kalanaur from 19.05.2008 to 11.04.2012 (date of issuance of certificate).

Whereas, said experience certificates are required to be corroborated by other relevant documents such as attendance register, salary slips and statement of school staff etc. to establish the genuineness of the experience certificate. DVC Prima-facie observed that experience certificate produced by the petitioner is not genuine as it is not supported with relevant original record. In view of the observation of DVC, a show-cause notice was issued to the petitioner to show cause as to why her candidature be not cancelled. The operative part of the show-cause notice dated 15.07.2014 is reproduced here as under: -

“.....As per observation made by the committee, the experience certificate is not found genuine. Prima-facie the case is made out of initiation of the department/legal action and to recommend to the HSTSB for cancellation of candidature in respect of Manju D/o Pramod Kumar recommended by HSTSB, Panchkula for appointment as PGT in Physics. But before initiating any action, the show-cause notice is hereby served as to why the recommendations for cancellation of the candidature in respect of be not made to the appropriate authority.”

Whereas, the petitioner replied to the said show cause notice vide reply dated 23.07.2014 vide which it was stated that the experience certificate obtained by her is genuine and she fulfils the essential qualifications, however, she did not produce any satisfactory record pertaining to her experience related qualification. Accordingly, the department again offered her opportunity for explanation as to why her name should not be proposed to Haryana Staff Selection Commission for withdrawal of candidature vide this office order bearing memo no. 6/4-2013 HRL (4) dated 17.11.2015, upon the same petitioner replied vide letter dated 21.12.2016, but she again did not submit any satisfactory proof w.r.t. her teaching experience.

Whereas, an opportunity of personal hearing was offered to the petitioner on 12.08.2021 for producing the relevant original school record to corroborate her experience certificate, however, petitioner again did not produce the original school record in support of her experience certificate.

In view of the above mentioned facts and non-production of relevant record pertaining to the teaching experience by the petitioner,

therefore, the claim of the petitioner demanded through representation dated 02.09.2020 is not tenable and same is hereby rejected being devoid of merits.

I, order accordingly.
