

Whereas, Sh. Rakesh Mor [207911] is working on the post of Post Graduate Teacher Hindi at GSSS Sukchain, Distt. Sirsa. A complaint has been filed by Sh. Vinay Kumar S/o Sh. Mansha Ram, Vill. Nimri Wali, District Bhiwani on CM Window portal vide complaint No. CMOFF/N/2016/011073. In the said complaint, the complainant alleged that Sh. Rakesh Mor got appointment as Post Graduate Teacher Hindi on the basis of HTET, whereas, the said examination was cleared by impersonating in his place.

A meeting has been held under the Chairmanship of OSD/CM on 20.10.2020 regarding complaints filed on CM Window portal and in the said meeting, it has been decided that Sh. Rakesh Mor, PGT Hindi be terminated from services due to the reason that he got the job on the basis of fake certificate.

In view of the complaint received on CM Window, number of communications have been made to the District Education Officer, Sirsa and Principal concerned with the request to take the thumb impression of Sh. Rakesh Mor and sent the same to the directorate, so that, the matter will be enquired accordingly, however, the District Education Officer, Sirsa informed that he is absent from duty w.e.f. 01.04.2020. After various number of communication made by the District Education Officer, Sirsa to his permanent address as well as on his E-mail address, you failed to appear before the District Education Officer for verification of your thumb impression. Hence, it is presumed that you are not willing for verification of your thumb impression

In view of the above, before it is decided that your services may be terminated as you got the government service on the basis of fake HTET

certificate, a show cause notice is hereby served upon you, to show reasons that why your services as Post Graduate Teacher Hindi are not be terminated with immediate effect. Reply, if any, you want to file in response to this notice, the same may be filed in the office of Director Secondary Education, Haryana, Panchkula not later than 15 days from the date of the receipt of this notice. In case you fail to respond the notice within a stipulated period, it shall be presumed that you have nothing to say/submit in this regard and decision will be taken ex-parte.

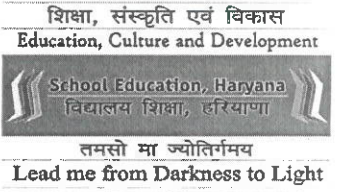

1. His appointment is subject to the condition that concerned District Education Officer may ensure the Character Certificate and all other documents regarding date of birth and all educational documents.
  2. He is also directed to participate in next online transfer drive for taking permanent Station.

**TERMS & CONDITIONS:-**

1. His appointment is against a purely temporary post which is liable to be abolished at any time and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to him at present. His services can be terminated without any notice, whenever there is no vacancy against which he can be retained.
2. If at any stage he desires to resign his posts he will be required to give one month's notice or forfeit in lieu thereof, his salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given to him by the Directorate Secondary Education, Haryana, Panchkula in case it is proposed to terminate his services for the reason other than that mentioned in clause (I) above.

3. He will be required to take the prescribed oath of allegiance to the constitution of India.
4. In case he is married, he will produce the following certificate to his/her Head of office:-

“That he/she is not having more than one living spouse.” In case they are unmarried, they shall have to furnish a declaration to the effect that each of these will not have more than one living spouse.
5. In case he is unmarried, he will have to furnish a declaration to the Head of the Department that he has not taken any dowry after marriage. The declaration should be signed by your wife, father and father-in law, as per Chief Secretary to Govt. Haryana letter No. 18/1/2004-2GSI dated 21.02.2006.
6. The candidate shall have to qualify the State Eligibility Test in Computer Appreciation and applications (SETC) within the probation period of two years, extendable by one year in case of direct recruitment. The candidate appointed against the aforesaid categories of posts in the group ‘C’ shall not be entitled to earn any increment in his pay scale till he/she qualifies the said test failing which the services of such employees shall be dispensed with.
7. He will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the pursuing of higher studies.
8. He will be required to produce the original Educational documents and date of birth certificate before joining his duties of the said post.

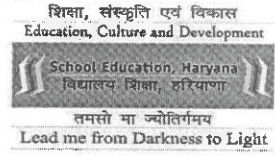
