

Order No. 13/163-2021 HRME-I (6) Dated, Panchkula, 16 3 2022

Whereas, the petitioners had filed the CWP No. 18841 of 2021 titled as Chhabil Das and others Vs State of Haryana & others in the Hon'ble High Court praying therein for issuance of a writ in the nature of Mandamus directing the respondents to grant similar pay scale to the petitioners as the other similar situated employees who have been selected out of the same selection list but have been allotted the other departments have been getting more pay scale than the petitioners but have been appointed in pursuance of the same selection process and grant the benefit of seniority to the petitioners above or at par with the candidates who are junior to the petitioners as per the merit list prepared at the time of selection pertaining to the advertisement dated 22.07.1987.

The above cited case came up for hearing before the Hon'ble High Court on 21.09.2021 and Hon'ble High Court was pleased to dispose of the present writ petition vide order dated 21.09.2021. The operative part of the same is reproduced as under:-

"Without commenting on the merits of the case, the writ petition is disposed of with the direction to the competent authority to look into the grievance of the petitioners as per legal notices dated 01.03.2021 (Annexure P-1 to P-3) and also by keeping in view the contentions raised in the present petition by treating the same as supplementary representation and take a decision, in accordance with law.

Let the needful be done within a period of 3 months from today.

### Disposed of accordingly."

In pursuance to the aforementioned directions of the Hon'ble High Court, the legal notice dated 01.03.2021 (Annexure P-2) of the concerned (petitioner i.e. petitioner No. 4) alongwith his service

record was examined and it has been found that petitioner No. 4 was appointed at the post of Clerk in the Education Department (presently working as Clerk in GHS Ratta Theh, Tehsil Tohana District Fatehabad) vide advertisement No. 1/86 and 4/87 dated 22.07.1987 issued by Subordinate Services Selection Board and the process from the publication of advertisement to the allocation of departments is to be conducted by the Subordinate Services Selection Board. Thus, the respondents department has no role in this process. Therefore, the respondents department i.e. Education Department is not answerable for the posting of the petitioner No. 4 in the respective department.

As far as the contention of the petitioner No. 4, in the present writ petition i.e. disparity in the salary is concerned, the same is not tenable because there are several posts (clerical grade) existing in FPL-2 (GP-1900) in the State of Haryana and ACP Structure for FPL-2 (GP-1900) is same. But, hierarchy for the post of clerks in different in some departments such as clerk is promoted to the post in FPL-4 (GP-2400) or FPL-5 (GP-2800). Due to the hierarchy for the post clerk like the Lower Divisional Clerk (LDC), Upper Divisional Clerk (UDC), Head Clerk, Auditor etc. in some departments, the clerk works on feeder post for long span. However, their pay is fixed by granting the benefit of increment from time to time. Whereas in absence of such hierarchy in Haryanaa Civil Secretariat and some other departments, the clerks get promotion directly to the post of Assistant and so on and their pay is fixed accordingly. The claim of the petitioner i.e. seniority at par with employees of Haryana Civil Secretariat and other department is not tenable as every department has its own seniority list. The seniority of one department cannot be compared with the other department. This practice is not prevalence. Every department has its own seniority list and similarly

this department i.e. Education Department has also maintained seniority list (Classwise) of its own employees. Presently the list dated 01.08.2015 is applicable on the petitioner No. 4, whereas petitioner No. 1, 2, 3 and 5 are not the employees of Education Department. Further, it is pertinent to mention here that the salary, promotion etc. of the employees of the concerned department totally depends upon the seniority list of the concerned department.

Whereas, each department and even the corporations established in the State have their own set of rules regarding the salary and other benefits and the same has been decided according to the settled rules, notifications and bye-laws of the concerned department/corporation. Thus, as per the aforementioned facts, the claim of the petitioner is not tenable as he has sought the benefits of the salary according to the seniority list of different departments.

Thus, the claim of the petitioner No. 4 i.e. Sh. Bhira Ram is hereby rejected being devoid of merits.

I order accordingly.
