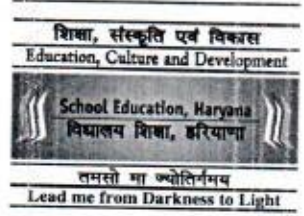

Terms and Conditions

1. This promotion is subject to final outcome of CWP No. 35929 of 2019 titled as Rajbir Singh V/s State and CWP No. 8791 of 2020 titled as Maha Singh Sindhu V/s State of Haryana.
2. The inter-se-seniority of the promote(s) shall be subject to the claim of their seniors, who have not been promoted in these order due to various reasons and for whom the posts have been kept reserved.
3. If any officer is found senior to these officers at any stage due to re-fixation of seniority in feeder cadre, they shall be reverted without giving any notice.
4. These promote(s) will remain on probation for a period of one year and which can be extended if their services are not found satisfactory.
5. The promotion is subject to the condition of pending ACRs mentioned against the name of the officers and if anything found adverse regarding their integrity in their ACR they will be reverted without giving any notice.

ORDER No. 13/151-2020 HRME- I(4) Dated, Panchkula, the 11.03.22

Whereas the petitioners have filed the CWP No. 13599 of 2020 titled as Balram and another Vs State of Haryana & others, before the Hon'ble Punjab & Haryana High Court, praying therein for issuance of a writ in the nature of certiorari to quash the transfer orders dated 14.08.2020 (P-3) qua the petitioners and further prayed for staying the operation of the transfer order dated 14.8.2020.

The above said Civil Writ Petition came up for adjudication before the Hon'ble High Court on 21.02.2022 and the same was adjourned by passing the following orders:-

"Learned counsel for petitioners has appraise the court that against the order impugned, written representations but submitted by both the petitioners on 20.08.2020 (P-4 colly), but the same has not been considered till date.

Learned State Counsel has acknowledged the above factual position and fairly submitted that the grievance shall be considered as per the policy within two weeks today positively.

Posted on 18.05.2022.

Till the next date of hearing, interim order to continue."

In compliance of the abovementioned orders of the Hon'ble High Court, the representations dated 20.08.2020 of the petitioners were examined & it was found that the petitioner no. 1 was compulsory participant of in the online transfer drive, 2020. He opted for 59 stations according to his suitability & choice and obtained merit score of 34.3178 points, as per

transfer policy. Thus, petitioner No. 1 was allocated his 59th preferred station as per his merit points. Whereas, the petitioner no. 2 voluntarily participated in the online transfer drive, 2020 and opted for 117 stations and obtained merit score of 40.9342 points, as per transfer policy and his 117th preferred station was allocated to one namely, NARESH KUMAR, (049933) who obtained 47.5151 scores. That's why the petitioner no. 2 was transferred in '**Anywhere in the State**' category due to non-availability of preferred stations as the same were allotted to the employees higher in merit and the same has been done in a fair & transparent manner in strict compliance of the Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Whereas, the Government of Haryana framed Online Transfer Policy of Ministerial Staff dated 06.03.2020, thereupon, transfers were made under this policy to ensure equitable distribution of Ministerial Cadre Employees of the Department across the State in a fair & transparent manner and to maximize job satisfaction amongst the employees. Under this policy all the government schools/ institutes have been categorized into seven zones for the purpose of transfer of clerks and every participant is eligible to opt for any number of schools/ institutes across the zones available to him/her. He/She is free to give preferences in order of his/her suitability, so that chances of being posted in '**Anywhere in the State**' category may be decreased. Further, according to the Para No. 4 sub clause V (b) of the Transfer Policy of Ministerial Staff 2020, the department is at liberty to post an employee anywhere in the State if he/she fails to get one of his/her preferred options. Thus the petitioners got the stations as per the online transfer policy of Ministerial Staff 2020.

Whereas the stations were blocked by following the process of rationalization. It is worthwhile to mention here that according to the sub

clause-iv of Clause-4 of online transfer policy of Ministerial Staff 2020, the department can block actual vacant post for the purpose of rationalization. Sub clause-iv of Clause-4 online transfer policy of Ministerial Staff 2020 is as under:-

iv) Rationalization and Blocking of posts: To avoid disproportionate concentration of employees at a particular station, the department should rationalize their sanctioned posts and also block actual vacant post to be kept vacant in the transfer drive. In the long run, however, the department may increase/decrease the total number of sanctioned posts as per the assessment/requirement in consultation with work Assessment Cell in the Administrative Reforms Department and Finance Department.

The posts with less workload were blocked by the department, because stations with over workload require more employees for smooth working in the department. So, for maximum utilization of the potential of an employee at over workloaded station and to avoid misappropriate concentration of employees at a particular station, the blocking of posts was done by the process of rationalization in the public interest.

Further the department blocked the Middle Schools, where the posts of clerks were lying vacant due to less strength of the students i.e. less than 125 students, but where the strength of the students is more than 125, the transfer of clerks has been done as per the online transfer policy. Whereas some newly appointed clerks joined the Department after the Online Transfer Drive, 2020. Therefore, these new incumbents were given temporary stations in those schools where students count is less than 125 but up to 55. The schools in which the students strength is less than 55 were blocked due to less

work load in those schools & shortage of clerks with the Department. It is worth to mention here that the clerical work in these schools in which student strength is less than 55 has been taken from the Clerks of field offices like Block Education Officer and District Education Officer or from a nearby situated school. Thus for even distribution of clerks in the State the process of rationalization was done as per mandate of Clause 4 (iv) of Online Transfer Policy of Ministerial Staff dated 06.03.2020.

Whereas it is germane to mention here that the blocked seats were opened only for the purpose of temporary posting of the clerks who later on joined the department after the present transfer drive by following the proper criteria and hence lowered the strength of students from 125 to 55 only for the purpose of temporary posting. It is pertinent to mention here that these new appointees will also have to compete with the other clerks in the next transfer drive whenever the same will be conducted by the department.

Whereas as per the provisions of the policy, allotment of a vacant seat/station to an employee is based on total composite score earned by the employee concerned out of total 80 score points. The employee concerned earning highest score is entitled to be transferred against a particular vacancy. For merit points, age is prime factor for deciding the claim of the employee against a vacancy, as it has weightage of maximum of 60 points out of total 80 points. However, it is worthwhile to mention here that the categories like women, widows, widowers, differently-abled persons, employees with serious ailments, a privilege of maximum 20 points can be availed by the employees. Therefore, the employees were asked to opt for maximum stations as per their choice suitable to them so that their chances of getting posted to an un-opted station in 'anywhere in the state category' may be reduced. In other words, if a employee could not be transferred against any of the stations preferred by

him/her, he/she shall be transferred under 'Anywhere in the State' category. In case, an employee is to be transferred to an un-opted station in "Anywhere in state" category then Computer Programme/Software, instead of sending them at a distant place, searches for a vacancy nearest to them and put them at that vacancy as per their merit points.

Whereas, according to general principles of the policy, every employee is responsible for the accuracy and regular updation of data in MIS in respect of his/her credentials, otherwise the department is at liberty to transfer him/her, in anywhere category in the state. Employees are liable to be transferred under this policy in any zone or anywhere in the State, in public interest, on completion of prescribed tenure.

In view of the circumstances mentioned above, I have come to the conclusion that petitioners have been transferred by the Department in strict compliance to the transfer policy dated 06.03.2020. Therefore, the claim of the petitioners is hereby rejected, being devoid of merits.

I order accordingly.



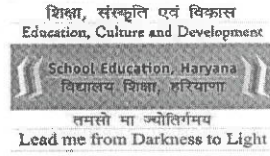
