Whereas, a complaint was filed by the staff of Govt. Model Sanskriti Sr. Sec. School, Tauru [866] (Nuh) on dated 19.06.2021 against Smt. Sabina Sehrawat [5000406], Guest PGT Hindi, Govt. Model Sanskriti Sr. Sec. School, Taoru [866] (Nuh) and her husband Sh. Ajit Singh working as Principal in the same school alleging therein grave misconduct and harassment of school staff by both of them. Smt. Sabina Sehrawat being wife of Sh. Ajit Singh, Principal (Suspended) harassed the school staff. In this regard, some other complaints were also received on 23.07.2021 against both of them. The allegations in the said complaint are reproduced herein below:-

1. विद्यालय के प्रधानाचार्य जी विद्यालय समय के बाद प्रतिदिन मितिग लेकर बिना कारण बैठाए रखते हैं व प्राध्यापकों का अपमान करते हैं।
2. मितिग में अपशब्दों का प्रयोग करते हुए स्टॉफ को निकम्मा, कामचोर तथा अभद्र शब्दों से संबोधित करते हैं और यहां से तबादला करवा कर चले जाने को कहते हैं।
3. प्रधानाचार्य हमेशा अशोभनीय व्यवहार करते हुए अभद्र भाषा का प्रयोग कर गाली गलौच करते हैं, जिसे हम लिखने में भी शर्म आ रही है।
4. महिला प्राध्यापिकाओं को बदतमीज, घटिया और गंदी औरत व जाति सूचक शब्दों से संबोधित करते हैं। प्रधानाचार्य द्वारा पूछे गए सवालों का जवाब देने पर हमें चुप रहने को कहते हैं व कहते हैं कि मेरे साथ बहत मत करो और हमें अपनी बात रखने नहीं देते।
5. प्रधानाचार्य बार-बार झूठी FIR दर्ज कराने की धमकी देते हैं। वहीं वेतन रोकने, वेतन काटने, रिलीव करने, ACR और सर्विस बुक, Probation Period खराब करने की धमकी देते हैं और कुछ अध्यापकों का वेतन काट भी चुके हैं।
6. प्रधानाचार्य आकस्मिक अवकाश का प्रार्थना पत्र देने पर भी हाजरी रजिस्टर में No Information भर देते हैं।
7. वह पूर्व प्रधानाचार्य के विरुद्ध झूठा ग्वाह बनने पर भी दबाव डालते हैं।
8. DSE व Director की भी धमकी देते हुए कहते हैं कि नौकरी से निकलवा कर घर बैठा दूंगा। मेरी सब अधिकारियों व पुलिस से जान पहचान है, मेरा कोई कुछ नहीं बिगाड़ सकता।
9. महिला स्टॉफ से तू क्या प्रधानमंत्री लग रही है जैसी भाषा का प्रयोग करते हुए कार्यालय से बाहर निकल जाने को कहते हैं। वहीं एक महिला प्राध्यापिका को मेटरनिटी लीव के दौरान बहुत अधिक परेशान भी किया गया और बार-बार वेतन रिकवरी की धमकी भी देते हैं।
10. प्रधानाचार्य की धर्म पत्नी श्रीमती सबीना सहरावत इसी विद्यालय में बतौर हिन्दी गैस्ट प्रवक्ता कार्यरत हैं, जो हमेशा पुरुष अध्यापकों को महिला एक्ट लगाकर झूठे केस में फंसाने की धमकी देती हैं और वह पूर्व में भी एक प्रिंसीपल पर ऐसा आरोप लगा चुकी हैं। जिस कारण ज्यादातर पुरुष अध्यापका श्रीमती सबीना सहरावत से डरते हैं और चुप रहते हैं। वह प्राध्यापिकाओं से भी गाली-गलौच करती हैं और अपने पति से नौकरी से निकलवाने की धमकी देती हैं। वहीं वह सभी महिला प्राध्यापिकाओं के चरित्र पर भी लांछन लगाती हैं और DEO Office में DEO की अनुपस्थिति में जब BEO Tauru (18.06.2021) दोनों पक्षों को समझा रहे थे तब उन्होंने प्राध्यापिकाओं के बच्चों के बारे में बुरा कहते हुए बच्चों की अर्थी उठाने की बात कही।
11. वहीं प्रधानाचार्य के व्यवहार के प्रति शहरवासियों ने एसडीएम को शिकायत भी दी हुई है। जिससे उनका व्यवहार जगजाहिर है। प्रधानाचार्य अजीत सिंह व सबीना सहरावत स्थानीय निवासी होने का भी दबदबा दिखाते हैं।

Whereas, Sub Divisional Magistrate, Nuh with regard to complaint received by him on dated 19.06.2021, a fact finding inquiry has been conducted in lieu of the allegations raised in the aforesaid complaint and

submitted his report vide dated 20.07.2021 with the following recommendations:-


That after through perusal/examination of all the documents/evidence/statements on the file and after investigation, I have reached to the conclusion that all the staff of GMSSSS Taoru [866], Nuh harassed by Smt. Sabina Sehrawat, Guest Teacher and her husband Sh. Ajit Singh, Principal without any reason. Therefore, the male and female teachers are in grievances against the both husband and wife. Earlier also, the complaint made by Sh. Dharambir, JBT, GPM Panchgaon against Sh. Ajit Singh, Principal and F.I.R. lodged by Dr. Rinku Sharma, Primary Health Center, Taoru against Sh. Ajit Singh, Principal who is husband of Mrs. Sabina Sehrawat evidently proved that Sh. Ajit Singh's character and behavior was not good with the staff. Therefore, the Local residents of Taoru and eminent persons are in rage against Sh. Ajit Singh, Principal. Therefore, the Deputy Commissioner is requested that in view of above facts it seems appropriate that the Director, Secondary Education, Haryana, Panchkula may be requested to transfer Smt. Sabina Sehrawat, Guest Teacher (from GMSSSS Taoru [866], Nuh) and her husband Sh. Ajit Singh, Principal to any other school against vacant post.

Keeping in view of the above said facts and circumstances, report of Sub Divisional Magistrate, Nuh, rules in force and documents on records, it is observed that Smt. Sabina Sehrawat, is a Guest teacher working in the said school. The allegations to which she has found guilty of are quite serious in nature considering the duties to discharge by her. A teacher with such a conduct is not good for the Educational Institution as the teacher should always be role model for the society. Any teacher involved in such kind of practices should not be allowed to continue in service. Further, as per the Haryana Guest Teacher Service Act, 2019 (as amended) also provides the provision regarding termination of service of Guest Teacher in case of his/her omission or commission. The same is reproduced herein below:-

"6. (1) A guest teacher may be removed from the service by the Appropriate Authority if he is proved guilty of an act of omission or commission which, if had been committed by a regular employee of the Government, would have made him liable for initiation of disciplinary proceedings for major penalty. (2) A guest teacher so removed may make an appeal against the above decision before the Appellate Authority whose decision shall be final."

Considering the seriousness of present matter, the service of Smt. Sabina Sehrawat [5000406], Guest PGT Hindi is liable to be terminated due to her act of omission or commission enumerated above. Therefore, the service of Smt. Sabina Sehrawat [5000406], Guest PGT Hindi is hereby dispensed with immediate effect.

It is, ordered accordingly.
