Shri Gulab Singh [023310], Principal (now retired) is hereby informed that it is proposed by the Governor of Haryana to take action against him under Rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016 read with Rule 12.2(b) of Haryana Civil Services (Pension) Rules, 2016, on the grounds set out in the enclosed statement of charges. The charges are based on the statement of allegations appended thereto.

- 2 Shri Gulab Singh is hereby required to state in writing within a period of 15 days from the receipt of this memorandum by him whether he admits the truth of all, or any, of the charges, what explanation or defence, if any, he has to offer and whether he desires to be heard in person.
- 3 Shri Gulab Singh is hereby further informed that if for the purpose of preparing his written statement, he wishes to have an access to the relevant official records, he should inspect the same in the office of the Director, General Secondary Education, Haryana, Panchkula on any working day after making prior appointment with him. It is, however, pointed out that only such documents will be shown to him as are in the possession of the Director General Secondary Education, Haryana, Panchkula, and as are strictly relevant to the case. If in the opinion of the Government, it is not desirable in the public interest, to allow him access to any document, such access shall be refused. If, Shri Gulab Singh, wishes to consult any other relevant record, which is not in the custody of the Director, General Secondary Education, Haryana, Panchkula, it is for him to undertake its inspection. It is, however, made clear to Shri Gulab Singh that his failure to inspect the documents shall not constitute a valid ground for delay in the submission of his written statement and if the written statement is not received by the undersigned within the specified period, it shall be presumed that he has none to submit.
- 4 The written statement should be submitted direct to the undersigned.



Statement of charges against Shri Gulab Singh [023310] the then Principal, Government Model Sanskriti Senior Secondary School, Taorori [1807], Karnal [now retired]

While being posted as Principal from 27.04.2018 to 28.02.2021 Shri Gulab Singh committed following acts of omission and commission for which he is charged as under :-



That Shri Vinod Parkash Verma Kumar son of Shri Ram Parshad resident of House No. 49/18, Near Kalpana Chawla Hospital, Karnal made complaint vide No. CMOFF/N/2021/032723 dated 08.04.2021 on the Chief Minister Grievances Redresss and Monitoring System Haryana wherein allegations of financial embezzlement were leveled against him i.e. Shri Gulab Singh the then principal. In this context, the District Education Officer, Karnal was already directed by the Director General Secondary Education, Haryana, Panchkula vide letter no. 5/211-2020 HRG-I(1) dated 09.02.2021 to enquire the complaint dated 20.01.2021 made by the complainant and the District Education Officer, Karnal constituted the committee under the chairmanship of Sub Divisional Engineer, Sarv Shiksha Abhiyan, Karnal and Section Officer office of the District Education Officer, Karnal and Junior Engineer, Sarv Shiksha Abhiyan Nilokheri, Karnal were members. Thereafter, the District Education Officer, Karnal submitted enquiry report dated 04.08.2021 and 02.11.2021 wherein the following irregularities were found to be committed on his part i.e. Shri Gulab Singh:-

1. That an amount of Rs. 3,52,000/- was released for construction of boundary wall of Government Model Sanskriti Senior Secondary School, Taorori, Karnal and the enquiry committee assessed the construction work of rupees 1,88,527/- on the said site. In this way, there is a difference of Rs. 1,63,473/- assessed by the committee and he i.e. Shri Gulab Singh being the principal embezzled this amount.
2. That an amount of Rs. 14,40,000/- was released vide letter no. 18/32-2019 Works(1) dated 05.08.2019, for construction of boundary wall of Government Primary School, R.C., Taorori, Karnal and the enquiry committee assessed the construction work of rupees 9,00,050/- on the site. In this way, there is difference of Rs 5,39,950/- assessed by the committee on the said work and he i.e. Shri Gulab Singh being principal of the school embezzled this amount. Further, he i.e. Shri Gulab Singh failed to submit the utilization certificate duly countersigned by District Education Officer, Karnal.
3. That an amount of Rs 18,50,000/- was released vide letter no. 2/21-2018 W(1) dated 04.12.2018 for construction of boundary wall, four rooms and staircase of Government Model Sanskriti Senior Secondary School, Taorori, Karnal and the enquiry committee assessed the construction work of Rs 14,02,017/- on the said site. In this way, there is difference of Rs 4,47,983/- assessed by the Committee and he i.e. Shri Gulab Singh embezzled this amount. Further, he i.e. Shri Gulab

Singh failed to submit the utilization certificate duly countersigned by the District Education Officer, Karnal.

In this way, he i.e. Shri Gulab Singh (Retired) committed an act *unbecoming of a Government officer* by performing his duty with malafide intentions in negligent and irresponsible manner and violated the provisions of rule 4(1) and (2) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016 and caused a total loss of Rs 11,51,406/- to the Government State Exchequer.

The lapses detailed above constitute grave misconduct on the part of Shri Gulab Singh [023310] the then Principal, Government Model Sanskriti Senior Secondary School, Taorori [1807], Karnal [now retired], rendering him liable for strict disciplinary action under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 2016 read with rule 12.2(b) of the Haryana Civil Services (Pension) Rules, 2016.



While being posted as Principal from 27.04.2018 to 28.02.2021 Shri Gulab Singh committed certain acts of omission and commission :-

That Shri Vinod Parkash Verma Kumar son of Shri Ram Parshad resident of House No. 49/18, Near Kalpana Chawla Hospital, Karnal made complaint vide No. CMOFF/N/2021/032723 dated 08.04.2021 on the Chief Minister Grievances Redress and Monitoring System Haryana wherein allegations of financial embezzlement were leveled against him i.e. Shri Gulab Singh the then principal. In this context, the District Education Officer, Karnal was already directed by the Director General Secondary Education, Haryana, Panchkula vide letter no. 5/211-2020 HRG-I(1) dated 09.02.2021 to enquire the complaint dated 20.01.2021 made by the complainant and the District Education Officer, Karnal constituted the committee under the chairmanship of Sub Divisional Engineer, Sarv Shiksha Abhiyan, Karnal and Section Officer office of the District Education Officer, Karnal and Junior Engineer, Sarv Shiksha Abhiyan Nilokheri, Karnal were members. Thereafter, the District Education Officer, Karnal submitted enquiry report dated 04.08.2021 and 02.11.2021 wherein the following irregularities were found to be committed on his part i.e. Shri Gulab Singh:-

That an amount of Rs. 3,52,000/- was released for construction of boundary wall of Government Model Sanskriti Senior Secondary School, Taorori, Karnal and the enquiry committee assessed the construction work of rupees 1,88,527/- on the said site. In this way, there is a difference of Rs. 1,63,473/- assessed by the committee and he i.e. Shri Gulab Singh being the principal embezzled this amount.
2. That an amount of Rs. 14,40,000/- was released vide letter no. 18/32-2019 Works(1) dated 05.08.2019, for construction of boundary wall of Government Primary School, R.C., Taorori, Karnal and the enquiry committee assessed the construction work of rupees 9,00,050/- on the site. In this way, there is difference of Rs 5,39,950/- assessed by the committee on the said work and he i.e. Shri Gulab Singh being principal of the school embezzled this amount. Further, he i.e. Shri Gulab Singh failed to submit the utilization certificate duly countersigned by District Education Officer, Karnal.
3. That an amount of Rs 18,50,000/- was released vide letter no. 2/21-2018 W(1) dated 04.12.2018 for construction of boundary wall, four rooms and staircase of Government Model Sanskriti Senior Secondary School, Taorori, Karnal and the enquiry committee assessed the construction work of Rs 14,02,017/- on the said site. In this way, there is difference of Rs 4,47,983/- assessed by the Committee and he i.e. Shri Gulab Singh embezzled this amount. Further, he i.e. Shri Gulab Singh failed to submit the utilization certificate duly countersigned by the District Education Officer, Karnal.

In this way, he i.e. Shri Gulab Singh (Retired) committed an act unbecoming of a Government officer by performing his duty with malafide intentions in negligent and irresponsible manner and violated the provisions of rule 4(1) and (2) of the *Haryana Civil Services (Government Employees Conduct) Rules, 2016* and caused a total loss of Rs 11,51,406/- to the Government State Exchequer.





