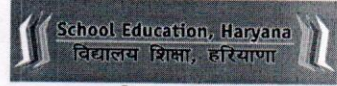



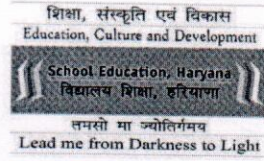

Terms and Conditions:-

- i) Their appointment is purely to the temporary posts which are liable to be abolished at any time and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to him at the present stage and in this respect he will have to take his chance like others who have been similarly recruited. Consequently his service may be terminated without notice.
- ii) If at any stage he desire(s) to resign his post he will be required to give three month's clear notice or forfeit in lieu therefore his salary including allowancs for

one month or the period by which the notice falls short of the month. Such a notice will be given to him by the Directorate also in case it is proposed to terminate his services for the reasons other than that mentioned in clause above. If any candidate has not been vaccinated within last twelve months, he should have it done before reporting himself for duty.

- iii) He will be required to take the prescribed oath of allegiance to the Constitution of India.
- iv) You will be on probation for a period of two years, which may further be extended for a period of one year. In case their work or conduct is not found satisfactory during the period of probation, their services are liable to be terminated with or without assigning any reason.
- v) In case he is married, he will produce the certificate to his Head of the office that he is not having more than one living spouse.
- vi) In case he is unmarried, he will have to furnish a declaration to the effect that he will not have more than one living wife.
- vii) He will not undertake higher studies of any kind without obtaining prior permission of the competent authority. Consequently no leave of any kind will be granted for the pursuing of higher studies.
- viii) He will be governed by the Haryana Education Department, National Cadet Corps Cadre (Group-C) Service Rules, 1991 and all other rule & regulations and executive instructions issued or to be issued by the State Govt. from time to time.
- ix) He will not be permitted to apply for the post of outside the Department before completing five years' service.
- x) He will be required to produce the original educational, date of birth certificate and driving license to the concerned District Education Officer.
- xi) He should furnish a medical fitness certificate(s) from the Chief Medical Officer concerned as required under Rule 3.1 of the Punjab C.S.R. Vol.I, Part-I before reporting himself for duty.
- xii) No TA/DA will be paid to him for joining this post.
- xiii) He will drive all the Govt. vehicles, as per requirement and will procure/get renewed the licences regularly.
- xiv) The appointment is subject to verification of their character and antecedents.
- xv) The "New Pension Scheme" as per F.D. Notification dated 28.10.2005 will cover them.

Whereas, Sh. Rajender Prasad Retired Principal filed CWP No. 6221 of 2021 in the Hon'ble High Court praying therein for directing the Respondents to grant State Teacher Award, 2018 to him and two years consequential extension in service to the petitioner as he alleges himself to be fully eligible for grant of State Award. In the interest of justice an opportunity was rendered to the petitioner as directed by the Hon'ble Court vide its order dated 08.03.2022. The operative part of the said order dated 08.03.2022 is as under:-

"Learned counsel for the petitioner submits that the impugned order has been passed without giving any opportunity of hearing to the petitioner. If that be so, the said order cannot be sustained in the eyes of law. Let the respondents inform this Court by 10.03.2022 whether the impugned order has been passed after giving due opportunity of hearing to the petitioner or not. In case, no opportunity was given, the respondents will be at liberty to withdraw the impugned order and pass a fresh order after complying with the rules of natural justice. Adjourned to 10.03.2022".

This writ petition was disposed of by the Hon'ble High Court vide order dated 10.03.2022, the operative part of which is as under:-

".....Keeping in view the facts and circumstances of this case, once the respondents have decided to grant an opportunity of hearing to the petitioner on 16.03.2022 coupled with the fact that nothing has been placed on record that the impugned order dated 19.02.2021 (Annexure P-7)

was passed after observing the rules of natural justice, the impugned order 19.02.2021 (Annexure P-7) is hereby set-aside. It is made clear that setting-aside of the impugned order will not debar the respondents to pass a fresh order in pursuance to the hearing of the petitioner, which has been fixed for 16.03.2022. This Court is not 2 of 3 opining upon the merits of the case with regard to the entitlement of the petitioner to retain the said amount or not, which will be decided by the respondents keeping in view the explanation, which the petitioner will submit before the authorities on the hearing i.e. 16.03.2022. The present petition is disposed of in above terms.”

Whereas, as per the orders dated 08.03.2022 of the Hon'ble High Court an opportunity of hearing was required to be given to the petitioner by the competent authority and then pass a well reasoned Speaking Orders.

Therefore, in the compliance of the orders dated 08.03.2022 the undersigned gave a personal hearing to the petitioner on 16.03.2022 to represent his case on merits along with requisite documents in support of his assertion. After scrutinizing the State Teacher Award documents and post giving him a reasonable hearing the undersigned is of considerate view that:


- Sh. Rajender Prasad had concealed the fact that a Criminal Charge Sheet is pending against him with mala fide intent to undeservingly claim the State Teacher Award 2018. Usually a condition to this effect i.e clarifying such charge sheeted officials not to apply for the award is duly circulated through a letter seeking such applications from eligible employees. However the letter issued informing the eligible applicants to

apply did not have this condition and appears to have been missed inadvertently.

- It is however quite clearly stated in the policy of the department that the scheme of State Awards envisages only those teachers who showed quality of teaching and professional competence, good conduct and team spirit. These awards are aimed at raising the prestige of such teachers who through their hardwork & consistent performance have fared well on certain parameters of the Department.
- The said charge sheet is still pending against him before W/ACSSE, Chandigarh. The petitioner had retired on 31.01.2021 as he was not rewarded with the extension of two years by the department which as per record appears to be fair, just and rational as per the policy.
- Furthermore, the petitioner was awarded the State Teacher Award along with Cash Amount of Rs. 21000/- , a Medal, shawl and two increments. The decision of withdrawing the State Award has rightfully been taken and before withdrawing the said award a clarification was also sought from the petitioner which was not found satisfactory.

Thus based on the facts as aforementioned the claim of the petitioner is summarily rejected & he is not found eligible for the State Teacher Award, 2018.

I Order accordingly.

1. Their appointment is subject to the condition that concerned District Education Officers may ensure the Character Certificate and all other documents regarding date of birth and all educational documents.
 2. They are also directed to participate in next online transfer drive for taking permanent Station.

TERMS & CONDITIONS:-

1. Their appointment is against a purely temporary post which is liable to be abolished at anytime and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to them at present. Their services can be terminated without any notice, whenever there is no vacancy against which they can be retained.
2. If at any stage they desire to resign their posts they will be required to give one month's notice or forfeit in lieu thereof, their salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given to them by the Directorate Secondary Education,

Haryana, Panchkula in case it is proposed to terminate their services for the reason other than that mentioned in clause (I) above.

3. They will be required to take the prescribed oath of allegiance to the constitution of India.

6. The candidate shall have to qualify the State Eligibility Test in Computer Appreciation and applications (SETC) within the probation period of two years, extendable by one year in case of direct recruitment. The candidate appointed against the aforesaid categories of posts in the group ‘C’ shall not be entitled to earn any increment in his pay scale till he/she qualifies the said test failing which the services of such employees shall be dispensed with.
7. They will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the pursuing of higher studies.
8. They will be required to produce the original Educational documents and date of birth certificate before joining their duties of the said post.
9. They shall have to furnish fitness certificate from the Chief Medical Officer as required under Rule 9 of Haryana CSR (General), 2016 before joining their duties.
10. No TA/DA and joining time will be paid to them for joining this post.
11. They will remain on probation for a period of two years, from the date of their joining in the department. The period of probation can be extended in accordance with the existing rule on the subject. For assessing their performance during the period of probation, their work conduct will be taken into consideration. If their work and conduct during this period is not found satisfactory their services will be terminated without any notice.
12. Their appointment is subject to have passed 10+2 or its equivalent examination with Hindi or Sanskrit.
13. That in the matters, not specifically mentioned in this Communication, they shall be governed by the Civil Service Rules as applicable to Haryana Government employees and such rules/order /instructions as may be issued by the State Government from time to time. They shall further be governed by the “Haryana Education Department Sub Offices Ministerial (Group-C) Services Rules, 1983” and amended in the year 2013.

14. Their services will be governed under the "NEW DEFINED CONTRIBUTORY PENSION SCHEME" of the Haryana Government as per Finance Department's notification dated 28.10.2005.
15. That if they got appointment on the basis of furnishing false/forged or fraudulent information/facts/documents which are detected later on to be false or forged or fraudulent, they would be liable for termination of their services without any notice besides such criminal action that may be taken as prescribed in the Indian Penal Code or any other Law enforce.


