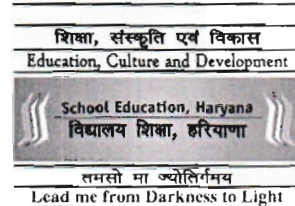

Terms and Conditions:-

- i) Their appointment is purely to the temporary posts which are liable to be abolished at any time and carries no promise of subsequent permanent employment. 

Whereas vide Order No. 04/09-2013 HRG-II(1) dated 10.02.2014, promotions of 860 Elementary School Headmaster(s) were made to the post of Headmaster High School (HES-II) under the Haryana State Education School Cadre (Group B) Service Rules, 2012. The said order was challenged before the Hon'ble Punjab & Haryana High Court Chandigarh by Smt. Anju Kumari Sharma & others by way of filing a **Civil Writ Petition No. 2884 of 2014** for quashing the order qua Classical & Vernacular teachers i.e. Hindi Teacher, Punjabi Teacher & Sanskrit Teacher. The above said writ petition was allowed on 22.12.2015 in clubbed matter of CWP No. 4301 of 2013 Sartaj Singh Dhanda vs State of Haryana and others. The operative part of order is reproduced herein as under:

“In view of the facts as well as law position as discussed above, the present petitions deserve to be allowed and the impugned orders dated 20.02.2013 (in CWP No.4301, 23444, 8184, 8105, 6134 and 10223 of 2013), 28.01.2014 (in CWP No.2884 and 2872 of 2014), 10.02.2014 (in CWP No.10922 and 12949 of 2014) are hereby quashed. A direction is also issued to the official respondents to consider the candidatures of all eligible candidates, who fulfil the requisite qualifications/ experience as per amended Rules of 2012 within a period of three months from the date of receipt of certified copy of this order and pass necessary orders accordingly.”

The petitions are allowed accordingly.”

The order dated 22.12.2015 was challenged in LPA No. 1208 of 2016 - Dalip Singh & others. Vs. State of Haryana & others and order dated 22.12.2015 was stayed. Thereafter, LPA was withdrawn with liberty to file review application.

Keeping in view the order dated 22.12.2015 passed in CWP No. 4301 of 2013 Sartaj Singh Dhanda vs State of Haryana & others, the case was examined and found that you did not possess the required 8 years experience neither as ESHM nor as TGT being Language Teacher on the date of your promotion as High School Headmaster i.e. on 10.02.2014. Accordingly, you were liable to be reverted to your feeder post.

But before issuing the order of reversion, you were, given a show cause notice to explain that why you should not be reverted from the post of High School Headmasters and you were directed to file the reply to the show cause notice within a period of 15 days vide No. 6/35-2016 HRG-II (2) dated 28.08.2020. You submitted your reply accordingly. The same has been examined. As no merit has been found in the reply submitted by you, but in the interest of justice, you were again



given 2nd show cause notice on 06.04.2021. The reply submitted by you has not been found satisfactory and it deserves to be rejected being devoid of merits.

As per position stated above, it is evident that you did not possess the required 8 years experience neither as ESHM nor as TGT being Language Teacher on the date of your promotion as High School Headmaster i.e. on 10.02.2014. As such you did not fulfil the requirement for this post as per provision of Haryana State Education School Cadre (Group B) Service Rules, 2012. Hence, in compliance with the order dated 22.12.2015 passed by Hon'ble Punjab and Haryana High Court in CWP No. 4301 of 2013, you are hereby reverted to the post of Elementary School Headmaster with immediate effect.
