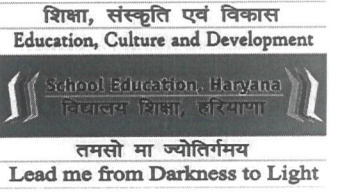

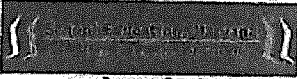

Whereas, Sh. Jai Parkash [007833], the then District Elementary Education Officer, Bhiwani now District Education Officer, Charkhi Dadri was charge-sheeted under rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order no. 5/235-2019 HRG-I (2) dated 18.06.2020 and the following charges were leveled against him:-

“That he i.e. Sh. Jai Parkash approved/ made deputation of 25 (Twenty Five) deputation orders although he i.e. Sh. Jai Parkash was incompetent to pass such orders and he i.e. Sh. Jai Parkash also failed to seek prior approval of the competent authority. Thus, he i.e. Sh. Jai Parkash violated the provisions of Teacher Transfer Policy, 2016 and Chief Secretary, Haryana instructions no. 15/16/2017-1GS-II dated 18.07.2019”

Thereafter, charged officer submitted his reply to the said charge-sheet on dated 15.07.2020 and denied the charges leveled against him. He further contended in his reply that being Head of District Elementary Education, Bhiwani, the internal adjustment of some teachers were made for a very short term basis i.e. on months or two months on the recommendation of the Head of the Institutions, School Management Committee of the schools and concerned Block Education Officer in the interest of students, having bona fide intention and in good faith. The reply of charged officer found un-satisfactory.

Resultantly, Sh. O.P. Langyan, IAS (Retd.) was appointed an inquiry officer vide order dated 19.08.2020. The inquiry officer submitted his report on 16.10.2020 to this Department wherein charges found proved against him. The operative part of the said report is as under:-

“I have gone through the policy of the department which does not empower the DEEO for any deputation, adjustment or transfer in violation of the transfer policy. As per Rule-12 of the policy, power of relaxation, lies with the Chief Minister of Haryana. Rule 12 is reproduced below:-Power of relaxation

Notwithstanding anything contained in the policy, the Administrative Secretary, School Education, Haryana with the prior approval of the Chief Minister, Haryana, shall be competent to transfer any teacher to any place in relaxation of any or all of the above provisions after recording reasons justifying such relaxation”.

The delinquent has given many reasons for making the alleged transfers but have not produced any evidence to prove those circumstances. Therefore, he has clearly violated the provisions of


the above said transfer policy of the department and has exercised the power of Chief Minister with the best reasons known to him. Therefore, the charges leveled against the delinquent are proved.

Thereafter, findings of the inquiry officer dated 16.10.2020 were conveyed to charged officer to make his representation within 30 days. The charged officer submitted his representation dated 07.12.2020 wherein he contended that inquiry officer not considered his version properly. Consequently, the charged officer was accorded with the personal hearing on dated 10.01.2022. During the course of hearing, the charged officer pleaded that internal adjustment of some teachers was made for a very short term basis on the request/recommendation of some of the Head of the Institutions, School Management Committee of the schools or concerned Block Education Officer in the interest of students. Further, the charged officer admitted his mistake and assured that he will remain more careful and diligent towards his duty in future.

Keeping in view the above said facts and circumstances, reply of the charged officer, finding of inquiry officer and documents on record it is found that the charged officer violated the instruction of higher authority by making deputation despite the fact that he was not competent to do the same. However, the said deputations/short term adjustments were made on the request of schools and Block Education Offices and the information regarding the same intimated to the higher authority. Further, no prejudice or economical loss has been caused to the state exchequer due to this act of omission of charged officer.

Therefore, taking a lenient view, the present charge sheet is converted into Rule 8 and punishment of 'Censure' is hereby inflicted upon Sh. Jai Parkash [007833], the then District Elementary Education Officer, Bhiwani now District Education Officer, Charkhi Dadri.

It is ordered accordingly.

Whereas, Shri Man Singh [051053] the then Principal, Government Senior Secondary School, Akbarpur [now Principal, Government Girls Senior Secondary School, Gaod [3872], Mahendergarh] was charge sheet under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 on 07.05.2021/24.05.2021 and the following allegations were leveled against him:-

“That the District Elementary Education Officer, Narnaul intimated on 03.03.2020 that he i.e. Shri Maan Singh made appointment of part time official i.e. Shri Anil Kumar S/o Shri Rajesh Kumar, Part Time Sweeper in violation of the Chief Secretary, Haryana instruction no. 6/50-2007-1 GS dated 03.08.2021 and as such his explanation i.e. Shri Maan Singh was called by the office of the Director Secondary Education, Haryana, Panchkula vide letter dated 25.08.2020 which was replied by him on 03.09.2020. On examination of the said reply, the following irregularity was found to be committed on his part i.e. Shri Maan Singh:-

That the Chief Secretary, Haryana issued instruction no. 6/50/2007-1GS 1 dated 03.08.2011 and ban on appointment of part time officials was imposed but he i.e. Shri Maan Singh appointed Shri Anil Kumar S/o Shri Rajesh Kumar, Part Time Sweeper vide order no. Spl/2/2013 dated 01.03.2013 at Government Senior Secondary School, Akbarpur, District Mahendergarh without getting the approval of the competent authority”.


The charged officer submitted his reply to the said charge sheet vide dated 10.06.2021 and denied the allegations leveled against him. The reply of the delinquent was found un-satisfactory. Resultantly, Shri R.P. Bhasin, DSJ (Retd) was appointed as inquiry officer vide order dated 14.07.2021/22.07.2021 to conduct regular departmental inquiry. The inquiry officer submitted his inquiry report vide dated 10.09.2021 wherein charges leveled against him were found proved. The findings of inquiry officer was conveyed to charged officer vide dated 17.10.2021/22.10.2021 to make his representation on it. The charged officer made his representation vide dated 15.11.2021 and denied the findings of the inquiry officer. Thereafter, the delinquent an opportunity of personal hearing on 28.12.2021 has been accorded to the charged officer and during the course of hearing, the charged officer admitted that he appointed the part time sweeper but the said appointment was done by him in good faith and on request of the villagers and in the interest of students. Further, the charged officer admits his mistake and tendered his unconditional apology and assured that he will remain more careful and diligent towards his duty in future.

Keeping in view the above facts and circumstances, finding of inquiry officer and documents on record, it is found that the charged officer made the said appointment of part time sweeper in contravention of the CS instructions dated 03.08.2011 but the same occurred due to the communication

gap between him and the then District Education Officer, Mahendergarh but it was administrative lapse on his part. However, no economic loss or prejudice has been caused to the state exchequer due to his act of omission.

Therefore, taking lenient view, the present charge sheet is converted into rule-8 and a minor punishment of "Censure" is hereby inflicted upon Shri Man Singh [051053] the then Principal, Government Senior Secondary School, Akbarpur, Mahendergarh now Principal, Government Girls Senior Secondary School, Gaod [3872], Mahendergarh.

It is ordered accordingly.
