NO. 5/199-2019 HRG-I(2)

Dated, Chandigarh, the 21-04-2022

Whereas, Sh. Satish Kumar [065918] the then District Elementary Education Officer, Sonapat (retired on 30.11.2019 under suspension) was charge-sheeted under rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 read with rule 12 (2) (b) of the Haryana Civil Services (Pension) Rules, 2016, vide order no. 5/199-2019 HRG-I (2) dated 16.07.2020 and the following allegations were leveled against him:-

"That he i.e. Shri Satish Kumar was present on 15.10.2019 before Hon'ble High Court in CM No. 17145-C II of 2019 in COCP No. 917 of 2013 and gave misleading statement i.e. "Education Department has done the needful on their behalf and now the matter is pending with the Finance Department" in a very callous manner without examining the record the order dated 22.09.2011 passed by the Hon'ble High Court in CWP No. 5919 of 1990 was not completely complied with by him i.e. Sh. Satish Kumar as the benefits of 6% interest along with arrears, was not extended to the petitioners i.e. Sh. Rattan Singh, Sh. Jai Pal and Sh. Yash Pal Kundu. Thus, he i.e. Sh. Satish Kumar failed to comply with said order dated 22.09.2011 passed by Hon'ble High Court completely and gave a misleading statement due to Hon'ble High Court ordered on 15.10.2019 that let the Chief Secretary, Haryana be remained present on next date of hearing i.e. 11.11.2019"

Thereafter, the charged officer submitted his reply to the said charge sheet on dated 14.08.2020 and denied all the allegations leveled against him. He submitted in his reply that on date of hearing before Hon'ble High Court i.e. 15.10.2019, he only met with Senior Deputy Advocate General Sh. Sandeep Maan and verbally told him that he had written to the Directorate for approval of interest amount in favor of the petitioner and after getting sanction from the Directorate, interest amount would be released as soon as possible to the petitioners. He further stated that he has made no such statement before the Hon'ble High Court as mentioned in the said court order dated 15.10.2019. The reply of charged officer found unsatisfactory. Resultantly, Sh. R.P. Bhasin, District & Session Judge (Retd) appointed as inquiry officer vide order dated 24.11.2020 to conduct regular departmental inquiry. The inquiry officer submitted his report vide dated 20.01.2021 wherein charges found proved against charged officer. The operative part of the findings/report is as under:-


"Evaluating the evidence as noticed in the earlier part of this report, the only logical conclusions which can be drawn by legal/judicial standards are that the prosecution has been able to prove the charges as highlighted in the earlier part of this report by acceptable legal evidence and accordingly while accepting the evidence of the prosecution and rejecting the evidence of the delinquent, I return firm findings in favour of prosecution and

against the delinquent by concluding that the charges stood proved against the delinquent and I hold accordingly”

Keeping in view the above said facts & circumstances, findings of inquiry officer, reply of the charged officer and documents on record, it is found that the charged officer never made such statement before Hon'ble High Court but he had only communication with Advocate General office on 15.10.2019. The same occurred due to the communication gap between him and the Advocate General office. The charged officer admitted his mistake and assured that he will remain more careful and diligent towards his duty in future. Further, no economic loss or prejudice caused to the state exchequer due to his act of omission.

Therefore, taking lenient view, the present charge sheet is converted into rule-8 and punishment of “*Censure*” is hereby inflicted upon Sh. Satish Kumar [065918] the then District Elementary Education Officer, Sonapat (Rtd.)

It is ordered accordingly.

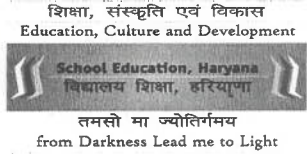

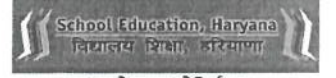



Whereas, Sh. Santosh Kumar, Assistant Office of DEO Bhiwani was charge-sheeted U/R 8 of Haryana Civil Services (Punishment and Appeal) Rules, 2016 vide order No. 13/111-2015 HRME (4) dated 28.01.2015, 5/70-2017 HRME-1 (3) dated 14.06.2017 and 5/70-2017 HRME-1 (3) dated 09.08.2018 with the charges that he omitted to perform his duties in proper manner as he has not perused the Court cases properly in various Courts especially in CWP No. 6043 of 2015 titled as Randhir Singh V/s State of Haryana & CWP No. 8885 of 2017 titled as Kalawati and others V/s State of Haryana and others. Moreover, he did not provide the information sought by Sh. Ved Parkash, Village Paintawas Khurd, Bhiwani under RTI Act, 2005, due to which the department had to face the dire consequences which lead to adverse orders by the courts as well as commission which lowers the dignity of the department.

The delinquent submitted the reply to the chargesheets on 09.08.2018 and 16.10.2018 and denied the charges levelled against him and further prayed to drop the chargesheets issued against him. Thereafter, the delinquent was given an opportunity of personal hearing on 19.07.2021, wherein he reiterated the same facts as were submitted by him in the reply to the charge-sheet. Thereafter, he submitted his additional reply on 21.09.2021

Therefore, after going through the official record of the delinquent, it was found that the employee has been continuously negligent as he has not perused the Court cases properly in various Courts especially in CWP No. 6043 of 2015 titled as Randhir Singh V/s State of Haryana & CWP No. 8885 of 2017 titled as Kalawati and others V/s State of Haryana and others. Moreover, he did not provide the information sought by Sh. Ved Parkash, Village Paintawas Khurd, Bhiwani under RTI Act, 2005 and has not shown any sign of improvement and resultantly, Department had to face the consequences. Thus, Sh. Santosh Kumar, Assistant office of DEO Bhiwani was found guilty under Rule 8 of Haryana Civil Services (Pay Rules, 2016). Therefore, the punishment of stoppage of two increments without cumulative effect is hereby inflicted upon Sh. Santosh Kumar, Assistant O/o DEO Bhiwani.


