



**ORDER NO. 6/21-2021 HRG-I (1)**

**DATED, PANCHKULA 09-05-2022.**

Whereas, Sh. Om Parkash [051061] and Shri Rameshwar [051057], Principals have filed the present writ petition No. 2755 of 2021 with the prayer to grant of promotion w.e.f. from the date their juniors were promoted as Principals and to consider them for promotion as Block Education Officer by placing them above in the seniority of principals.

That the present case came up for the hearing before this Hon'ble Court on 09.02.2021 and passed the following order:

***"The hearing of the case was held through video conferencing on account of restricted functioning of the Courts.***

***The petitioner No.1 and 2 claim to have been appointed as lecturers on 24.10.1991 and 29.10.1991, respectively. In 2012, they were promoted as school Principals. It is claimed that juniors to the writ petitioners were also promoted. On 08.07.2019, the seniority list of lecturers was issued and the petitioners were depicted seniors to their juniors who were also promoted. Even in the seniority list issued for the cadre of Principals, the petitioners were placed seniors to the said juniors. The petitioners through the present writ petition pray that they are entitled to be considered for promotion to the post of Principal with effect from the date their juniors were promoted to the post of Principal. It has also been brought to the notice of the Court that various writ petitions have been filed in this Court for identical relief. Once such writ petition is disposed of, the officials grant them the benefit of antedated promotion. He contends that the petitioners are identically situated.***

***Notice of motion.***

***On the request of this Court, Mr. Samarth Sagar, Additional Advocate General, Haryana, accepts notice and prays for time to file reply.***

***Respondent No.2 is directed to file an affidavit as to why all the identically situated employees are being compelled to file writ petitions.***

***List on 13.05.2021."***

In compliance of the directions of the Hon'ble Punjab & Haryana High Court relevant record of the matter was examined. Shri Kundan Kalra [002823] was placed at seniority no. 1099 of PGTs as stood on 01.04.2005 and was promoted as Principal vide order no 4/30-2007 HRG-I (2) dated 20.07.2007.

The officer shown senior to Shri Kundan Kalra [002823] filed various writ petitions for antedated promotion w.e.f. 20.07.2007 at par Shri Kundan Kalra [002823] who was promoted as principal w.e.f. 20.07.2007. To find out ambiguity, a committee was constituted vide order dated 29.12.2020/ 31.12.2020 to examine and to fix the seniority of Sh. Kundan Kalra, as PGT which consists of the following members:-

1. Smt. Sunita Rani, Joint Director
2. Sh. Ramesh Duhan, CAO
3. Smt. Vandhan Gupta, Deputy Director
4. Smt. Indra Beniwal, Deputy Director
5. Sh. Salim Hooda, Assistant District Attorney

The committee submitted its report wherein date of appointment for fixation of seniority of Sh. Kundan kalra has been suggested as 25.10.1991 instead of 15.10.1991. Accordingly, the department passed the order no.15/64-2020 PGT-I(1) dated 27.07.2021/03.08.2021 and the seniority of Shri Kundan Kalra [002823] was re-fixed at Sr. No. 1701 A instead of 1533 as stood on 01.04.1998 and 1269 A instead of 1099 as stood on 01.04.2005. Consequently, Shri Kundan Kalra [002823] has now placed in seniority between Sh. Sunil Kundu and Smt. Sudesh Kumari, therefore, his promotion date is to be rectified.

Keeping in view the above stated facts, you are hereby given show cause notice to explain your position that as to why your promotion orders should not be modified and your promotion be treated as such w.e.f 21.04.2012 and pay & pension be fixed accordingly. In this regard, reply/ representation, if any, be submitted within a period of 15 days from the date of receipt of this notice. In case of failure to submit the same within stipulated period, it would be presumed that you have nothing to say in this regard and consequently, the action will be taken against you for modification of your promotion orders and granted promotion be treated as such from 21.04.2012.

Whereas, Smt. Krishna Kumari Yadav filed CWP No. 1140 of 2021 titled as Krishna Kumari Yadav Vs. State of Haryana & Others before the Hon'ble Punjab & Haryana High Court under Article 226/227 of the Constitution of India with the prayer for issuance of writ, order or direction especially in the nature of mandamus directing the respondents to consider the candidature of the petitioner who has not been called for the joining on the post of PGT Sanskrit despite the fact that she has already been selected on the aforesaid post against Advt. no. 1/2012 dated 06.06.2012 (Annexure P-1) and the verification process has already been completed on 04.09.2020.

The above mentioned writ petition came up for adjudication on 10.11.2021 before the Hon'ble Punjab & Haryana High Court and this department filed short reply vide which it was stated that the department has decided to offer another opportunity to petitioner for submission of relevant documents w.r.t. her claim. In pursuance of said short reply, Hon'ble Court passed the following order: -

***“.....Short reply on behalf of respondents No. 1 and 2 filed in Court today with copy thereof to learned counsel for the petitioner is taken on record subject to just exceptions. However, cost by way of demand draft in favour of the petitioner has not been handed over. Needful be done before the next date of hearing. Petitioner also be intimated of the specific date in terms of averment in para 5 of the short reply.”***

In compliance of the above said order dated 10.11.2021 passed by the Hon'ble High Court, the petitioner was called for personal hearing before the document verification committee vide letter bearing no. 13/04-2021 PGT-1 (2) dated 17.11.2021 for 23.11.2021.

Whereas, Smt. Krishna Kumari Yadav, appeared personally on 23.11.2021 alongwith certain documents pertaining to her claim before the



Document Verification Committee (hereinafter referred as 'DVC'). Whereas, the DVC minutely examined the claim of the petitioner prayed through aforesaid writ petition and representation dated 08.10.2020 served by the petitioner in light of prevailing rules, instructions & available record.

Whereas, Smt. Krishna Kumari Yadav applied for the post of PGT Sanskrit under Advt. No. 1/2012 dated 07.06.2012 issued by Haryana School Teacher Selection Board (hereinafter referred as 'HSTSB') now merged in Haryana Staff Selection Commission (hereinafter referred as 'HSSC') on the basis of experience obtained from privately managed school. Whereas, under *Haryana State Education School Cadre (Group – B) Service Rule, 2012*, the one-time exemption to acquire/passing Haryana Teacher Eligibility Test (HTET) was granted to those candidates who worked under privately managed Government aided, recognized and Government Schools for a minimum period of four years.

Whereas, the DVC also found that the name of the petitioner was recommended by the HSTSB at Merit No. 995 vide letter No. 2/1/2013-HSTSB/2014/CA/452 dated 30.06.2014/03.07.2014. Whereas, appointment was not offered to petitioner on the ground that she didn't produce the relevant record pertaining to her experience certificate.

Whereas, before DVC petitioner submitted the experience certificate issued by Vivekanand Sr. Sec. School, Dahina, Rewari for the period of 01.08.2004 to 20.06.2012. Whereas, the DVC asked the petitioner to submit Passbook of Bank or CPF accounts statement which may prove about the salary withdrawn by the petitioner from concerned school alongwith certificate/copy of result gazette pertaining to Sanskrit Students, which may prove the strength of Sanskrit Students of concerned school.

DVC also asked the petitioner for clarification, as there was no Sanskrit Student in concerned school w.e.f. March, 2008 for Class – 12<sup>th</sup> & 11<sup>th</sup> and for Class 10<sup>th</sup> w.e.f. March 2010. Furthermore, DVC also called for the staff statement of the school concerned from the petitioner to corroborate the fact that she was worked in concerned school.

Whereas, petitioner neither submitted any satisfactory record/document nor proves the genuineness of any document tender by her on 23.11.2021

during DVC process.

Whereas, DVC has observed that the petitioner is not eligible to be considered for the post of PGT Sanskrit because, petitioner failed to corroborate her experience certificate with any independent evidence

In view of the above mentioned facts and official record and in furtherance to the report of DVC, the claim of the petitioner demanded through representation dated 08.10.2020 is not tenable and same is hereby rejected being devoid of merits.

I, order accordingly.

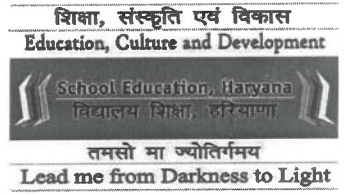

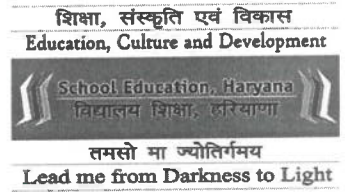

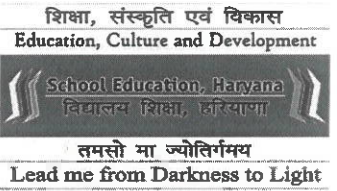
