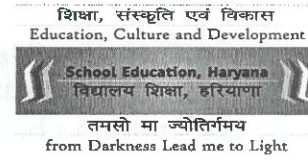

Whereas, **SMT. SNEH LATA [081190], TGT/Master (Social Studies), Govt. Sr. Sec. School, Rajpur (Sonipat) [3539]** is hereby promoted as **PGT History w.e.f. 08.01.2021 (Notionally)** i.e. the date from her juniors were promoted to the post of PGT History in the Scheduled-I of Revised Pay Matrix of functional Pay Level-8 i.e. 47,600-1,51,100/- plus usual allowances as admissible from time to time. However, no arrears will be admissible to her and the benefit of pay-fixation and seniority will be admissible only. Further, she is temporarily posted against vacancy in the school mentioned against her name in the table. TERMS AND CONDITIONS:-

- 1) If any, disciplinary proceeding under Rule 7 or 8 of Haryana Civil Service (Punishment & Appeal) Rules, 2016 is found pending subsequently, the said incumbents(s) shall be reverted without issuing any prior notice.
- 2) The promotion has been given on the basis of availability of 70 percent or more records falling in the category of good or better than that and in the eventuality of finding integrity doubtful during the said period as well as remaining records, the incumbent(s) shall be reverted without issuing any notice.
- 3) If subsequently, it is found that any candidate has done Post Graduation or other qualifications in distance mode from deemed Universities, from study centers located outside the territorial jurisdiction of the University, without seeking approval of UGC and the State Government, the same shall be reverted in view of judgment passed by Hon'ble Division bench of Punjab and Haryana High Court in CWP No. 1640 of 2008 decided on 06.11.2012 titled as Kartar Singh Versus Union of India and others cited in 2013(1) RSJ 224. Moreover, LPA No. 19 of 2021 titled as State of Haryana and others Vs. Shri Bhagwan and others has filed by the department, in which the Hon'ble Bench has stayed the order dated 16.10.2019 and the same is listed for hearing on 19.05.2022.
- 4) If the penalty of stoppage of grade increments with or without cumulative effect is still in operation, the candidate(s) shall be reverted in view of Govt. instructions dated 31.05.2006.
- 5) If any discrepancy regarding not fulfilling the essential qualifications eligibility as prescribed in the Haryana State Education School Cadre (Group B) Service Rules, 2012, the said incumbent(s) shall be reverted without issuing any prior notice.
- 6) The promotion being based on provisional list and without prejudice to the right of the seniors to be considered if they opt for promotion as **PGT History** provided they are found eligible for the post.

- 7) Promotions are subject to undergo change if warranted on the regularization of the provisional gradation list.
- 8) In case the degree of a teacher is found not to be from a recognized University having no statutory authority/jurisdiction in regard to award of such degree, the promotion shall be cancel forthwith and the teachers so promoted shall be liable for strict disciplinary action as per rules.
- 9) The teachers in the provisional seniority list who are senior to the teachers whose documents have been found in order and eligible are being promoted and posts have been reserved for them pending determination of their eligibility at a later date.
- 10) Inter-se seniority based on the feeder cadre shall be the determining factor in the PGT Cadre. In other words if a senior employee in the TGT cadre is found eligible at a later date and vacancy in respect of them is occupied by a junior employee, then the junior employee shall have to be reverted back so that such senior employee may get their due promotion.
- 11) She will remain on probation for a period of one year, which can be extended in terms of Service Rules, in case their work and conduct is not found satisfactory.
- 12) It is also made clear that the candidates can't be considered senior then other TGTs those will be promoted thereafter in other subjects and seniority will be considered only from their feeder cadre i.e. as per seniority list of TGTs.
- 13) It is made clear that they should compulsorily participate in the next General Transfer Drive as per Teacher's Transfer Policy, 2016.
- 14) She is directed to join their place of posting within 07 days, failing which this offer of promotion will be deemed to have been withdrawn.



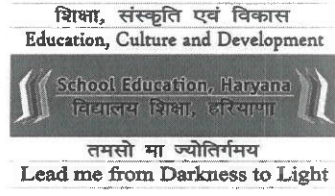
