Terms and conditions:-

1. He/She is appointed purely on temporary basis. This appointment is against temporary post and his/her confirmation against substantive post shall be considered on the basis of his/her seniority and record of service as and when such post is available.
2. The benefit of ante-date appointment will be admissible w.e.f. 06.03.2019 from the date when his/her juniors have been appointed only for notional pay fixation & seniority and actual financial benefits will be admissible to him/her from the date he/she joins duty as **PGT Mathemsitcs**.
3. He/She shall have to take an oath of allegiance to the Constitution of India.



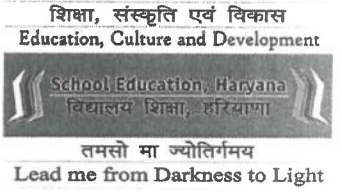

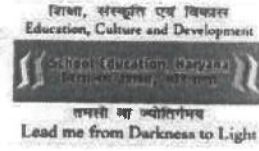
