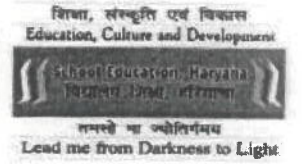



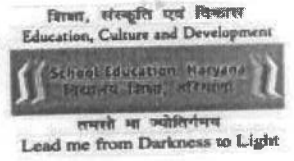

Whereas, recommendation was received from HSSC vide their Memo No. HSSC/Confd./Recomm./2020/760 dated 19.10.2020. The name of Sh. Ram Niwas, Roll No. 40202277, Merit No. 212-A was recommended for appointment to the post of PGT Chemistry in this recommendation.

After receiving the recommendation dated 19.10.2020, the selected candidates were directed to appear before the document verification committee (hereinafter referred as 'DVC') on 12.01.2021 for document verification. The DVC after examining the record pertaining to Sh. Ram Niwas, observed that he passed M.Sc. Chemistry from Manonmanniam Sundaranar University, Tamilnadu through a study centre situated at Hisar, which is now closed (as reported by DVC).

In response to the above observation of DVC and to avoid any complexity, the Department requested University Grant Commission vide letter dated 22.07.2021 to clarify as to whether Manonmanniam Sundaranar University, Tamilnadu was allowed to open study centres outside its jurisdiction or not?

Accordingly, UGC has clarified vide letter dated 22.09.2021, that the Manonmanniam Sundaranar University, Tamilnadu is State University and can operate within its State only. The clarification received from UGC is reproduced here as under:-

***The UGC (ODL) Regulations, 2017 were notified on 23<sup>rd</sup> June, 2017 and subsequently the process for granting recognitions to HEIs for offering programmes through the ODL mode was undertaken by the UGC. Under these Regulations, programme-wise recognition has been accorded to the HEI for 2019-20. The current recognition status of the HEI, along with the recognized programmes for 2019-20 Academic session beginning form July 2019 and Jan 2020 only is available on the UGC website at the following URL; <https://www.ugc.ac.in/pdfnews/0114374 ProgrammeRecognition ListOLD.pdf> It is for information that being a State University, it can operate within its State only. The university is not authorized to open study centre/off campus centre beyond the territorial jurisdiction of the State as per the judgment of Hon'ble Supreme Court of India in the case of Prof. Yash Pal vs. The State of Chhattisgarh (2005). Kindly refer the Public Notice dated 27.06.2013 on territorial jurisdiction of universities and other matters related to distance education on UGC website. The UGC has not granted any approval to the university to open***

Whereas, in meanwhile, before taking any decision in pursuance to the facts referred *supra*, Sh. Ram Niwas filed CWP No. 2570 of 2022 which was disposed of on the first very date of the case i.e. 10.02.2022, with the following direction:-

***“The limited prayer addressed, facts and circumstances of the case but without expressing any opinion on the merits thereof, this writ petition is disposed of with a direction to the competent authority, to decide representation dated 28.01.2022, Annexure P-5, submitted by the petitioner definitely within a period of six (06) weeks from the date of receipt of certified copy of this order.”***

In compliance of the above direction passed by the Hon'ble High Court dated 10.02.2022 (certified copy received on 05.03.2022), the representation dated 28.01.2022 was minutely examined in light of the clarification dated 22.09.2021 provided by UGC. Furthermore, the contention of petitioner vide which he placed reliance upon the appointment of another PGT Chemistry namely Ms. Sonia, who has obtained her master degree from the study centre of Manonmanniam Sundaranar University, Tamilnadu situated beyond the territorial jurisdiction, from which the petitioner has also obtained the disputed qualification.

Whereas, thereafter, the appointment matter of Ms. Sonia was also re-examined and it has been found that the said appointment was issued inadvertently without taking the appropriate clarification from UGC and Kurukshetra University Kurukshetra regarding equivalency. The appointment of Ms. Sonia is being withdrawn after providing her an opportunity of being heard.

Keeping in view of the facts and circumstances stated *supra* and clarification dated 22.09.2021 received from UGC, the candidature of Sh. Ram Niwas, Roll No. 40202277, Merit No. 212-A is hereby rejected.



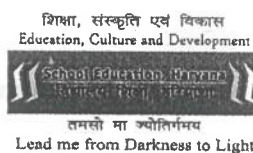

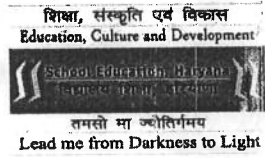
