The matter has been reviewed by the Government and it has been observed that the marking of attendance through AEBAS is very low. All the Administrative Secretaries are requested to issue the direction to all the Departments/Boards/Corporations etc. under their administrative control to motivate the officers/officials to ensure marking attendance through Aadhaar Enabled Biometric Attendance System (AEBAS), so that attendance percentage increases to 90% by the month end.

Further, all departments/boards/corporations will take all steps for implementation of AEBAS, renewal of Annual Maintenance Contract (AMC) and repair/purchase of new Biometric Attendance Devices as per Government instructions. Further data of registered users be also updated and all the officers/officials be registered. The officers/officials who are required to attend office shall ensure marking attendance through AEBAS and wherever, any relaxation is required due to nature of work/job then the same may be sought. All relaxations/exemptions granted earlier would cease to apply as communicated earlier.

A special mention can be recorded in the ACR of the Officers/Officials, who marks attendance above 90% through AEBAS as appreciation.

A meeting with departments having maximum registered users, to work out modalities for better implementation of Aadhaar Enabled Biometric Attendance System (AEBAS) was held, wherein, the attendance percentage of the departments was reviewed. The attendance percentage of the Ayush Department, School Education Department, Transport Department, Urban Local Bodies Department & Home Department was found less than 10%.

After detailed discussions the following decisions were taken:-

Item No. 1 - Attendance marked against total registered users.

i. CS advised to motivate the officers/officials to mark their attendance through Aadhaar Enabled Biometric Attendance System (AEBAS) and to increase the low percentage of biometric attendance. Further data of registered users be also updated and all the officers/officials be registered. The officers/officials who are required to attend office shall ensure making attendance through AEBAS and wherever, any relaxation is required due to nature of work/job then the same may be sought. All relaxations/exemptions granted earlier would cease to apply as communicated earlier.

Item No. 2 - Status of active device/tablet/Desktops.

ii. It was decided that all departments/boards/corporations shall take immediate steps for implementation of AEBAS such as renewal of Annual Maintenance Contract (AMC), repair/purchase of new Biometric Attendance Devices as per Government instructions.

Item No. 3 – Steps being taken to enforce marking attendance through AEBAS.

Departments/Boards/Corporations etc. under their administrative control to motivate the officers/officials to mark attendance through Aadhaar Enabled Biometric Attendance System (AEBAS), so that attendance percentage increases to 90% by the month end.
