I am directed to refer to the subject noted above and to say that Government has reconsidered the role and responsibilities of Additional Deputy Commissioner in Haryana State and decided that the role and responsibilities of Additional Deputy Commissioners in Haryana State will be as under in addition to their existing duties:-

Revenue related work:-

- a The powers of Collector may be vested with under various Revenue Act.
 - b He/She shall hold courts and Deputy Commissioner may transfer revenue cases to him/her.
 - c He/She may also supervise various branches related to Revenue works in Deputy Commissioner's office.
 - d Additional Deputy Commissioner shall be made Nodal Officer for all Revenue related works of the district.
- i) Additional Deputy Commissioner shall be given more financial autonomy to make more effective role in Sarva Siksha Abhiyan.
 - ii) Additional Deputy Commissioner shall be vested financial powers to make their intervention more effective for Supplementary Nutrition Programme (SNP) for Women and Child Department.
 - iii) Additional Deputy Commissioner shall be given more financial and functional control over Social Sector related Departments to make their intervention more effective for Mukhyamantri Antyodaya Pariwar Utthan Yojanan (MMAPUY) Sanrakshak Scheme.
 - iv) Additional Deputy Commissioner shall be made ex-officio Vice-Chairman of the District Sports Council and District Olympic Association, and shall be the Nodal officer for Sports related activities by Association/Council in the District.
 - v) Additional Deputy Commissioner shall be made Nodal Officer for work/proposals related to District Health & Family Welfare Societies.
