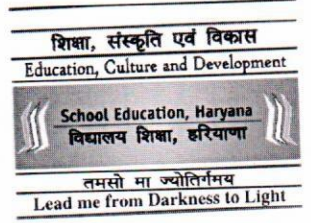

In pursuance with instructions of Chief Secretary, Haryana issued vide letter No. 22/10/2013-1GS-III dated 17/19.04.2017 & 22/10/2013-1GS-III dated 25.03.2022 amended from time to time and recommendations of State Commissioner for the Persons with Disabilities, Department of Social Justice and Empowerment, Haryana in case No. 395/2021 titled as Bansi Lal Jarohar, State President, Viklang Sangh Umang, Sirsa V/s ACS School Education, the following Post Graduate Teachers are hereby granted promotion to the post of Principal (Rest of Haryana Cadre) (School Cadre) in the pay scale notified under Haryana Civil Services (Pay) Rules 2006/2016 under 3% reservation in PwD quota with benefit of notional pay fixation although such officers will not be entitled for arrears for the period they have not actually worked as Principal.

NOTE: THE OFFICERS WHO ARE PROMOTED AS PRINCIPAL WITH IMMEDIATE EFFECT SHALL CONTINUE TO WORK AS PGT AT THEIR PRESENT PLACE TILL THE NEW PLACE OF POSTING AS PRINCIPAL IS GIVEN.

Terms & Conditions:-

1. In case the claim belonging to disability certificate of any PGTs is found false and fabricated at any stage later on, he/she would be reverted without any notice and without any prejudice to such further disciplinary action as may be initiated under the provisions of the Indian Penal Code for production of such false/fabricated documents.
2. The candidate is directed to provide latest disability certificate in accordance with the Government of Haryana Gazette Notification No. 32/05/2019-6HB-I dated 05.08.2021 within 30 days of joining to promotional post, failing which, he/she would be reverted without serving upon a notice.
3. The date of this Roaster/promotion can be changed/amended/alterd, if required on the basis of any legitimate claim of some other or any of the PGTs in the cadre.
4. In addition to these candidates, if claim of another disabled PGT is found legitimate in respective category, the junior most would be reverted without a notice and concerned senior disabled PGT would be promoted.
5. The candidate would not claim any arrear of pay on account of his/her notional promotion and only notional benefits of pay fixation will be granted. He/She would be granted actual benefit of pay fixation from actual date of joining to promotional post.
6. If any discrepancy regarding not fulfilling the essential qualifications as prescribed in the Haryana State Education School Cadre (Group B) Service Rules, 1998 & 'Haryana State Education School Cadre (Group B) Service Rules, 2012 amended in 2014', the said incumbent(s) shall be reverted without issuing any notice.
7. The Promotee(s) will remain on probation for one year as per rule 27 of Haryana Civil Services (General) Rules, 2016.
8. After promotion, seniority of these officers will be determined as per instructions/rules issued or notified by the Govt. of Haryana, School Education Department from time to time.
9. There should not be any enquiry/charge sheet/embezzlement/punishment effect etc. pending against him/her. In case such a thing is pending, the promotion may be withdrawn as per rule.
10. The above promotion is subject to the decision of CWP No. 24613 of 2019 titled as Satbir Singh Vs State of Haryana and another, CWP No. 21481 of 2019 titled as Prahlad Singh Vs State of Haryana and others, CWP No. 24867 of 2019 Pardeep Singh Vs State of Haryana and others, CWP No. 2162 of 2022 Jitender Singh and anr Vs State of

Haryana and another, CWP No. 21444 of 2018 Ajay Kumar and others Vs State of Haryana and any other court case(s) pending before Hon'ble High Court or Hon'ble Supreme Court of India.

11. The candidate would have no claim of seniority over those who are otherwise senior to him/her but his/her case could not have been got considered for promotion due to one reason or the other.
12. In case any adverse remark found in his/her ACRs or any ACR is awaited/missing ACRs, he/she would be reverted without serving any notice.
13. He/She would be liable for reversion without giving any notice in case any other official emerges as senior most in the respective seniority list.
14. The promotion would be as per the respective pay scale issued by the Finance Department, Govt. of Haryana from time to time.
15. The newly promote officers shall have to seek permanent posting through MIS portal by participating in Transfer Drive.
16. He/She has also not claim seniority above his/her senior on the basis of this promotion and he/she would be reverted to the post of PGT without serving any notice if any senior to him/her is/are found fit or entitled for promotion at later stage in the event of decision in the seniority position made by the department.
17. The promotions under these instructions have been granted to the persons with disabilities who may be junior to others in the seniority list. No benefit of stepping up of pay or pay scale shall be admissible to others who were/are senior to him/her in the PGT Cadre.
