#### ORDER

No. 11/2-2021 HRME-II (2)

Dated, Panchkula 03-06-22

Whereas, Sh. Ashok Kumar Yadav, retired Superintendent O/o District Education Officer, Rewari, has made a representation dated 27.02.2021 to the Department to grant him the pay scale of Superintendent from the period, when he was assigned the current duty charge of Superintendent to the period when he was promoted as Superintendent i.e. w.e.f 13.08.2014 to 30.11.2017 alongwith all consequential benefits.

In reference to the above said representation, the service record of Sh. Ashok Kumar Yadav was examined and during examination it has been found that Sh. Ashok Kumar Yadav, who was appointed as a Clerk on 18.11.1977, was promoted to the post of Assistant on 12.06.2012 and thereafter promoted to the post of Dy. Superintendent vide order No. 2/7-2012 HRME (2) dated 26.09.2012. But due to exigency of work, current duty charge of Superintendent was assigned to him vide order No. 2/5-2011 HRME (2) dated 11.08.2014 for smooth functioning of administrative work, in his own pay scale and the same was clearly mentioned at Point No. 7 in the terms and conditions of the said order dated 11.08.2014. Consenting to the aforesaid condition he joined in the O/o District Education Officer, Rewari on 13.08.2014.

Whereas, as per Haryana Education Department, sub-offices, Ministerial (Group-C) Rules, 1983, the Dy. Superintendent must have the experience of at least three years for the promotion to the post of Superintendent.

Whereas, at the time of assigning the current duty charge of Superintendent to Sh. Ashok Kumar Yadav, he had only the experience of 01 year 10 months and 15 days as a Dy. Superintendent. So, he could not be promoted to the post of Superintendent at that time. But on the completion of the abovesaid experience as a Dy. Superintendent, he was promoted as Superintendent vide order No. 2/1-2016 HRME(3) dated 24.11.2017/30.11.2017, who retired as a Superintendent from the O/o District Education Officer, Rewari on 28.02.2018, on attaining the age of superannuation.

Further, the example of Sh. Krishan Chander Rana was quoted by the applicant that he was given the pay scale of Superintendent vide order No. 13/14-2011 HRME (2) dated 29.06.2016, whereas he was assigned the duty of Superintendent Incharge vide order dated 01.03.2007 and in the context of the same, it is hereby clarified that Sh. Krishan Chander Rana, the then Dy. Superintendent O/o DEO Sonipat was assigned the duty of Superintendent Incharge, due to exigency of work, vide order No. 2/33-99 HRME (3) dated 01.03.2007. But due to clerical error in order dated 01.03.2007, it was inadvertently mentioned therein that he was promoted to the post of Superintendent Incharge in the pay scale of Dy. Superintendent i.e. Rs. 5500-175-8300-EB-175-9000. So by taking the advantage of that mistake of the Department, he approached to the Hon'ble High Court through CWP No. 2240 of 2011 titled as Krishan Chander Rana Vs. State of Haryana & Ors. and got the favorable orders from the Hon'ble High Court vide order dated 09.04.2015.

Thus, the inadvertent benefit granted to a particular person in un-avoidable circumstances can't be set as a wrong precedent for the others.

Keeping in view the facts mentioned above as well as the statutory provisions and instructions issued by the Govt. of Haryana from time to time, I am of the considered view that Sh. Ashok Kumar Yadav is not entitled for the pay scale of Superintendent from the period when he was assigned the current duty charge of Superintendent to the period of his promotion to the post of Superintendent i.e. w.e.f. 13.08.2014 to 30.11.2017. Thus, the claim of the applicant demanded through representation dated 27.02.2021 is not tenable and hence rejected.

I order accordingly.
