It is, however, pointed out that only such documents will be shown to her as are in the possession of the Director, Secondary Education, Haryana, Panchkula, and as are strictly relevant to the case. If in the opinion of the Government, it is not desirable in the public interest, to allow her access to any document, such access shall be refused. If, Smt. Sanju Sharma, wishes to consult any other relevant record, which is not in the custody of the Director General, Secondary Education, Haryana, Panchkula, it is for her to undertake its inspection. It is, however, made clear to Smt. Sanju Sharma that her failure to inspect the documents shall not constitute a valid ground for delay in the submission of her written statement and if the written statement is not received by the undersigned within the specified period, it shall be presumed that she has none to submit.
- 4 The written statement should be submitted direct to the undersigned.

While being posted as Principal at Government Model Sanskriti Senior Secondary School, Sector-26 [30114], Panchkula from 09.03.2021 to 18.02.2022, Smt Sanju Sharma committed following acts of omission and commission:-

That Smt Priyanka Sharma being Trained Graduate Teacher, Physical Education while posted at Government Model Sanskriti Senior Secondary School, Sector-26, Panchkula made complaint dated 03.02.2022 against her i.e. Smt Sanju Sharma being Principal of said school alleging therein that she i.e. Smt Sanju Sharma being Principal forced her i.e. Smt. Priyanka Sharma to not to participate in the sports activities of the school and gave school land to a private party for Basket Ball Court. In this context, a committee chaired by Shri Nand Kishore Verma, Assistant Director (Academic) submitted his report dated 17.02.2022, after visiting the Government Model Senior Secondary School, Sector-26, Panchkula on 03.02.2022 wherein various irregularities were found. Further, Executive Engineer office of Haryana School Shiksha Pariyojana Parishad, Panchkula was also appointed as Inquiry Officer on 18.02.2022 and report dated 03.03.2022 was submitted by the Executive Engineer office of Haryana School Shiksha Pariyojana Parishah, Panchkula wherein the following lapses were found to be committed on her part i.e. Smt Sanju Sharma:-

That she i.e. Smt Sanju Sharma engaged private person i.e. Shri Ashish Dubey for construction work of Basket Ball Court in Government Model Sanskriti Senior Secondary School, Sector-26, Panchkula as per School Management Committee Resolution number 19 dated 26.01.2022 and allowed Shri Ashish Dubey to construct and operate the Basket Ball Court in the school premises without obtaining the formal approval of the competent authority, which is serious lapse on her part i.e. Smt Sanju Sharma being an supervisory post.

In this way, she i.e. Smt Sanju Sharma performed her duty in a negligent and irresponsible manner and committed an act unbecoming of a Government Officer and violated the provisions of rule 4(1) and (2) of the Haryana Civil Services (Government Employees Conduct) Rules, 2016.

While being posted as Principal at Government Model Sanskriti Senior Secondary School, Sector-26 [30114], Panchkula from 09.03.2021 to 18.02.2022, Smt Sanju Sharma committed certain acts of omission and commission for which she is charged as under:-

That Smt Priyanka Sharma being Trained Graduate Teacher, Physical Education while posted at Government Model Sanskriti Senior Secondary School, Sector-26, Panchkula made complaint dated 03.02.2022 against her i.e. Smt Sanju Sharma being Principal of said school alleging therein that she i.e. Smt Sanju Sharma being Principal forced her i.e. Smt. Priyanka Sharma to not to participate in the sports activities of the school and gave school land to a private party for Basket Ball Court. In this context, a committee chaired by Shri Nand Kishore Verma, Assistant Director (Academic) submitted his report dated 17.02.2022, after visiting the Government Model Senior Secondary School, Sector-26, Panchkula on 03.02.2022 wherein various irregularities were found. 
