



Order no. 6/123-2021 HRG-I (2)

Dated 21-06-2022

Whereas, the petitioners have filed a CWP No. 12663 of 2021 titled as Raj Singh and Another v. State of Haryana and Another with a prayer to consider and make promotions of the petitioners as per their merit and entitlement after implementing 3% reservation of physically handicapped category in view of the statutory provisions of The Rights of Persons with Disabilities Act, 2016 as well as the judgments of Hon'ble Apex court of India with all consequential benefits and to decide the legal notice dated 23.03.2021.

The present writ petition was came up for hearing on 14.07.2021 and the Hon'ble High Court disposed of the present writ petition. The operative part of the order is as under:-

"Accordingly, without commenting on the merits of the case and the entitlement of the petitioners, it is directed that respondent No.2 shall decide the legal notice (Annexure P-1) of the petitioners within a period of three months on receipt on certified copy of this order. In case, it is found that the petitioners are entitled for the claim sought, necessary benefits be granted to them and if they are not found entitled for the said claim or there is any legal impediment, a reasoned order be passed and communicated to the petitioners."

In compliance of the above said order, the legal notice of the petitioners was examined. The petitioners were initially appointed as Head Masters and the department has passed the order vide no. 6/123-2021 HRG-I (2) dated 16.05.2022/01.06.2022 and granted the deemed date promotion to the post of Principal under 3% reservation in PwD Quota w.e.f 12.10.2002 and 10.05.2002 respectively. The petitioners will not be entitled for any arrear of pay for period of promotion in which they have not actually worked as Principal.

That for further promotions of the petitioners under 3% reservation disabled quota, firstly, the department will make promotions to the post of Principal from the cadre of PGT and Headmaster and then the seniority of Principals under reservation quota will be finalized. After that, the claim of the petitioners for further promotion will be considered accordingly.



Keeping in view the above mentioned facts, the claim of the petitioners for further promotion from the post of Principal will be decided after the finalization of the seniority of the Principals under handicapped category.

It is ordered accordingly.
