Order No. 5/2-2017 HRME-I (6)

Dated, Panchkula, 01.06.2022

Whereas Sh. Rajesh Kumar, the then Clerk DIET Ikkas, Jind now posted in GSSS Ghimana, Jind was charge sheeted vide order No. 5/2-2017 HRME-I (6) dated 14.12.2017 under Rule-7 of Haryana Civil Services (Punishment & Appeal Rules), 2016 wherein the following charges levelled against him:-

“यह कि जिला शिक्षा एवं प्रशिक्षण संस्थान ईक्कस (जींद) में सर्व-शिक्षा अभियान की ग्रंट के तहत वर्ष 2009-10 में संस्थान की चार दीवारी का निर्माण संस्थान के प्राचार्य के नेतृत्व में पांच सदस्यीय कमेटी ने करवाया था, जिस कार्य की जांच मौजूदा प्राचार्य श्री जयवीर सिंह ढाण्डा ने एक कमेटी नियुक्त करके करवाई। इस जांच कमेटी में संस्थान की 1 MDC कमेटी के सदस्य गांव के सरपंच श्री सुबेदार मेजर, श्री अमीचन्द नम्बरदार, श्री धर्मसिंह पूर्व सरपंच तथा गांव के अन्यगण मान्य व्यक्तियों को शामिल करते हुए दिनांक 18.02.2015 व दिनांक 19.02.2015 को जांच की गई। जांच में तत्कालीन इन्चार्ज (DDO) प्राचार्य डाईट ईक्कस (जींद) व राजेश मोर, लिपिक, डाईट ईक्कस (जींद) की अनियमितार्ये पाई गई तथा उन द्वारा ग्रंट नाजायज खर्ची गई थी। उन गल्तीयों पर 1MDC व गांव के गणमान्य व्यक्तियों ने अनियमिता खर्चे को जोड़कर व इस पर ब्याजदर 9% लगाकर, श्री राजकुमार वर्मा तत्कालीन इन्चार्ज व श्री राजेश मोर, लिपिक को रु 93671/- को SSA के खाते में जमा करवाने को कहा। उन्होंने यह रकम कमेटी को दी तथा कमेटी ने खाते में यह राशि जमा करवा दी।

उपरोक्त राशि श्री राजेश मोर, लिपिक डाईट ईक्कस (जींद) ने जांच कमेटी के सदस्यों को दिनांक 24.02.2015 को दी तथा सभी जांच कमेटी के सदस्यों ने हरियाणा ग्रामीण बैंक, ईक्कस में डाईट ईक्कस के खाता संख्या SSA A/C No 82590100011892 में रसीद संख्या D1119925 तथा D119873 के माध्यम से जमा करवा दी।”

The delinquent submitted the reply to the chargesheet on 09.01.2018 and denied the charges leveled against him and further prayed to drop the



charge sheet issued against him. He further contended that there was no fault on his part.

Thereafter, vide order No. 5/2-2017 HRME-I (6) dated 07-05-2018 Sh. V.G. Goel, HCS (Retd.), was appointed an enquiry officer in the said matter and in the context of the same, the inquiry report dated 29.04.2019 was submitted by the Inquiry Officer wherein it was concluded that Sh. Rajesh Kumar, Clerk had attempted to embezzle the amount of Rs. 10,000/- with the connivance of his counterparts. Accordingly, the punishment of stoppage of two annual increment with cumulative effect was inflicted upon him vide order No. 5/2-2017 HRME-I (6) dated 27.07.2020.

Now, Sh. Rajesh Kumar preferred First Appeal against the order dated 27.07.2020 to Director General Secondary Education Haryana, Panchkula. Before finalizing the same an opportunity of personal hearing was granted to him on 01.06.2022. During the course of hearing, the appellant submitted that there was no fault on his part & reiterated the same facts as submitted by him in his reply dated 09.01.2018.

Thus, keeping in view of the above said facts and circumstances, contents of appeal as well as the documents on record, it has been observed that the version of the appellant has already been considered by the Competent Authority while passing the order No. 5/2-2017 HRME-I (6) dated 27.07.2020 and no new grounds/documents were preferred in the context of the present appeal.

Therefore, I find no reason to interfere with the orders dated 27.07.2020 of the Joint Director, Admn.-I and hence the present appeal is hereby rejected being devoid of merits.

I, order accordingly.

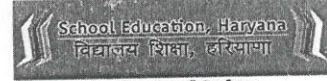

Whereas Sh. Yogesh Kumar, the then Clerk, DIET Ikkas, Jind now posted in the office of District Education Officer, Yamuna Nagar was charge sheeted vide order No. 5/2-2017 HRME-I (6) dated 14.12.2017 under Rule-7 of Haryana Civil Services (Punishment & Appeal Rules), 2016 wherein the following charges were levelled against him:-

The delinquent submitted the reply to the chargesheet on 18.12.2017 and denied the charges levelled against him and further prayed to drop the charge sheet issued against him. He further contended that there was no fault on his part.

Thereafter, vide order No. 5/2-2017 HRME-I (6) dated 07-05-2018 Sh. V.G. Goel, HCS (Retd.), was appointed an enquiry officer to inquire into the said matter. The inquiry report dated 29.04.2019 was submitted by the Inquiry Officer wherein it was concluded that Sh. Yogesh, Clerk had attempted to embezzle the amount of Rs. 10,000/- with the connivance of his counter parts. Accordingly, the punishment of stoppage of two annual increment with cumulative effect was inflicted upon him vide order No. 5/2-2017 HRME-I (6) dated 27.07.2020.

Now, Sh. Yogesh Kumar has preferred First Appeal against the order dated 27.07.2020 to Director General Secondary Education Haryana, Panchkula. Before finalizing the same an opportunity of personal hearing was



granted to him on 01.06.2022. During the course of hearing, the appellant submitted that there was no fault on his part & reiterated the same facts as submitted by him in his reply dated 18.12.2017.

Thus, keeping in view of the above said facts and circumstances, contents of appeal as well as the documents on record, it has been observed that the version of the appellant has already been considered by the Competent Authority while passing the order No. 5/2-2017 HRME-I (6) dated 27.07.2020 and no new grounds/documents were preferred in the context of the present appeal.

Therefore, I find no reason to interfere with the orders dated 27.07.2020 of the Joint Director, Admn.-I and hence the present appeal is hereby rejected being devoid of merits.


