Whereas Smt. Sunita Chauhan had filed the CWP No. 24099 of 2019 in the Hon'ble Punjab & Haryana High Court praying therein for issuance of a writ in the nature of mandamus directing the respondents to select and appoint the petitioner being meritorious candidate to the post of Post Graduate Teacher (*hereinafter referred as 'PGT'*) Hindi under Scheduled Caste Category against those two posts which were earlier kept reserved in compliance of the order of this Court.

Whereas, the aforesaid writ petition came up for adjudication on 10.09.2019 and the Hon'ble High Court disposed of the same with order dated 10.09.2019. The operative part of the order dated 10.09.2019 is reproduced here as under: -

".....Mr. Mohan Singla, learned counsel appearing on behalf of petitioner submits that in pursuance to Advertisement No.4 of 2015, caused for filling up 367 posts of PGT Hindi, petitioner applied for the aforementioned post under Scheduled Caste Category. After having participated in the selection process, she secured 100 marks in written examination and last short listed candidate for interview in the SC Category secured only 98 marks despite that she has not been called for interview. Petitioner filed CWP No.21720 of 2018 wherein vide interim order dated 29.08.2018, allowed her for provisional interview and she cleared the same by securing 18 marks. This Court dismissed aforementioned writ petition but gave liberty to the petitioner to approach this Court again in case SC Category vacancies remain vacant. Without adhering to the aforementioned directions, respondents caused an advertisement dated 22.08.2019 (Annexure P-13) and in this regard, petitioner has submitted representations dated 22.07.2019 (Annexures P-11 and P-12) but no action has been taken so far. The predicament of petitioner is writ large.

In view of statement made by learned counsel for the petitioner and without going into merit of case or commenting thereon, present writ petition is disposed of with a direction to respondents No.2 and 3 to decide the representations dated 22.07.2019 (Annexures P-11 and P-12) by passing a well

reasoned and speaking order within a period of one month from the date of receipt of certified copy of this order."

In compliance of the above said order dated 10.09.2019 passed by the Hon'ble High Court, the representation dated 22.07.2019 served by petitioner was minutely examined and it has been found that the department has not received any recommendation pertaining to the petitioner from Haryana Staff Selection Commission (*hereinafter referred as 'HSSC'*). Therefore, without any recommendation, the department is not in position to offer appointment to Smt. Sunita Chauhan for the post of PGT Hindi.

Whereas, it is submitted here that the Department of School Education sent a requisition to the HSSC for selection and recommendation of the names of eligible candidates for the various posts of PGT Hindi, as per the *Haryana State Education School Cadre (Group - B) Service Rules, 2012*. The whole selection process i.e. from issuing advertisement to the declaration of final result is carried out by the HSSC. Thus, the claim Smt. Sunita Chauhan can only be redressed by HSSC, as they can explain as to why the name of petitioner has been recommended yet.

Keeping in view of the facts and circumstances stated *supra*, the claim of the petitioner demanded through representation dated 22.08.2019 is hereby rejected.

- Note:- 1. Their appointment is subject to the condition that concerned District Education Officers may ensure the Character Certificate and all other documents regarding date of birth and all educational documents.**
- 2. They are also directed to participate in next online transfer drive for taking permanent Station.**

TERMS & CONDITIONS:-

1. Their appointment is against a purely temporary post which is liable to be abolished at anytime and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to them at present. Their services can be terminated without any notice, whenever there is no vacancy against which they can be retained.

2. If at any stage they desire to resign their posts they will be required to give one month's notice or forfeit in lieu thereof, their salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given to them by the Directorate Secondary Education, Haryana, Panchkula in case it is proposed to terminate their services for the reason other than that mentioned in clause (I) above.
3. They will be required to take the prescribed oath of allegiance to the constitution of India.
4. In case they are married, they will produce the following certificate to his/her Head of office:-

"That he/she is not having more than one living spouse." In case they are unmarried, they shall have to furnish a declaration to the effect that each of these will not have more than one living spouse.
5. In case they are unmarried, they will have to furnish a declaration to the Head of the Department that they have not taken any dowry after marriage. The declaration should be signed by your wife, father and father-in law, as per Chief Secretary to Govt. Haryana letter No. 18/1/2004-2GSI dated 21.02.2006.
6. The candidate shall have to qualify the State Eligibility Test in Computer Appreciation and applications (SETC) within the probation period of two years, extendable by one year in case of direct recruitment. The candidate appointed against the aforesaid categories of posts in the group 'C' shall not be entitled to earn any increment in his pay scale till he/she qualifies the said test failing which the services of such employees shall be dispensed with.
7. They will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the pursuing of higher studies.
8. They will be required to produce the original Educational documents and date of birth certificate before joining their duties of the said post.
9. They shall have to furnish fitness certificate from the Chief Medical Officer as required under Rule 9 of Haryana CSR (General), 2016 before joining their duties.
10. No TA/DA and joining time will be paid to them for joining this post.
11. They will remain on probation for a period of two years, from the date of their joining in the department. The period of probation can be extended in accordance with the existing rule on the subject. For assessing their performance during the period of probation, their work conduct will be taken into consideration. 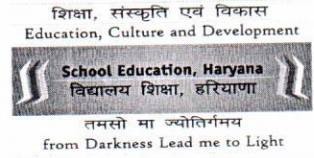

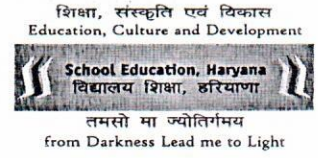
