Whereas, Smt. Braham Shakti has filed the Civil Writ Petition no. 9961 of 2022 before the Hon'ble Court for quashing the orders dated 15.02.2022 passed by respondent state.

The said Petition was disposed of by the Hon'ble court vide order dated 11.05.2022. The operative part of the order is as under:-

***"Notice of motion.***

***Mr. Raman Kumar Sharma, Additional A.G. Haryana accepts notice on behalf of respondents-State and raises no objection in deciding legal notice dated 14.03.2022(Annexure P-4) submitted by the petitioner.***

***In view of the above, without expressing any opinion on the merits of the case or the claim being made by the petitioner, respondent No. 1 is directed to decide legal notice dated 14.03.2022 (Annexure P-4) submitted by the petitioner by passing a speaking order within a period of three months from the date of receipt of copy of this order.***

***Present writ petition stands disposed of.***

Whereas, the incumbent was appointed as Headmaster High school in the year 2008 by way of direct recruitment. The candidature of some Headmasters including the incumbent was in dispute. Some Headmasters filed CWP No. 14975 of 2017 titled as Sukhdev Singh and others v. State of Haryana and another to which incumbent was placed at Sr. no. 5 seeking promotion to the post of Principal. The writ petition was disposed of by Hon'ble Court with the direction to the respondent state to consider the claim of the incumbent.

Whereas, in compliance of the said directions, the department passed speaking order vide dated 06.12.2017 as mentioned hereinafter:-

***"..The experience certificates of all the selected candidates were scrutinized by the committee constituted by the Department. Out of the whole selection list, the experience certificates of 90 persons, who were selected as Headmaster, have been found to be doubtful. From the perusal of legal notice, it is found that all the 20 petitioners are having doubtful experience certificates which are not genuine. Therefore, show cause notices have been issued to all the petitioners as to why their appointment as Headmaster should not be cancelled. All the petitioners have given the replies to their show cause notices. Now, all the replies are being examined. Thereafter, action will be taken accordingly on their promotions. In the meantime promotions of all the applicants are being withheld."***

Consequently, three committees were constituted by the department on dated 08.10.2020 to verify the experience as well as

academic qualifications of all 106 doubtful candidates including the incumbent. The committees have categorized the 106 candidates into four categories. These committees examined the documents of the candidates and categorizes the candidates as per their record. The candidates falling in category 1 and 2 were found eligible and have been promoted to the post of Principal vide order dated 15.02.2022.

Whereas, the incumbent was falling in category no.1. Hence, she was promoted to the post of Principal w.e.f 31.05.2017 subject to the condition that she was only entitled for notional pay fixation which was duly accepted by her. The petitioner retired from the service on 30.11.2020.

Keeping in view the facts and circumstances, content of legal notice and documents on record, the incumbent is not entitled for the payment of arrears on the basis of principle "no work no pay" as the incumbent had not worked for that period. In the light of principle "no work no pay" as precedent in State of Haryana v. O.P. Gupta & others (1996) 7 SCC533, The Hon'ble Supreme Court held that there has to be "no pay for no work", i.e. a person will not be entitled to any pay and allowances during the period for which he did not actually perform the duties of post. The incumbent is not entitled for any arrears of salary for the post for which she has not worked on the post of principal as also enumerated in the conditions mentioned in the promotion orders of incumbent.

Therefore, the claim of Smt. Braham Shakti is not tenable and devoid of merit and the same is hereby rejected.

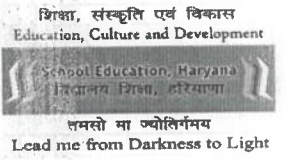
