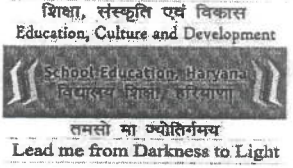

Order No. 13/45-2022 HRME-I (3)

Whereas, the petitioner namely Om Parkash has filed the CWP No. 6502 of 2022 titled as Om Parkash Vs State of Haryana & others, praying therein for issuance of a writ in the nature of mandamus directing the respondents to release the pensionary/retiral benefits to the petitioner under Old Pension Scheme by counting his services on regular basis from the date of issuance of appointment letter dated 22.12.2005 (P-1) or to treat his part time service rendered by him in the respondents department itself prior to his regularization from 01.04.1991 to 02.01.2006, as a qualifying service for grant of pensionary/retiral benefits under Old Pension Scheme.

The above-said Civil Writ Petition came upon hearing on 30.03.2022 before the Hon'ble High Court & the same was disposed of by the Hon'ble High Court. The operative part of the orders dated 30.03.2022 is reproduced here as under:-

"Without going into the merits of the case or the claim being made by the petitioner in the present petition or in the representation, the respondent No.2 is directed to decide the representation dated 11.01.2022 (Annexure P-5) within a period of eight weeks from the date of receipt of certified copy of this order. In case, after the decision, the petitioner is found entitled for any benefits, the same be also extended to him within a period of next four weeks."

In-compliance to the aforesaid direction of the Hon'ble High Court, the representation dated 11.01.2022 (Annexure P-5) of the petitioner was duly examined. On the examination of the matter, it is pointed out that initially the petitioner was engaged as Part-time class IV on 01.04.1991 through employment Exchange against un-sanctioned post in Govt. High School, Sonhasra, Bhiwani for a short span of 1 and ½ Hours daily and after working there, the petitioner was free to do any work/job anywhere else. It is significant to clear here that the services of the

petitioner were regularized w.e.f. 03.01.2006 vide order No. Est./3/04/6044-46 dated 22.12.2005 and as such the petitioner had joined as regular employee in the department on 03.01.2006. Thus, he was entitled to get the benefit as regular employee w.e.f. 03.01.2006 and not prior to that. Whereas, as per notification dated 18.08.2008 of Finance Department of Govt. of Haryana, NEW PENSION SCHEME came-in-to force, which is applicable to the employees, who has joined as regular employee on or after 01.01.2006. Thus, the petitioner Sh. Om Parkash had joined as regular employee on dated 03.01.2006. Therefore, on the basis of "NEW PENSION SCHEME", the PRAN Number was also allotted to the petitioner in which he had also deposited his share of NPS amount. In this manner, the General Provident Fund attached to Old Pension Scheme is not applicable in the case of the petitioner.

It is relevant to mention here that Rule 3.17-A of the Punjab Civil Service Rules Volume-II deals with the issue of "Qualifying-service" for pension & pensionary benefits.

However as per rule 3.17 - A(g)(iii) of Punjab Civil Service Rules Volume-II, the service period rendered as "PART TIME" employee cannot be computed for pension & pensionary benefits. Relevant portion of the same is reproduced as under.

Rule 3.17 A (g): The entire service rendered by an employee as work charge shall be reckoned towards retirement benefits provided:-

- (i) Such service is followed by regular employment.
- (ii) There is no interruption in the two or more spells of services or the interruptions fall with-in condonable limits: and
- (iii) Such services is a whole time employment and not part-time or portion of day.

Whereas, the judgment cited by the petitioner in his petition is not applicable in the case of the petitioner as the same is related to Adhoc/work-charge & Daily wager employees and not to the Part-time employees.

In-view of the above-mentioned facts, the case of the petitioner cannot be considered under OLD PENSION SCHEME, rather the benefits of NEW PENSION SCHEME have already been granted/ released to the petitioner. Thus, the claim of the petitioner sought through his representation dated 11.01.2022 is not maintainable and hence liable to be rejected.

I, order accordingly.





Subject: Appointment for the post of Clerk.

As per provision in the Haryana Civil Services (Compassionate Financial Assistance/Appointment) Rules, 2019, issued vide notification No. G.S.R. 32/Const./Art.309/2019 dated 02.08.2019. You are hereby appointed as Clerk on provisional basis in the office of Director Secondary Education Haryana, Panchkula in the pay band FPL-2 (19900-63200) of Schedule-1 pay matrix of Haryana Civil Services Schedule-I pay matrix of Haryana Civil Services (Revised pay) Rules, 2016 plus usual allowances as sanctioned by the Haryana Government from time to time, with effect from the date you resume duty in the office on the terms and conditions mentioned below:-

1. Your appointment is against a purely temporary post which is liable to be abolished at anytime and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to you at present and in this respect you will have to take your claims like others who have been recruited similarly. Your services can be terminated without any notice, whenever there is no vacancy against which you can be retained.
2. If at any stage, you desires to resign from your post you will be required to give one month's notice or forfeit in lieu thereof, your salary including allowances for one month or for the period by which the notice falls is short of one month. Such a notice will be given to you by the Directorate also in case it is proposed to terminate your services for the reason other than that mentioned in clause (I) above.
3. You will be required to take the prescribed oath of allegiance to the Constitution of India.
4. In case you are married, you will produce the following certificate in this Head of office:- "That he/she is not having more than one living spouse."

In case you are unmarried, you shall have to furnish a declaration to the effect that you will not have more than one living spouse.

5. In case you are unmarried, you will have to furnished a declaration to the Head of the Department that you have not taken any dowry after marriage. The declaration should be signed by your wife, father and father-in-law, as per Chief Secretary to Govt. Haryana letter No. 18/1/2004-2GSI dated 21.02.2006.
6. As per Govt. Notification No. G.S.R. 65/Const.Art. 309/2013 dated 08.11.2013, the candidate shall have to qualify the State Eligibility Test in Computer Appreciation and applications (SETC) within the probation period of two years. You shall not be entitled to earn any increment in his pay-scale till you qualify the SETC Test failing which the services of such employees shall be dispensed with.
7. You will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the persuing of higher studies.
8. You will be required to produce the original Educational documents and date of birth certificate.
9. You shall have to furnish fitness certificate from the Chief Medical Officer as required under Rule 9 of Haryana CSR (General), 2016 before joining his duties.
10. You shall get themself vaccinated and re-vaccinated at any time when so directed by the Government by general or special order.
11. No TA/DA and joining time will be paid to you for joining this post.
12. You will remain on probation for a period of two years, from the date of your appointment. The period of probation can be extended in accordance with the existing rule on the subject.
