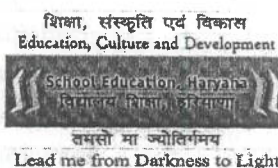



Whereas, Sh. Ram Niwas filed CWP No. 2570 of 2022 titled as Ram Niwas Vs. State of Haryana & Others before the Hon'ble Punjab & Haryana High Court, which was disposed of vide order dated 10.02.2022, with the following direction:-

“The limited prayer addressed, facts and circumstances of the case but without expressing any opinion on the merits thereof, this writ petition is disposed of with a direction to the competent authority, to decide representation dated 28.01.2022, Annexure P-5, submitted by the petitioner definitely within a period of six (06) weeks from the date of receipt of certified copy of this order.”

Whereas, Sh. Ram Niwas alleged appointment for the post PGT Chemistry on the basis of Post-Graduation degree obtained from Manonmanniam Sundaranar University, Tamilnadu. However, for supporting his claim, Sh. Ram Niwas placed reliance upon the appointment of Mrs. Sonia [Employee I'd - 5017550] D/o Sh. Sultan Singh, Sonia Singh W/o Sh. Subhash Chander, House No. 7-8, Auto Market, Mandi Adampur, District Hisar - 125052, PGT Chemistry who also obtained her post-graduation degree from Manonmanniam Sundaranar University, Tamilnadu.

In furtherance, to the claim quoted by Sh. Ram Niwas in his representation dated 28.01.2022, the appointment matter of Mrs. Sonia (referred above) was re-examined in light of clarification provided by University Grant Commission (*hereinafter referred as 'UGC'*).

Whereas, vide clarification dated 22.09.2021, UGC clarified that the Manonmanniam Sundaranar University, Tamilnadu is a State University and can operate within its State only. The clarification received from UGC is reproduced here as under:-

The UGC (ODL) Regulations, 2017 were notified on 23rd June, 2017 and subsequently the process for granting

recognitions to HEIs for offering programmes through the ODL mode was undertaken by the UGC. Under these Regulations, programme-wise recognition has been accorded to the HEI for 2019-20. The current recognition status of the HEI, along with the recognized programmes for 2019-20 Academic session beginning from July 2019 and Jan 2020 only is available on the UGC website at the following URL; https://www.ugc.ac.in/pdfnews/0114374_ProgrammeRecognitionListOLD.pdf It is for information that being a State University, it can operate within its State only. The university is not authorized to open study centre/off campus centre beyond the territorial jurisdiction of the State as per the judgment of Hon'ble Supreme Court of India in the case of Prof. Yash Pal vs. The State of Chhattisgarh (2005). Kindly refer the Public Notice dated 27.06.2013 on territorial jurisdiction of universities and other matters related to distance education on UGC website. The UGC has not granted any approval to the university to open off-campus/study centre anywhere.

Whereas, in pursuance to the above clarification received from UGC, the department has already rejected the appointment related claim of Sh. Ram Niwas, Roll No. 40202277, Merit No. 212-A vide this Office order bearing no. 6/19-2020 PGT-1 (2) dated 13.05.2022.

Whereas, due to the facts and circumstances referred *supra* and in pursuance to the condition no. 14 referred in Appointment Order, it has been decided by the department to withdraw the appointment of Mrs. Sonia [Employee I'd - 5017150] D/o Sh. Sultan Singh, Sonia Singh W/o Sh. Subhash Chander, House No. 7-8, Auto Market, Mandi Adampur, District Hisar - 125052, PGT Chemistry. The relevant condition referred in appointment order is reproduced here as under: -

.... 14. If he/she gets an appointment as PGT on the basis of his/her furnishing ineligible/invalid qualification, false/forged or fraudulent information/facts which are

detected later on, he/she would be liable for termination of service without any notice.

However, before initiating any action towards the withdrawal of appointment, a show-cause notice is hereby served upon you (Mrs. Sonia), as to why your appointment may not be withdrawn? Reply, if any, you want to file in response to this notice, the same may be filed in the office of Director Secondary Education, Haryana, Panchkula not later than 15 days from the date of the receipt of this notice. In case you fail to file a reply to the notice within the stipulated period, it shall be presumed that you have nothing to say/submit in this regard and decision will be taken ex-parte.
