

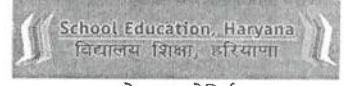

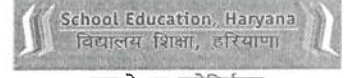

Whereas, Sh. Sanjiv Kumar filed a Civil Writ Petition No. 4238 of 2022 titled as Sanjiv Kumar vs. State of Haryana & others before the Hon'ble Punjab and Haryana High Court praying therein benefit of promotion from the date on which juniors to the incumbent were promoted w.e.f. 26.04.2016.

The Hon'ble Punjab & Haryana High Court disposed of present petition on dated 04.03.2022. The operative part of order dated 04.03.2022 is as under:

*".....Keeping in view the limited prayer addressed, facts and circumstances of the case but without expressing any opinion on the merits of the case, this writ petition is disposed of with a direction to the competent authority, to decide legal notice dated 13.10.2021, Annexure P-12, filed by the petitioner by passing a speaking order, within three months from the date of receipt of certified copy of this order.."*

Whereas, the legal notice dated 13.10.2021 of Sh. Sanjiv Kumar has been duly examined and it is found that he had submitted his case for promotion from TGT (Trained Graduate Teacher) to PGT (Post Graduate Teacher) in the year 2015-16.

As per Haryana State Education School Cadre (Group- B) Service Rules, 2012, the qualification for promotion in PGT (Post Graduate Teacher) Mathematics is as under:-

	PGT Mathematics		By promotion:- (i) M.A/M.Sc. Mathematics/Applied Mathematics with Mathematics as one of the Subject as Graduation level with atleast 50% marks and B.Ed from recognized university; AND (ii) 2 years teaching experience as TGT Mathematics;

Whereas, Sh. Sanjiv Kumar has passed his degree of M.Sc Mathematics from Vinayaka Mission University, Tamil Nadu through distance education mode.

Whereas, the incumbent has acquired his degree of Post-Graduation/ Master Degree from study centre of the Deemed University through distance mode i.e. Vinayaka Mission University, Tamil Nadu and University Grants Commission has clarified vide letter dated 21.07.2017 that a Deemed University can operate within its own Head Quarter and the University Grants Commission has not granted its approval to the university to open any study centre in any other State or even within its State. Therefore, the department has rightly not considered the petitioner for promotion to the post of Post Graduate Teacher (PGT) mathematics as the incumbent is not eligible for promotion as Post Graduate Teacher (PGT) on the basis of said qualification as the same has been obtained through distance mode and through study centre of the university.

Whereas, the Hon'ble Punjab and Haryana High Court in CWP No. 11049 of 2017 titled as Karmjeet Kaur Vs. State of Punjab and another has held that in case the candidate has got admission in the course prior to the cut-off date in that case, the State will then verify the statutes/Memorandum of Association (MOA) and is also mentioned in the list of degree specified under Section 22 of the University Grant Commission Act, 1956, then the qualification will be considered as valid subject to the territory from which university is operating is in consonance with the Acts/Statutes/MOA of the university. In the present case, the University Grants Commission has specifically clarified that no approval has been granted to the above said university to run the study centre and hence territorial jurisdiction of the above said university is only at the Head Quarter of the university and hence the qualification attained from the study centre is invalid.

Whereas, vide minutes of meeting dated 01.08.2007, the Distance Education Council had granted sanction to Vinayaka Mission University, (Deemed University) Tamil Nadu, till the academic session June-July 2007 only. Further, even as per minutes of meeting dated 07.08.2007, provisional recognition for a period of one year i.e. academic year 2007-08 only and not thereafter.

Whereas, as per order dated 21.07.2017, the Deemed University is not authorised to offer any programme which includes not only M.Phil and Ph.D but also the Post-Graduation degree which is covered under "*any programme*".

Whereas, once the service rules which provided that only the degree from a recognized university is to be considered then there is no question to accept the degree from deemed university which is not a recognized one. Vide dated 25.07.2015, wherein the Government of India notifies that all the degree/diploma/ certificate including technical education degrees/ diplomas awarded through open and Distance Learning mode of education are recognized for the purposes of the employment and service provided they have been approved by the University Grants Commission. The incumbent acquired post-graduate

degree in M.Sc Mathematics in the year 2009-2010. As per the clarification order dated 21.07.2017, it was mentioned that the Vinayaka Mission University, (Deemed University) Tamil Nadu, was granted provisional recognition for the academic year 2007-2008. It was also mentioned that no further recognition had been granted to Vinayaka Mission University, (Deemed University) Tamil Nadu, either by DEC-or UGC to offer 'any programme' through distance mode.

Whereas, letter dated 14.10.2013 issued by the University Grants Commission which provides that the Degrees/Diplomas/Certificates awarded for programmes conducted by the ODL institutions, recognized by DEC and UGC, in conformity with UGC Notification on specification of Degrees should be treated as equivalent to the corresponding awards of the Degree/Diploma/Certificate of the traditional Universities/ institutions in the country. However, the subsequent notification dated 25.07.2015 issued by University Grants Commission wherein the Government of India notifies that all the degree/diploma/ certificate including technical education degrees/diplomas awarded through open and Distance Learning modes of education are recognized for the purposes of the employment and service provided they have been approved by the University Grants Commission. Subsequent notification dated 25.07.2015, in which it is mentioned that degree/diploma/ certificate has to be approved by the UGC. In the present case, the Vinayaka Mission University (Deemed University) Tamil Nadu was granted provisional recognition for the academic year 2007-2008 as per clarification order dated 21.07.2017.

Whereas, even vide clarification dated 12.07.2013 issued by UGC, no permission was granted to deemed universities i.e. Vinayaka Mission University, Salem (Tamilnadu) to establish Study Centres to run distance education programme. In the absence of permission of UGC and that of the State Government in which study centres are located (outside the jurisdiction of above mentioned university) the degrees obtained from the study centres by the petitioner is not legal and the incumbent is not eligible for promotion as PGT in Haryana Government Service.

Whereas, similar situated employees have filed CWP No. 15843 of 2018, which was allowed by Hon'ble High Court on 16.10.2019. Thereafter, the department has filed the Latent Patent Appeal No. 19 of 2021 before the Division Bench in the Hon'ble High Court against the order of Single Bench dated 16.10.2019 and LPA is pending for 19.05.2022. This LPA was listed before the Division Bench on 26.02.2021 and the stay was granted by the Hon'ble Division Bench while hearing of the case. Satyavir Singh has filed CWP No. 15145 of 2022 titled as Satyavir Singh vs. State of Haryana & others before Hon'ble Punjab and Haryana High Court praying therein to direct the respondent Department to promote the petitioner to the post of Lecturer/PGT Math w.e.f. 17.09.1997 i.e the date from junior has been promoted with consequential benefits including seniority and notional pay fixation from 17.09.1997, actual pay fixation from the date he was promoted as Lecturer Math i.e. w.e.f. 27.04.2000 and payment of arrear with interest @12% per annum.

The Hon'ble Punjab & Haryana High Court disposed of said petition on dated 18.07.2022 The operative part of order dated 18.07.2022 is as under:-

**"...In view of the request made, without expressing any opinion on the merits of the case or the claim being made by the petitioner on 31.03.2022 (Annexure P-10), respondent No.2 is directed to decide the legal notice dated 31.03.2022 (Annexure P-10) by passing a speaking order within a period of eight weeks from the receipt of copy of this order.**

**Present writ petition stands disposed of."**

In compliance of above mentioned order, the legal notice dated 31.03.2022 of Sh. Satyavir Singh, PGT Math has been duly examined and it is found that Sh. Satyavir Singh was initially appointed as TGT Mathematics on adhoc basis on 16.12.1988 and regularized on 01.01.1991. Later on, promoted to the post of PGT Mathematics on 27.04.2000.

Whereas, Sh. Joginder Singh was appointed as TGT Science on 19.11.1991 and promoted to the post of PGT Mathematics on 25.01.2006 w.e.f. 17.11.2000, so, he is still junior of the petitioner.

Whereas, the petitioner placed reliance upon the promotion of junior in this regard it is germane to mention here that the promotion of junior has been made on w.e.f. 17.11.2000 which is much far away from

the promotion of the petitioner. In furtherance, it is stated here that the facts mentioned by the petitioner are totally wrong and fabricated.

In view of the facts mentioned above, representation of incumbent and documents on record, the claim of Sh. Satyavir Singh is not tenable & hereby rejected being devoid of merits.

It is ordered accordingly.
